Call to Order

Mayor Olk called the meeting to order at 7:00 p.m.

Mayor Olk determined that a quorum was present. Everyone was reminded to turn off or silence their cell phones and the Pledge of Allegiance was recited.

Citizen Input

1. Citizen Input:

Community Interest

2. Community Interest Items:

Mayor Olk presented to Finance Director Liz Exum the 2015 Certificate of Achievement for Excellence in Financial Reporting Award from the Government Finance Officers Association.

Mayor Olk then read a Proclamation declaring October 2016 as Breast Cancer Awareness Month.

Mayor Olk announced that Saturday, October 22, 2016 was the City's annual Founders Day event.

Public Hearing

3. Public hearing to consider adopting Ordinance 2016-10-00840 amending the City's Code of Ordinances, Chapter 14, Article 14.04, Division 8 - Accessory Buildings, Structures and Uses regarding square footage requirements for habitable space and accessory buildings; and amendments to the Code of Ordinances, Schedule Use Chart related to guest/servant quarters and accessory buildings with habitual space.

Development Services Director Joe Hilbourn gave a presentation noting the proposed changes recommended by the Planning and Zoning Commission that included:

- No trailers, containers, commercial boxes or other similar structures shall be used as accessory structures or buildings, with the exception of industrial, commercial, and agriculture uses with 5 acres or more, that may use trailers, containers, or commercial boxes for temporary storage, for a period not to exceed 90 days total in any one calendar year.
- Accessory buildings may contain habitable space as defined by the International Residential Code adopted by the City and may not be rented out.
- Accessory buildings may contain habitable space up to 600 square feet in Residential-1 zoning districts; 800 square feet in Residential-1.5 zoning districts; and 1,000 square feet in Residential-2 zoning districts.

Mayor Olk opened the public hearing at 7:08 pm and noted that a citizen input card was received from Kathleen LoSapio, 650 Scarlett Drive, Lucas, noting her opposition to the accessory building amendments.

There being no one in the audience wanting to speak, Mayor Olk closed the public hearing at 7:08 pm.

The Mayor and City Council discussed various aspects of the proposed ordinance including, architectural compatibility with the main structure, square footage requirements for habitable space, accessory buildings within agricultural zoned properties, zoning compliance and enforcement related to accessory buildings, square footage requirements within residential zoning districts, and being cautious to over-regulating with proposed changes.

MOTION: A motion was made by Mayor Olk, seconded by Councilmember Millsap, to adopt Ordinance 2016-10-00840 amending the City's Code of Ordinances, Chapter 14, Article 14.04, Division 8 - Accessory Buildings, Structures and Uses with the below written amendments. The motion passed by a 6 to 1 vote, with Councilmember Fisher voting in opposition. The following Sections outline amendments made to the adopted Ordinance.

Section 14.04.302(d) shall read "Exception: agricultural use on property with five or more acres, and industrial or commercial uses may use trailers, containers or commercial boxes for temporary storage for a period not exceeding 90 days total in

any one calendar year. The Development Services Director may approve additional time in 30 day increments up to a maximum of 180 days."

Section 14.04.304, Subsection 4, Subsection 1(b) this section shall be removed relating to accessory buildings containing habitable space shall be architecturally compatible with the main building.

Section 14.04.304, Subsection 4, Subsection 1(d) this section shall be removed that regulates the people that could reside in the habitable space; and renumbering Subsections e and f.

Section 14.04.304, Subsection 4, Subsection 2 (a)(ii) shall read "one accessory building may contain up to 1,500 square feet of habitable space."

Section 14.04.304, Subsection 4, Subsection 2 (b)(i) shall read "one accessory building may contain up to 1,250 square feet of habitable space."

Section 14.04.304, Subsection 4, Subsection 2 (c)(i) shall read "one accessory building may contain up to 1,000 square feet of habitable space."

Consent Agenda

- 4. Consider approval of the minutes of the September 15, 2016, City Council meeting.
- 5. Consider approving Resolution R 2016-10-00455 authorizing an interlocal agreement between the City of Lucas and Collin County for Collin County to fund a portion of the construction costs for improvements to the East Winningkoff Trailhead.

MOTION: A motion was made by Councilmember Millsap, seconded by Councilmember Lawrence to approve the Consent Agenda as presented. The motion passed unanimously by a 7 to 0 vote.

Regular Agenda

6. Consider updates to the Water System Capital Improvement Plan for 2016 to 2030 prepared by BW2 Engineers, Inc.

Public Works Director/City Engineer Stanton Foerster stated that as the City Council updates the Comprehensive Plan, the design, upgrade and growth of the City's water infrastructure should also be evaluated as to items that should be prioritized and budgeted for future years. Mr. Foerster discussed dead end lines that need to be addressed as well as water loss that occurs during flushing.

The City Council discussed the possibility of establishing rates to cover a portion of the costs, impact fees, and the option of paying as you go to not incur the cost of bonds.

Mr. Foerster shared with the City Council a prioritized list and funds needed for the top five recommended CIP projects:

- 1. Parker Road 12-inch phase 1 (TxDOT) \$292,037
- 2. Lewis/Parker 8-inch (TxDOT) \$326,004
- 3. Wiltshire/N. Pump 8-inch connection \$98,237
- 4. N. Pump Water Tower \$1,496,880
- 5. Restore N. Pump Station \$153,821

Mr. Foerster stated that funds were budgeted for Items 1, 2 and 3; funds were not budgeted for items 4 and 5.

Councilmember Millsap discussed reserve funds in the water fund and adjusting rates to assist in covering costs. Councilmember Millsap noted that projects could be funded without having to obtain any Certificates of Obligation.

Mayor Olk asked staff to include these projects as part of the Comprehensive Plan update and Capital Improvement Projects and to include how they will be funded.

This was a discussion item only, no formal action was taken.

7. Consider adopting Ordinance 2016-10-00844 removing the Statutory Limitations for funding for the Texas Municipal Retirement Services.

Human Resources Manager Cheryl Meehan stated that the Texas Municipal League (TML) notifies the City each year of the actuarially contribution rate for retirement benefits and supplemental death benefits required for participation. The City's current rate is 13.90% for 2017. Ms. Meehan stated that TML requires the City to contribute an actuarially determined amount in order to insure full funding of employee retirement benefits, with the amount varying from year to year.

Ms. Meehan discussed the need to remove or increase the statutory limitation to keep the benefit plan properly funded.

The City Council agreed that they would like to review this item as part of the budget annually each year, and they would also like to table the item to a later City Council meeting in order for staff and the City Attorney to review and clarify the options available.

MOTION: A motion was made by Mayor Olk, seconded by Councilmember Fisher to table this item at this time. The motion passed by a 7 to 0 vote.

8. Consider the City of Lucas options available through Texas Multistate
Intergovernmental Benefits Pool and Public Employee Benefits Alliance (PEBA) for
Pre and Post Sixty-five Retiree Benefits.

Human Resources Manager Cheryl Meehan stated that currently healthcare was not offered by the City for pre sixty-five retirees because it could negatively impact the cost to existing employee health coverage. However, healthcare for pre sixty-five retirees was available through COBRA for 18 months. Ms. Meehan noted that the City also had the option to consider offering a healthcare opportunity to post sixty-five retirees through the Public Employees Benefits Alliance without negatively impacting the cost to employee benefits. All arrangements would be handled by the retiree and PEBA; however, the City would be required have to opt into the program in order to have access to participate.

MOTION: A motion was made by Councilmember Millsap, seconded by Councilmember Lawrence to decline the pre sixty-five retiree election and to allow the post sixty-five election as presented by staff. The motion passed by a 7 to 0 vote.

9. Consider adopting Ordinance 2016-10-00833 approving amendments to the City's Code of Ordinances by amending Appendix C "Fee Schedule" Article 19.000 (7) "Wastewater Rates" to provide for rates for wastewater consumption and discharge over 2,000 gallons.

Public Works Director/City Engineer Stanton Foerster stated that wastewater fees are based on the water consumption and the amount of water the City sells. The City pays North Texas Municipal Water District for each gallon placed into the sanitary sewer system. Mr. Foerster noted that the cost the City pays was rising much faster than the revenue generated from customers. Mr. Foerster suggested that in an attempt to charge customers appropriately, the fee should be increased.

Mr. Foerster discussed leak testing and infiltrations, such as ground water getting into the sewer system.

MOTION: A motion was made by Councilmember Millsap, seconded by Councilmember Fisher to adopt Ordinance 2016-10-00833 approving amendments to the City's Code of Ordinances by amending Appendix C Fee Schedule, Article 19.000(7) to provide for rates for wastewater consumption and discharge over 2,000 gallons. The motion passed by a 7 to 0 vote.

- 10. Consider amendments to the City's Comprehensive Plan including:
 - Chapter 1 Introduction
 - Chapter 2 Demographics
 - Chapter 3 Housing
 - Chapter 4 Land Use
 - Chapter 5 Economic Development
 - Chapter 6 Parks, Recreation & Open Space
 - Chapter 7 Streets, Drainage & Master Thoroughfare Plan
 - Chapter 8 Water System

Mayor Pro Tem Peele noted her updates to the Comprehensive Plan and forwarded those to the City Secretary.

City Manager Joni Clarke asked that the City Council review the Master Thoroughfare Plan and submit any amendments that did not accurately reflect the vision for the city. In particular, roadways managed by the State and County, such as, Country Club Road, Estates Parkway and FM 1378.

Mayor Olk discussed the increase in traffic in and around Lucas due to additional development and suggested that East Lucas Road may have to be widened at some point to alleviate congestion.

Mayor Pro Tem Peele expressed her opposition to the widening of East Lucas Road to 4-lanes and noted that Angel Parkway would be widened in the future to assist with alleviating traffic through the City.

City Manager Joni Clarke stated that currently emergency services faces problems traveling on East Lucas Road due to traffic congestion. Three lanes would help alleviate that congestion.

Mayor Olk asked the Council to review the Thoroughfare Plan and the Collin County Transportation Plan and discuss this item again at another meeting.

The Council also suggested that a Town Hall meeting be held in order to gain feedback regarding traffic and potential future roadway changes.

This was a discussion item only, no formal action was taken.

11. Consider adopting Ordinance 2016-10-00843 approving amendments to the City's Code of Ordinances Chapter 10, Section 10.03.123 (i) Streets and Drainage relating to where street lights may be located and including an appeal process.

Development Services Director Joe Hilbourn gave a brief presentation noting that proposed changes to street lighting including requiring street lights in new subdivisions when deemed necessary by the Public Works Director/City Engineer for safety, as well as for existing intersections. Mr. Hilbourn noted that proposed amendments also include guidelines on the types of lights that are permitted and an appeal process to allow for further review.

Mayor Olk noted that the appeal process was not included in the proposed ordinance and asked staff to bring the ordinance back at the November 3, 2016 meeting with the appeal section added.

There was no formal action taken on this item.

ORDINANCE 2016-10-00843 [AMENDING CODE OF ORDINANCE CHAPTER 10]

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LUCAS, COLLIN COUNTY, TEXAS, AMENDING THE LUCAS CODE OF ORDINANCES BY AMENDING CHAPTER 10 TITLED "SUBDIVISIONS" BY AMENDING ARTICLE 10.03 TITLED "SUBDIVISION AND DEVELOPMENT ORDINANCE" BY AMENDING DIVISION 4 TITLED "STANDARDS AND REQUIREMENTS" BY AMENDING SECTION 10.03.123 TITLED "STREETS AND DRAINAGE" BY CREATING A NEW SUBSECTION (i) TITLED "STREET LIGHTING" TO PROVIDE NEW REGULATIONS FOR STREET LIGHTING; PROVIDING FOR AN APPEAL OF THE DECISION OF THE CITY ENGINEER; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000) FOR EACH OFFENSE; AND PROVIDING FOR AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LUCAS, COLLIN COUNTY, TEXAS, THAT:

Section 1. The Code of Ordinances of the City of Lucas, Texas, is hereby amended by amending Chapter 10 "Subdivisions" by amending Section 10.03.123 titled "Streets and Drainage" by creating a new subsection (i) titled "Street Lighting", to read as follows:

"CHAPTER 10

SUBDIVISIONS

ARTICLE 10.03 SUBDIVISION AND DEVELOPMENT ORDINANCE

DIVISION 4. Standards and Requirements

. . .

Sec. 10.03.123 Streets and drainage

. . .

(i) Street lighting.

City of Lucas

Ordinance 2016-10-00843 Amendment to Code of Ordinance Chapter 10 Approved: November 3, 2016

- (1) Street lighting shall be provided at street intersections at the request of the city engineer within new subdivisions and at streets connecting to new subdivisions. Street lighting shall conform to the latest edition of the Illuminating Engineering Society Handbook and the city's regulations as provided in the Code of Ordinances and zoning regulations. When a conflict exists between the two, the city's Code of Ordinances shall take precedent. The use of sodium vapor lights for street and parking lot illumination shall not be allowed in the city.
- (2) Cost of installation of street lighting shall be borne by the subdivider. Cost of ongoing service and utilities shall be borne by the subdivider and included in a maintenance agreement as part of the homeowners' association documents approved by the city attorney.
- (3) The city may install lights at existing intersections that the city engineer deems necessary.
- (4) The city engineer may, based on field conditions, modify the requirements of this section.
- (5) A request for street lightening that is denied by the city engineer may be appealed to the planning and zoning commission. A recommendation for approval from the planning and zoning commission shall then be forwarded to the city council for final action. A recommendation of denial by the planning and zoning commission will only be forwarded to the city council for final action upon written request of the applicant. Such written request must be received within thirty (30) days of the commission denying the request. The decision of the city council is final. The request for an appeal must be made in writing to the Development Services Director explaining why a street light in the proposed location is warranted and further citing factors as to why the city engineer's decision should be overturned. This request for an appeal must be received by the Development Services Department no less than 20 days prior to the scheduled planning and zoning commission meeting in which the appeal will appear on the agenda.
- (6) All street lights shall conform to the city's lighting regulations and be the same or similar in nature to the examples of streets lights as shown on Figure 1, Figure 2 and Figure 3:



Sec. 10.03.124 Water and utility extensions

...,

- All ordinances of the City of Lucas in conflict with the provisions of this Ordinance shall be, and same are hereby, repealed, provided, however, that all other provisions of said Ordinances are not in conflict herewith shall remain in full force and effect.
- Section 3. Should any word, sentence, paragraph, subdivision, clause, phrase or section of this Ordinance or of the City of Lucas Code of Ordinances, as amended hereby, be adjudged or held to be voided or unconstitutional, the same shall not affect the validity of the remaining portions of said Ordinances or the City of Lucas Code of Ordinances, as amended hereby, which shall remain in full force and effect.
- An offense committed before the effective date of the Ordinance is governed by Section 4. prior law and the provisions of the City of Lucas Code of Ordinances in effect when the offense was committed and the former law is continued in effect for this purpose.
- Any person, firm or corporation violating any of the provisions or terms of this Section 5. Ordinance shall be subject to the same penalty as provided for the in the City of Lucas Code of Ordinances, as amended, and upon conviction shall be punished by a fine not to exceed the sum of Two Thousand Dollars (\$2,000) for each offense, and each and every day such violation shall continue shall be deemed to constitute a separate offense.
- This Ordinance shall take effect immediately from and after its passage and Section 6. publication in accordance with the provisions of the Charter of the City of Lucas, and it is accordingly so ordained.



Executive Summary

Mitigation is commonly defined as sustained actions taken to reduce or eliminate long-term risk to people and property from hazards and their effects. Hazard mitigation focuses attention and resources on community policies and actions that will produce successive benefits over time. A mitigation plan states the aspirations and specific courses of action that a community intends to follow to reduce vulnerability and exposure to future hazard events. These plans are formulated through a systematic process centered on the participation of citizens, businesses, public officials, and other community stakeholders.

The planning area for this plan update is for Collin County, Texas and includes the following jurisdictions:

The contents of this plan update are designed and organized to be as reader-friendly and functional as possible. The structure and format of this plan has significantly changed from the initial Mitigation Plan that was adopted in 2011. However, the content or base information has been maintained.

As this plan is an update to the original plan, there have been developments and evolutions to the hazard mitigation strategy of Collin County. The first is the addition of new jurisdictions to the plan. Each jurisdiction's individual mitigation strategy is discussed in their annex. Fourteen new jurisdictions participated in this plan. Jurisdictions that participated in the 2011 HazMAP have changes in development highlighted in their individual annex.

As the growth of Collin County has expanded since the previous version of the plan, the vulnerability analysis has changed. New hazards have been added, including:

- Expansive Soils
- Lightning

Discussion of these hazards, along with expanded discussion of all previously-included hazards, can be found in chapter 3.

The objectives of this updated plan remain the same as in the previous plan. These include:

- To save lives and reduce injuries.
- Minimize damage to buildings and infrastructure (especially critical facilities).
- Minimize economic losses

Further examination of the action items from the 2011 plan, including the status of each action item, can be found in Chapter 4 of the main plan. New action items for each jurisdiction are located in the jurisdictional annexes.

During the development phase of this updated planning document, the review team noted some changes. While the scope and intent of the 2011 priorities remain the same, some of the underlying factors driving the priorities reflect new external trends, such as public perceptions and expectations, or are indicative of new awareness and approaches to community mitigation strategies.

2011 Plan Priorities:

- Local Plans and Regulations, including: changes to plans and regulations across a variety of community departments and commissions for the purpose of strengthening future documents
- Structure and Infrastructure Projects, including: construction regulations; rights-of-way, easements and road specifications; implementation of the Tornado Safe Room Rebate Program; development of extreme temperature shelters
- 3) Natural Systems Protection, including: flood zone regulations, wildland fire planning and prevention, and acquisition of hazard prone land; studies to further identify hazard-prone areas
- 4) Educations and Awareness Programs, including: systems to alert residents of impending hazard events, and public education programs to promote awareness of natural hazards and mitigation efforts

Areas of 2015 Priority Refinement:

- Post disaster conditions
 - With the potential for significant reimbursement for post-disaster projects through FEMA grants, it was prudent the plan be updated.
- Financial, legal and political realities
 - The Collin County Hazard Mitigation Action Plan (HazMAP) was updated to new standards
 utilizing a HMA grant and the North Central Texas Council of Governments (NCTCOG). This
 provided the necessary financial assistance and personnel to help organize the jurisdictions
 of Collin County, as well as compile the data into a cohesive plan.
 - Due to a HMA grant funding the NCT Safe Room Rebate Program, there was initial concern that only jurisdictions that were part of the county plan or had their own HazMAP would be eligible. As a result, most of the Collin County jurisdictions opted to participate in the Collin County HazMAP.
- Changes in hazard focus
 - Collin County has not changed the overall focus on hazards but has updated the likelihood of an occurrence based on new data from past meteorological and archival data. With these updates, the data has shown we are more likely to experience certain disasters over others. Through the use of the Priority Risk Index, persons interested in the plan will be able to better understand the rank of disasters and why one disaster may be considered at a higher risk than others. In addition, expansive soils and lightning were included as potential hazards. These hazards were not included in the 2011 plan.

The 2015 Planning Team acknowledges this mitigation plan is a planning document, not a regulatory document. The plan meets Federal Emergency Management Agency (FEMA) planning requirements by addressing hazards, vulnerability and risk.




Chapter One: Introduction

1.1 Purpose

Collin County is susceptible to a number of different natural hazards that have potential to cause property damage or loss, loss of life, economic hardship, and threats to public health and safety. Occurrence of natural disasters cannot be prevented; however, their impact on people and property can be lessened through hazard mitigation measures.

The Collin County Hazard Mitigation Action Plan has been developed by the Collin County Hazard Mitigation Planning Team (HMPT). The plan represents collective efforts of citizens, elected and appointed government officials, business leaders, non-profit organizations, and other stakeholders.

Through the development of this plan, the Planning Team identified the natural hazards that could affect Collin County, and evaluated the risks associated with these hazards. The implementation of this plan will make Collin County more disaster- resilient because the benefits that can be gained by planning ahead and taking measures to reduce damages before the next disaster strikes have been recognized. The plan will allow Collin County and participating jurisdictions to comply with the Disaster Mitigation Act of 2000 (DMA 2000) and it's implementing regulations 44 CFR Part 201.6, thus resulting in eligibility to apply for federal aid for technical assistance and post-disaster hazard mitigation project funding.

1.2 Collin County Hazard Mitigation Action Plan Planning Process

The Collin County Hazard Mitigation Action Plan (HazMAP) was created in order to meet current federal and state hazard mitigation plan regulations in compliance with the following rules and regulations:

Section 322, Mitigation Planning, of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as enacted by Section 104 of the Disaster Mitigation Act of 2000 (P.L. 106-390)

Federal Emergency Management Administration's Interim Final Rule, published in the Federal Register on February 26, 2002, at 44 CFR Part 201.

Each jurisdiction participated by having a Hazard Mitigation Planning Committee (HMPC). Each HMPC participated in the creation of and contributed to the Hazard Mitigation Action Plan. The North Central Texas Council of Governments (NCTCOG) Emergency Preparedness Department also participated in the HazMAP update341. NCTCOG's role was to assist in compiling the jurisdictional information and preparing the plan for submission. Collin County hazard mitigation planning meetings were held on June 11, 2014 and September 18, 2014.



Sec. 1.06.009 Interpretation of content

Any official may request, and the city attorney shall issue, a verbal or written opinion (as deemed appropriate) concerning the meaning or effect of any section, word, or requirement of this code of ethics as it affects such person.

ARTICLE 1.07 EMERGENCY MANAGEMENT*

Sec. 1.07.001 National Incident Management System adopted

The city hereby adopts the National Incident Management System dated March 1, 2004. (Ordinance 2005-10-00537 adopted 10/3/05)

Sec. 1.07.002 Organization

- (a) There exists the office of emergency management director of the city, which shall be held by the mayor in accordance with state law.
- (b) An emergency management coordinator may be appointed by and serve at the pleasure of the director.
- (c) The director shall be responsible for a program of comprehensive emergency management and for carrying out the duties and responsibilities set forth in this article. The director may delegate authority for execution of these duties to the coordinator, but ultimate responsibility for such execution shall remain with the director.
- (d) The operational emergency management organization shall consist of the officers and employees of the city so designated by the director in the emergency management plan, as well as organized volunteer groups. The functions and duties of this organization shall be distributed among such officers and employees in accordance with the terms of the emergency management plan.

Sec. 1.07.003 Emergency management director - powers and duties

The duties and responsibilities of the emergency management director shall include the following:

- (1) Conduct an ongoing survey of actual or potential hazards which threaten life and property within the city and an ongoing program of identifying and requiring or recommending the implementation of measures which would tend to prevent the occurrence or reduce the impact of such hazards if a disaster did occur.
- (2) Supervision of the development and approval of an emergency management plan for the city, and shall recommend for adoption by the city council all mutual aid arrangements deemed necessary for the implementation of such plan.

^{*} State law reference-Local and interjurisdictional emergency management, V.T.C.A., Government Code, ch. 418.

- (3) Authority to declare a local state of disaster. The declaration may not be continued or renewed for a period in excess of seven (7) days except by or with the consent of the city council. Any order or proclamation declaring, continuing, or terminating a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the city secretary.
- (4) Issuance of necessary proclamations, regulations, or directives which are necessary for carrying out the purposes of this article. Such proclamations, regulations, or directives shall be disseminated promptly by means calculated to bring their contents to the attention of the general public and, unless circumstances attendant on the disaster prevent or impede, promptly filed with the city secretary.
- (5) Direction and control of the operations of the emergency management organization as well as the training of emergency management personnel.
- (6) Determination of all questions of authority and responsibility that may arise within the emergency management organization.
- (7) Maintenance of liaison with other municipal, county, district, state, regional or federal emergency management organizations.
- (8) Marshaling of all necessary personnel, equipment, or supplies from any department of the city to aid in the carrying out of the provisions of the emergency management plan.
- (9) Supervision of the drafting and execution of mutual aid agreements, in cooperation with the representatives of the state and of other local political subdivisions of the state, and the drafting and execution, if deemed desirable, of an agreement with the county and with other municipalities within the county, for the countywide coordination of emergency management efforts.
- (10) Supervision of, and final authorization for, the procurement of all necessary supplies and equipment, including acceptance of private contributions which may be offered for the purpose of improving emergency management within the city.
- (11) Authorizing of agreements, after approval by the city attorney, for use of private property for public shelter and other purposes.
- (12) Survey of the availability of existing personnel, equipment, supplies, and services which could be used during a disaster, as provided for herein.
- (13) Other requirements as specified in the Texas Disaster Act of 1975, codified in chapter 418 of the Texas Government Code.

Sec. 1.07.004 Emergency management plan

A comprehensive emergency management plan shall be developed and maintained to the advanced level, and the plan and all annexes shall be NIMS compliant. The plan shall set forth the form of the organization, establish and designate divisions and functions; assign responsibilities, tasks, duties, and powers; and designate officers and employees to carry out the provisions of this article. As provided by state law, the plan shall follow the standards and criteria established by the state division of emergency management. Insofar as possible, the form of organization, titles, and terminology shall conform to the recommendations of the state division of emergency management. When approved, it shall be the duty of all departments and agencies to perform the functions assigned by the plan and to maintain their portion of the plan in a current state of readiness at all times. The emergency management plan shall be considered supplementary to this article and have the effect of law during the time of a disaster.

Sec. 1.07.005 Interjurisdictional program

The mayor is hereby authorized to join the county judge and the mayors of other cities in said county, in the formation of an interjurisdictional emergency management program for the county, and shall have the authority to cooperate in the preparation of an interjurisdictional emergency management plan and in the appointment of a joint emergency management coordinator, as well as all powers necessary to participate in a countywide program of emergency management insofar as said program may affect the city.

Sec. 1.07.006 Organization of city, officers, functions and duties

The operational emergency management organizations of the city shall consist of the officers and employees of the city so designated by the director in the emergency management plan, as well as organized volunteer groups. The functions and duties of this organization shall be distributed among such officers and employees in accordance with the terms of the emergency management plan. Such plan shall set forth the form of the organization, establish and designate divisions and functions, assign tasks, duties and powers, and designate officers and employees to carry out the provisions of this chapter. Insofar as possible, the form of organization, titles and terminology shall confirm to the recommendations of the state division of emergency management and of the federal government.

Sec. 1.07.007 Override

At all times when the orders, rules, and regulations made and promulgated pursuant to this article shall be in effect, they shall supersede and override all existing articles, orders, rules, and regulations insofar as the latter may be inconsistent therewith.

Sec. 1.07.008 Article not to conflict with state and federal regulations

This article shall not be constructed so as to conflict with any state or federal statue or with any military or naval order, rule or regulation.

Sec. 1.07.009 Liability

This article is an exercise by the city of its governmental functions for the protection of the public peace, health, and safety, and neither the city, its agents nor representatives, nor any individual, receiver, firm, partnership, corporation, association, or trustee, nor any of the agents thereof, in

good faith carrying out, complying with or attempting to comply with any order, rules or regulation promulgated pursuant to the provisions of this article shall be liable for any damage sustained to persons as the result of said activity. Any person owning or controlling real estate or other premises who voluntarily and without compensation grants to the city a license of privilege, or otherwise permits the city to inspect, designate, and use the whole or any part or parts of such real estate or premises for the purpose of sheltering persons during an actual, impeding, or practice enemy attack or natural or manmade disaster shall, together with his successors in interest, if any, not be civilly liable for the death of, or injury to, any person on or about such real estate or premises under such license, privilege or other permission or loss of, or damage to, the property of such person.

Sec. 1.07.010 Commitment of funds

No person shall have the right to expend any public funds of the city in carrying out any emergency management activity authorized by this article without prior approval by the city council, nor shall any person have any right to bind the city by contract or otherwise without prior and specific approval of the city council unless during a declared disaster. During a declared disaster, the mayor may expend and/or commit public funds of the city when deemed prudent and necessary for the protection of health, life, or property.

Sec. 1.07.011 Offenses; penalties

- (a) It shall be unlawful for any person willfully to obstruct, hinder, or delay any member of the emergency management organization in the enforcement of any rule or regulation issued pursuant to this article.
- (b) Is shall be unlawful for any person to wear, carry, or display any emblem, insignia, or any other means of identification as a member of the emergency management organization of the city, unless authority to do so has been granted to such person by the proper officials.
- (c) Any authorized person who shall operate a siren or other device so as to simulate a warning signal, or the termination of a warning, shall be deemed guilty of a violation of this article and shall be subject to the penalties imposed by this article.
- (d) Convictions for violations of the provisions of this article shall be punishable by fine not to exceed two thousand and no/100 dollars (\$2,000.00).

Background Information:

The Comprehensive Plan should be updated periodically to reflect changes in the community. The last update to the Comprehensive Plan was conducted in 2006. The City had its Comprehensive Plan kick off meeting that included the Planning and Zoning Commission, City Council and the Parks and Open Space Board on June 7, 2015 and the Planning and Zoning Commission has begun their review and update of components of the Comprehensive Plan. The items to be considered for update include Chapter 8 - Water and Sewer, which include a Water System Master Plan Map and a Sewer Master Plan Map. This is a technical review only.

Citizen Summary:

There is no state law that requires a City to have a Comprehensive Plan; however, if a City would like to enforce zoning it is required to have an adopted Comprehensive Plan that is updated from time to time. The Comprehensive Plan is a long-range planning tool that is intended to be used by the City to guide growth and development of the community for the future. The Comprehensive Plan was adopted in 1980 and as the City grows, the Plan needs periodic updating, the last update was 2004. The goal of this update is to continue to make long-range plans for the community of Lucas as it continues to grow. At this time the Comprehensive Plan has been brought before the Planning and Zoning Commission as a standing item each month. The Comprehensive Plan is required to be adopted following two public hearings. Public hearings for adoption of the amended Comprehensive Plan are tentatively scheduled for January or February, 2017.

INTRODUCTION

The City of Lucas owns and operates Lucas Waterworks that serves the residents inside and outside its current Certificate of Convenience and Necessity (CCN) site map. The Lucas Waterworks serves residents outside the city limits and outside the Lucas extraterritorial jurisdiction (ETJ), but the City does not supply water to all residents within the Lucas ETJ. The Seis Lagos Utility District, the Wylie Northeast Special Utility District and the City of Allen supply water to a portion of residents inside the Lucas city limits and within the Lucas ETJ.

The City's water system is a vital part of the City owned infrastructure. The purpose of this section on the water system is to update the Comprehensive Plan by providing a description of the current water system, identifying the criteria for determining future additions to the water system, and providing a description of the capital improvements needed for the future water system.

EXISTING WATER SYSTEM

Water Supply

The City purchases water from the North Texas Municipal Water District (NTMWD). Water is delivered to the City at two delivery points. One of the delivery points is at the North Pump Station site located on Country Club Road between West Lucas Road and Estates Parkway. The other delivery site is at the McGarity Pump Station site located on McGarity Lane just east of Angel Parkway. The delivery point at the McGarity Pump Station site is the newer of the two delivery sites. It was established when the first facilities were constructed at that site in 2004/2005.

Existing System Facilities

The principal facilities in the existing water system include ground storage tanks, elevated storage tanks, and pump stations. The storage tanks and pump stations are all located at the McGarity Pump Station, the North Pump Station and the Winningkoff elevated tank site. The existing water system is shown on Figure 8.1 at the end of this section. Following is a summary of the principal facilities in the existing water system:

Ground Storage:

McGarity Pump Station 200,000 gallon tank

350,000 gallon tank

North Pump Station 500,000 gallon tank

750,000 gallon tank

Total 1,800,000 gallons

Elevated Storage:

McGarity Pump Station300,000 gallon tankWinningkoff Site300,000 gallon tankTotal600,000 gallons

Pumping Facilities:

McGarity Pump Station:

Pump #3 – 750 gpm Pump #4 – 750 gpm Pump #5 – 750 gpm

North Pump Station:

Pump #1 – 1,100 gpm Pump #2 – 1,000 gpm Pump #3 – 1,000 gpm Total 5,250 gpm

New Facilities

A number of facilities have been added to the existing water system since the last comprehensive plan was prepared in 2004. These facilities include the initial McGarity Pump Station facilities which were under construction at the time of the preparation of the last comprehensive plan. Those facilities include the 300,000 gallon elevated storage tank, the 200,000 gallon ground storage tank, and the pump station with the first two 750 gpm pumps. Other facilities that have been added to the water system include the following:

Ground Storage:

- 750,000 gallon ground storage tank at the North Pump Station
- 350,000 gallon ground storage tank at the McGarity Pump Station

Pumping Facilities:

- Replacement of 900 gpm pump with 1,100 gpm pump at the North Pump Station
- New pump station at the McGarity Pump Station with two 750 gpm pumps
- Additional 750 gpm pump at the McGarity Pump Station

Water Lines:

- Country Club Road Water Line, including 9,200 feet of sixteen inch- and twelve-inch water lines
- Forest Grove Road Water Line, including 1,000 feet of eight-inch water line
- Shady Lane Water Line including 2,200 feet of eight-inch water line
- Southview Drive Water Line, including 12,000 feet of twelve inch water line
- Brockdale Park Road Water Line, including 7,000 feet of eight-inch water line
- Brookhaven Drive Water Line, including 6,300 feet of eight-inch water line
- Stinson Road Water Line, including 11,700 feet of twelve water line
- Water line to the fire station, including 320 feet of 12-inch water line
- Rock Ridge Road Water Line Phase I, including 3,500 feet of twelve inch water line
- Osage Lane Water Line, including 2,700 feet of six-inch water line

PARAMETERS FOR FUTURE FACILITIES

Typically, the two principal factors that determine the size and capacity of future water system facilities are the anticipated water demand in the water system and certain facilities design criteria. In the case of the Lucas water system, four other factors will also have an impact on the future water system facilities. These factors are the pending conversion of the water system from two pressure planes to one pressure plane, staging the additions to the water system to account for development, the need to reduce the number of dead end water lines in the system, and the ability of the NTMWD to supply water.

Water Demand

Water demand is a function of the number of people living in the service area and their water usage habits. The water customers projected population of the water customers is included in the following table:

The present water system service area is shown in Figure 8.2.

The population to be served by the water system will include the build out population of 13,274, plus an estimated population of 168 people in the Allen ETJ currently being served by the water system. Accordingly, a total population of 13,442 located within the proposed CCN (site map) will be utilized for determining the water demand that will eventually need to be met by the water system. The size and capacity of future system facilities will be based on this population of 13,442. Since water demand in the water system service area is based on the population and their water usage habits, historical water usage habits need to be determined in

order to establish the projected demands. Based on established water usage habits, the water usage is approximately 250 gallons per capita per day, the maximum day to average day ratio is 2.5, and the peak hour to maximum day ratio is 1.8. With a build out population of 13,442 in the service area, this water usage will result in an average daily demand of 3.36 mgd, a maximum day demand of 8.4 mgd, and a peak hour demand of 15.12 mgd for the water system at build out.

Design Criteria

Different design criteria can be used to determine the size and capacity needed for future system facilities. Minimum requirements for determining the size of storage facilities and pumping facilities are provided by the Texas commission on environmental quality (TCEQ). Per the Texas commission on environmental quality (TCEQ), the water system needs to have at least 200 gallons of ground storage and 100 gallons of elevated storage per connection. More stringent design criteria has been utilized, per previous analysis, for the present water system. This design criteria is based on providing elevated storage to meet peak hour demands in the system. [Based on this criteria, the elevated storage needs to have enough capacity to provide for peak hour demand with a reserve] of one-third of the total elevated storage capacity for fire flow. The ground storage requires sufficient capacity to meet a specified portion of the maximum day demand. The pumping capacity in the system needs to be sufficient to meet a specified portion of the maximum day demand. It is recommended that the more stringent design criteria, which has been used in the past for the existing water system, continue to be utilized for system facilities.

Pressure Planes

The existing water system presently operates on two pressure planes. The upper pressure plane is located primarily in the northwest part of the service area. The lower pressure plane serves the rest of the service area. The facilities that provide water to the upper pressure plane are located at the McGarity Pump Station site. The facilities that provide water to the lower pressure plane are located at the North Pump Station site and the Winningkoff Elevated Tank site.

Prior to the establishment of the two pressure planes, the water system was operating on a single pressure plane. One of the goals is to reestablish one pressure plane in order to simplify operation of the water system and improve efficiency. Due to the difference in elevations of the elevated storage tanks serving the existing water system, one strategy is an altitude valve installed at the Winningkoff elevated storage tank. This will allow the two elevated storage tanks to work together in the water system when it is converted to one pressure plane. Additionally limiting connections between the planes and the installation of residential pressure regulating valves (RPRVs) are other strategies for balancing the planes.

ETJ Annexation

The areas within the Lucas ETJ with the highest potential for annexation are already being served by the Lucas waterworks. However, the large ETJ area in the southeast part of the City is not. If this ETJ area is added to the City by annexation, the area would not be added to the water system service area. These areas are currently located within the CCN held by the Wylie Northeast Special Utility District (WNSUD) and the Seis Lagos Utility District (SLUD). In general terms, the WNSUD supplies water to the southeast corner of the city as well as the Inspiration neighborhood with in the Lucas ETJ and the SLUD supplies the Seis Lagos and Brockdale Park neighborhoods.

Projected population in this area at build out is 3,892 people. This added population would not increase the projected population in the water system service area at build out. The only potential impact to the Lucas waterworks would be the operation of the SLUD water infrastructure. The WNSUD would most likely not relinquish its system to the City of Lucas.

Dead End Water Lines

There are a large number of dead end water lines in the existing water system. Most of these have been created over the years as a result of expansion of the water system, primarily when subdivisions were built. Several of the dead end lines are long. Dead end water lines have to be periodically flushed per TCEQ requirements in order to keep sufficient disinfection levels in the water lines. The City has to devote resources and funds to accomplish this purpose. It is the City's goal to address this situation by reducing the number of dead end water lines in the City thru the addition of water lines that will provide loops to eliminate the longer dead end water lines. Looping lines will eliminate the need to flush the lines, will improve the dependability of the system in the area, and enhancing fire protection, Improving. Included at the end of this section is a water system map showing the existing dead end water lines.

PROPOSED WATER SYSTEM

Proposed System Facilities

A number of system improvements will need to be made for the future water system based on water demand, the design criteria for improvements, and the other criteria mentioned in the previous section. The principal facilities needed for build out conditions when the water system service area (without the large ETJ area in the southeast part of the City included in the service area) include the following. These improvements are shown on Figure 8.3 (The capital improvements map) included at the end of this section.

McGarity P.S. Site:

- 1,000,000 gallon ground storage tank
- Pump station with two 1,250 gpm pumps (replaces old pump station)
- 300,000 gallon elevated storage tank

North P.S. Site:

- Replace existing 8" delivery line (from NTMWD) with 12" delivery line
- Pump station with two 800 gpm pumps

Winningkoff Elevated Tank Site:

Altitude valve with valve vault and piping

The additional facilities needed for build out conditions when the water system service area (with the large ETJ area in the southeast part of the City included in the service area) include the following. These improvements are shown on Figure 8.4 (the capital improvements map) shown at the end of this section.

McGarity P.S. Site:

- Add a third 1,250 gpm pump in the new pump station
- 200,000 gallon elevated storage tank




- 800,000 gallon ground storage tank
- Add a third 800 gpm pump in the new pump station

Water Lines:

- 12" water line along Country Club Road and East Lucas Road
- 12" water line between Brockdale Park Road and Southview Drive

The additions to the water system listed above for both sets of conditions (i.e., with and without the large ETJ area in the southeast part of the City included in the service area) provide the facilities that will be needed in the water system under build out conditions and provide a balanced water system with similar capacity facilities at the two pump station sites.

Agenda Item:

Discuss and consider appointments and reappointments to the Board of Adjustment, Planning and Zoning Commission and the Parks and Open Space Board for two year terms beginning November 3, 2016 through November 1, 2018.

Background Information:

Board of Adjustment:

Currently, there are two members with terms expiring and up for reappointment, and one vacant regular member position. One of the members up for reappointment has expressed that he will have another year of heavy travel and due to his lack of availability offered to resign, but would serve if the Council desired.

Parks and Open Space Board:

Currently there are three members with terms expiring and up for reappointment. All members have expressed they would like to continue to serve; however, one member has expressed their interest in serving on the Planning and Zoning Commission.

Planning and Zoning Commission:



Background Information:

The City owns a 1940's fire truck named Streaker. The truck has not run in over twelve years. At least one cylinder is not functioning of the six cylinder motor that would require a rebuild or a new motor. With the Fire-Rescue Departments Tahoe having a bad transmission, Public Works can take the motor and have the transmission rebuilt and have an updated LS drive train for about \$1,000. The truck also needs a new standalone wiring harness someone in the past rigged a twelve volt alternator and regulator to a system that required a six volt generator destroying the wiring harness for the truck. The truck needs new tires due to dry rot and some miscellaneous material such as front brake pads and new kingpins in the steering system to get running and fully operational.

Citizen Summary:

The city has owned a vintage fire truck for about twelve years and have planned to get running for special events and educational opportunities at schools. With a truck in the fleet with a good motor going down we have an opportunity to get Streaker in action for a reasonable sum of \$5,000.
