#### City Council Highlights

- > City Council adopted an effective tax rate of \$0.317948 per \$100 assessed valuation on all taxable property for tax year 2016.
- > The City's fiscal year budget for 2016-2017 was adopted.
- > The City Council approved a final plat for Five Oaks Estates with 17 lots near Orr Road and Winningkoff.
- ➤ Chapters 1 through 5 of the Comprehensive Plan have been reviewed by the City Council to date. A total of 8 chapters are being reviewed in all. Once draft review is complete, public hearings will be held for final adoption of the updated and amended Comprehensive Plan.

### Mayor's Message By Jim Olk



Every year about this time the City looks for citizens that are interested in participating in local government through committee work. The City of Lucas has several Boards and Commissions that are appointed by City Council. They are as follows:

**Board of Adjustment** – The Board of Adjustment is a quasi-judicial board that hears and decides on requests for variances to the technical

terms of the Zoning Ordinance. This Board is appointed by the City Council, but acts independently and makes determinations if applicants have unique property conditions that warrant the granting of a variance as established by City Ordinance and State Law. The Board meets as needed, when a request has been submitted.

Planning and Zoning Commission - The Planning and Zoning Commission studies zoning change requests, specific use permits, plats and other zoning related issues and makes recommendations to the City Council. The Commission's decisions are guided by the Comprehensive Plan. The Planning and Zoning Commission is appointed by the City Council and meets in the evening on the second Thursday of each month.

Parks and Open Space Board - The Parks and Open Space Board studies our parks, trails and other open spaces and makes recommendations to the City Council regarding the use and improvements of these spaces. The Parks and Open Space Board also promotes the Lucas Founders Day and Country Christmas events. This Board is appointed by the City Council and meets on the fourth Tuesday of the month.

The City has always been blessed to have a very good pool of applicants, but the City is always seeking new and diverse people, opinions and personalities to participate in making this community what we all want it to be.

# Don't Forget to Enter the Scarecrow Contest





#### Blondy Jhune Bridge Project Update

The process is slow at the beginning of most construction projects, and the Blondy Jhune Bridge project is no exception. The contractor has be in contact with five steel-truss bridge manufactures, but none have been able to deliver competitive cost. The City is moving forward with no modifications to the plans that were bid on earlier this summer. Many of the bridge elements are fabricated on-site during the construction of the bridge, except for bridge beams that will be trucked into the project in November or December. The schedule for a project can be difficult to nail down to the day when there are multiple variables such as weather, sub-contractors, and required permitting that each impacts scheduling. ### **LEARN CPR SAVE LIVES**

On August 19, 2016 Lucas Fire-Rescue B-Shift members Captain/Paramedic Jonathan Haynes, Firefighter/Paramedic Jason Bender, Firefighter/Paramedic Aaron Alderdice, Firefighter/EMT Victor Jones, and Firefighter/EMT Theron Johnson were going about their regular morning duties, when the emergency dispatch tones sounded alerting them of a call. "Lucas Firefighters respond to a medical call, cardiac arrest," came over the fire station loudspeakers. Dropping their brooms and mops, the crew manned the ambulance and fire squad and responded to the location with lights and sirens. While en route, the dispatcher relayed "CPR in progress". After arriving on the scene, Lucas Fire-Rescue crews entered the home and found Lucas Sheriff Deputy George White performing CPR on the patient, which was initially started by a family member as instructed by the dispatcher. The paramedics attached a heart monitor to the patient and discovered that the patient had no heartbeat and was not breathing. The paramedics continued CPR. At this time, I arrived on the scene and entered the residence to find our crew performing CPR on a lifeless patient. Realizing that they would need a backboard for transport and the ambulance prepared for a quick departure, I exited the home and returned with a backboard. As I began to exit the home again to prepare the ambulance for departure, I made eye contact with one of the paramedics sharing a look of concern.

As the paramedics were preparing medications and watching the heart monitor's analysis of the patient, they were bracing for the worst. Then, eight minutes after the family member began CPR, over the radio came the words "CPR stopped, ROSC obtained!" In emergency services, ROSC stands for Return of Spontaneous Circulation. To the patient and the patient's family, ROSC means that the patient's heart started beating again. I thought to myself "There is no way!" I went back into the residence to verify what I had heard, and the patient did have a heartbeat.

The three paramedics and two EMT's then prepared the patient for transport. Seventeen minutes after the patient's heart started beating, the ambulance was on its way to the hospital. Thirty-four hours later, the patient was released from the hospital with no immediate complications noted.

In the fire service world, this is a called a "Life Saved". Yes, I am so proud of our staff for what they did. In honor of their actions, they were recently recognized at a Lucas City Council meeting and will be presented with the "Life Saving Award" at the Lucas Fire-Rescue annual awards banquet in early December. However, in all honesty, any member of the Lucas Fire-Rescue would have done exactly the same thing. It is one of the many things we are trained to do. With that said, it is NOT just a job or part of the job. We are proud of what we do and its a great honor to serve the citizens of Lucas.

The true heroes of this incident are those that gave the patient <u>immediate</u> CPR, which were the family members, the 911 dispatchers who instructed them on how to perform CPR, and Sheriff Deputy George White. This life was saved in the first five minutes after the patient's heart stopped beating.

The importance of calling 911 early cannot be overlooked in any emergency. The quick actions of a family member or bystander in calling 911 and then following the dispatcher's instructions is vital. Learning CPR and not being afraid to use it can save a life.

The Lucas Fire-Rescue will be offering Community CPR classes in the near future and details of the classes will be posted in upcoming issues of the Lucas Leader.

# NEWS from the Fire-Rescue Department What is ISO and how can it help you?



To establish appropriate fire insurance premiums for residential and commercial properties, insurance companies need reliable, up-to-date information about a community's fire-protection service. The Insurance Services Office of Texas (ISO) provides that information through the Public Protection

Classification program. The ISO is a private corporation that with oversight from the Texas Department of Insurance, evaluates industries for insurance rating purposes. Approximately every ten years each community is scheduled for an audit. The City of Lucas was last audited in 2009.

The ISO uses the Public Protection Classification program to collect information on municipal fire-protection efforts in communities throughout the United States. In each of those communities, the ISO analyzes relevant data using a Fire Suppression Rating Schedule, which grades features such as water distribution, fire department equipment and manpower, and fire alarm facilities. Each community is then assigned an ISO rating classification from 1 to 10. Class 1 represents exemplary public protection and Class 10 indicates that the area's fire-suppression program does not meet the ISO's minimum criteria. The City of Lucas is currently a Class 3 rating.

By classifying a community's ability to suppress fires, the ISO helps the community evaluate their public fire-protection services. This program provides an objective, countrywide standard that helps fire departments in planning and budgeting for facilities, equipment, and training; and by securing lower fire insurance premiums for citizens in communities with better public protection.

#### Chlorine Residual: A Public Health Safeguard

Chlorine and chlorine-based disinfectants are used worldwide to destroy germs in drinking water. One of the reasons for the use of chlorine disinfectants is that they provide a "residual" level of protection against waterborne pathogens. A chlorine residual is a low level of chlorine remaining in water after its initial application. It constitutes an important safeguard against the risk of subsequent microbial contamination after treatment.

The City of Lucas performs hundreds of tests each year to maintain healthy, clean drinking water with proper residuals. The City does this throughout the water works system with an emphasis on dead end waterlines where water is more likely to become "stale." Immediately after adding chlorine to the water, the chlorine starts to dissipate or evaporate. City staff checks the chlorine levels in the water system in seven to ten locations everyday 365 days per year. Some samples are tested on the spot to determine the chlorine levels (aka residuals) and a few of the samples are sent to a water quality lab for analysis of other elements.

If you see a public works employee around town taking water samples from residential neighborhoods and other locations, its to ensure the safety of our drinking water. Random samples are required, so locations vary daily.

#### Friends of the Lucas Fire-Rescue Department

The Friends of Lucas Fire-Rescue Board is a 501(c)(3) non-profit was formed several years ago to support Lucas Fire-Rescue. A new board of directors was recently appointed by the City Council, and the board is now gearing up fundraising through t-shirt sales and collection of aluminum cans for recycling. A recycling trailer is located behind the Fire Station where your aluminum cans can be dropped off. Be sure to place only clean aluminum cans in the recycling bin, no trash bags or boxes. We appreciate all the great folks who have brought their cans for donation.

Another Friends project is the restoration of the 1949 Ford Antique Fire Truck aka "Streaker". It is a part of the Lucas history and will be a great addition public relations during special events. The board is getting estimates on Streaker's refurbishment. The Friends will be participating in two upcoming events - the Fire Department Open House on October 9 and Founders Day October 22. Board meetings take place the fourth Tuesday of every month at the Lucas Fire -Rescue Department located at 165 Country Club Road. Everyone is welcome to attend.

#### Roadway Maintenance

During the month of September, seasonal maintenance is done on various roadways in Lucas. Through an interlocal agreement with Dallas County, the City of Lucas has entered into an agreement with APAC for the maintenance of the local streets. During the month of September, APAC worked on Snider Lane, Stinson Road, Ingram Lane, Moonlight Trail, Estelle Lane, and Lynn Lane. The City saves a substantial amount of money by using the interlocal, but there are various elements that are normally in a contract that are missing from the interlocal. The main element missing is scheduling. The City provides the contractor with a list of streets, and the contractor determines where and when the work is to be done. This can lead to traffic delays with little warning to the traveling public. The City spent over a half a million on street maintenance of these roadways.
