Minutes

Call to Order

Chairman Rhoads called the meeting to order at 7:00 p.m.

Chairman Rhoads determined that a quorum was present and reminded all in attendance to silence their cell phones. The Board conducted the Pledge of Allegiance.

Regular Agenda

1. Consider approving the minutes of the July 24, 2018 Parks and Open Space Board meeting.

Chairman Rhoads noted on page 1, Agenda Item 3, the date should be changed from November 4 to November 3.

MOTION: A motion was made by Chairman Rhoads, seconded by Vice Chairman Vanhorn to approve the minutes as amended. The motion passed unanimously by a 4 to 0 vote.

2. Consider quarterly review of Parks Board projects, goals and objectives established by the project matrix.

The Parks Board reviewed the matrix and discussed upcoming events and projects. There was no formal action on this item.

3. Discuss Keep Lucas Beautiful Fall Sweep Clean-up and Arbor Day Event.

Special Projects Coordinator Kent Souriyasak shared the details of the Fall Sweep Clean-up and Arbor Day event with the Board stating the event would take place on November 3 from 8:00 am – noon at the Community Park. He also noted that he had reached out to Lovejoy ISD and approximately 20-30 volunteers from the school would be taking part in the event.

Board Member Bill Esposito explained that the 4-H Club would again be participating in the Arbor Day event by providing 200 sapling trees consisting of Pecan and Shumato trees. Representatives from the Collin County Master Gardeners and possibly Texas Pure would be at the event to share information about their organic products.

The Board discussed items and supplies needed for the event.

4. Receive update regarding details of the Scarecrow Contest to be held November 3, 2018.

Board Member Debra Guillemaud updated the Board regarding the Scarecrow Contest details. She noted that to date there were six entries received and the deadline to register was Friday, October 26. Ms. Guillemaud asked the Board to complete their judging of the contest so that winners could be notified in advance and would also be announced at the Arbor Day event on November 3. The Board discussed placing ribbons for the winners on the scarecrow displays in the park and staff would print certificates to be handed out at the event on November 3 along with the gift cards.

5. Update on improvements to the Lucas Community Park, East Winningkoff Trailhead, Kenneth R. Lewis Park, and Forest Creek Park.

Development Services Director Joe Hilbourn discussed updates to the various parks including:

- Lucas Community Park Items still needed:
 - o Split rail fencing would be added in two areas: 1) separation of the parking lot from the park; and 2) separation between the Community Center to the Public Works yard
 - o Cleanup of landscaping
- East Winningkoff Trailhead pricing for the round pen came in high, bids will be attempted again at a later date
- Kenneth R Lewis Park Items still needed:
 - o Drainage and erosion prevention at sidewalks
 - o Additional landscaping
 - o Updates to pavilion; repair of roof leak
- Forest Creek Community Park This project was completed with the following items:
 - o Existing pavilion removed, and a new pavilion installed
 - o Tree line trimmed and thinned out
 - o Painting swing sets, refurbishing playground equipment, and new mulch
 - o Installed new benches, soccer goals, trees and picnic tables
 - o Basketball courts
 - o Grade and sod work

6. Update for possible grant funding for a Little League baseball field in the Lucas Community Park.

Development Services Director Joe Hilbourn explained that the City would be looking for grant funding as a source to fund the baseball field. Collin County Parks and Open Space has a bond proposition on the ballot in November for the acquisition and improvement of land for parks and open space purposes. Mr. Hilbourn explained that should that proposition pass and bonds were approved, the City would apply for funding in July of 2019. Mr. Hilbourn noted that staff would keep the board informed regarding this item.

7. Discuss partnering with the Trinity Trail Preservation Association (TTPA) for a cleanup event on Saturday, September 28, 2019 in support of National Public Lands Day.

Special Projects Coordinator Kent Souriyasak explained that National Public Lands Day was a holiday observed annually to encourage people to enjoy public land and promote conservation. On National Public Lands Day, volunteers gather to assist in cleaning up public lands including trails. Mr. Souriyasak stated that this cleanup event would strictly focus on trails and trailheads and would be a an opportunity to partner with TTPA.

The Board discussed its current partnership with TTPA on several items, most notably the Founders Day parade event. The Board also discussed ways to advertise for the event and possible grants that could be obtained in the long term by taking part in the event and having cross-agency partnerships.

MOTION: A motion was made by Mr. Esposito, seconded by Vice Chairman Vanhorn to partner with Trinity Trails Preservation Association for a cleanup event on September 28, 2019 supporting National Public Lands Day. The motion passed unanimously by a 4 to 0 vote.

8. Adjournment.

Founders Day is scheduled for Saturday, May 11, 2019 from 12:00 pm to 4:00 pm at the Lucas Community Park located next to City Hall at 665 Country Club Road. The planning has started in securing contracts, identifying vendors, and outreach to community partners. The committee will be meeting to work on detailing maps, parking, traffic control, and scheduling activities. Discuss details of the Keep Lucas Beautiful Spring clean-up event Don't mess with Texas Trash-Off on April 6, 2019.

Background Information

The Don't mess with Texas Trash-Off is Texas' signature cleanup event for the nation's Great American Cleanup program. The event is a partnership between Keep Texas Beautiful and the Texas Department of Transportation. As an affiliate member of Keep Texas Beautiful, the City participates in this annual cleanup to support efforts in clearing city-maintained areas and roadsides of trash.

In a joint effort for the cleanup event, the City will partner with United Electronic Recycling to provide a recycling drop-off for residents to dispose of electronics. The drop-off location will take place at and during the cleanup.

The City's Don't mess with Texas Trash-Off event will take place on Saturday, April 6 from 8 am to 12 pm. Volunteers will be asked to register for the cleanup and meet at Lucas Community Park on the scheduled event date. Food and beverages will be served to volunteers. Keep Texas Beautiful will provide cleanup supplies. Marketing and communication will be distributed through the Lucas Leader, City website, Lovejoy Messenger, Lovejoy ISD schools, churches, and local organizations.

Provide update on a grant with the Texas Department of Transportation for the purpose of constructing approximately 5.3 miles of the City's trail network, referred to as the exercise loop, adjacent to Estates Parkway, West Lucas Road, Allison Lane, and Country Club Road.

Background Information

The Texas Department of Transportation (TxDOT) has announced an upcoming call for projects for bicycle and pedestrian infrastructure. Two sources of funding will be included: Transportation Alternatives (TA) and Safe Routes to Schools (SRTS).

Who can apply?

- Texas communities of all sizes may apply for TxDOT's SRTS-Infrastructure funds to construct bikeway and pedestrian projects located within two miles of K-8 schools
- Texas communities of 200,000 or less are also eligible to apply for TxDOT's TA funds

What types of projects are eligible?

• Sidewalks, bikeways, shared use paths, traffic calming measures, and other safety improvements for non-motorized travel

When are applications due?

- TxDOT's Call for Projects will open in February 2019
- The 2019 TA/SRTS Call for Projects will have a two-step process: Preliminary Project Applications will be due in April 2019
 Detailed Project Applications will be due in August 2019
- Project sponsors must complete both application steps to compete for funding

Budget/Financial Impact

The options below are based on cost estimates from previous projects. There have been no estimates for this project to date. These cost estimates were shared with the City Council at their January 7, 2019 meeting, and the Council wanted to consider Option No. 2 for this project. The costs below do not include design or engineering.

Option 1:

Twelve-foot wide concrete trail times 28,000 lineal feet equals 336,000 square feet. 336,000 square feet times \$6.50 per square foot equals \$2,184,000. This is an estimate based on other project costs. The project would also need drainage, grading, easement acquisition, and approach replacement. An estimate of those portions of the project cost approximately \$900,000. Total cost is estimated to be approximately \$3,084,000.


Option 2:

Remove Allison Lane from the project and have the trail system utilize the sidewalk provided by commercial projects adjacent to Angel Parkway. Eight-foot wide times 22,000 linear feet equals 176,000 square feet times \$6.50 per square foot equals \$1,144,000 plus \$900,000 for drainage, grading, easement acquisition. The estimated cost is \$2,044,000.

Option 3:


Use trail pattern from Option 2 but replace concrete with crushed gravel, within edged border to hold in place with weed prevention material in the base. The cost has not yet been determined.
