# Outdoor Watering Schedule - Begins April 1, 2019

Beginning Monday, April 1, 2019, Lucas water customers are required to limit outdoor watering to twice per week. The outdoor watering schedule will help prevent stressing the capabilities of our water system. The City has established specific watering zones to help manage water usage. Please refer to the map below that identifies watering zones to help you determine your watering days. NO OUTDOOR WATERING WILL BE ALLOWED BETWEEN 10 am and 6 pm ON ANY DAY. 
Zone 1 Monday and Saturday

West of Country Club - North of West Lucas Road

Zone 2 Tuesday and Friday East of Country Club - West of Orr Road - North of Blondy Jhune

Zone 3 Wednesday and Saturday East of Country Club - South of Blondy Jhune - East of Orr Road - North of West and East Lucas Road

Zone 4 Thursday and Sunday South and west of East Lucas Road







Mayor's Message By Jim Olk

There is a lot of talk and press lately about property tax reform and revenue caps on municipal government. I can't open a publication without reading about the pros and cons regarding property taxation. So, I thought I would share some thoughts on this for my article this month. Under the current system, each year the Lucas City Council holds multiple budget work sessions and

public hearings. Council then sets a tax rate that is intended to meet the expenses of the City. If that tax rate exceeds the rollback rate of 8%, the citizens can petition for an election. If there is no petition, the tax rate goes into effect. Right now, the State Legislature is holding hearings on two identical bills (SB-2 and HB-2) that will attempt to limit the amount of increase in property taxes without an election being held. There are two categories; small taxing entities (those that raise less than \$15 million in property tax and sales tax revenue) and large taxing entities (those over \$15 million). The bill proposes to set 8% rollback rate for the small taxing entities and 2.5% for the large ones. These limits only impact the maintenance and operation (M&O) portion of a budget not the debt portion. The maintenance and operations (M&O) portion of our budget that pays for services like street maintenance, administration, fire services and police services, totals \$2.5 million. For the City of Lucas an increase of 8% to the maintenance and operation (M&O) budget revenue would equate to \$200,000. As the proposed bill stands, the implication for Lucas would be IF we needed to raise our revenues by more than \$200,000 for M&O (8 percent of \$2.5 million) the City would be required to hold an election and have the voters decide to allow the increase.

When I look at this from the big picture I can tell you, I am somewhat conflicted on this. On one hand, the State is proposing to establish a limit for tax increases without voter approval. I'm okay with that...if I can't justify that increase to you in an article like this or in a conversation, then maybe we shouldn't be spending that money. But the current system provides for transparent local government spending and an election if the people demand one. Whereas, on the other hand, I feel that the State is attempting to diminish the representative form of democracy that we have at the local level. They are saying the people you elected into office at the local level are not representing you and not listening to you and can't make budget decisions.

Three things that have come up recently that would be impacted by this come to mind. The City of Lucas recently purchased a new Fire Engine from our budget reserves. This was just over a \$737,300

purchase. We decided to pay for it out of reserves for several reasons, we got discounts for ordering before the end of the year, paying cash and we saved interest by not borrowing money. The second thing that has come up was a left turn lane on Parker Road into a subdivision in Lucas. TxDOT would not install the second turn lane as part of their reconstruction, so, for safety of those residents the City Council funded \$200,000 from the budget reserves to provide the necessary access. One other item, is that we have been putting money aside to purchase a new ambulance which we know will be needed very soon. This will be about a \$400,000 vehicle, which we will not borrow money for.

When you look at our M&O we need to have about a 3% increase just to cover the increases in cost of goods we purchase including things like concrete and asphalt, as well as keeping our staff salaries in line with the economy. Every budget year I suggest that we look more toward a "pay as you go" program, putting more money aside and earmarking it for purchases and expenses like the ambulance. I believe this type of revenue cap may hamper planning for future needs and push us toward borrowing more money. I believe that should the proposed election requirements be implemented for revenue increases we will have to take a longer look at issuing debt as it may be cheaper to borrow the money than it is to pay for an election.

I thought about touching on school tax reform, but I better not. Let me just say that on my tax bill, the City taxes equate to 13.5% of the total tax bill. For round numbers let's just say that the M&O for the City of Lucas is 50% of that (it is actually 48%). That means an 8% increase on the City M&O taxes equates to less than \$49.00 on my tax bill excluding all exemptions. I'm not sure I would call less than \$50 a year, tax relief or tax reform. And, in the bigger picture, isn't that why we select people to represent us, for them to gather all the facts and make these types if decisions so that we the residents don't have to get into the weeds of the day to day operation of running a city?

I do want to end on the bright side...the residents of Lucas have a very engaged and conservative City Council. Over the years they have managed to move forward with paid EMS/Fire staffing, increase our street maintenance budget, purchase a new fire engine, increase our partnership with the Sherriff's office by adding an additional deputy to patrol our community and are saving money for a new ambulance. These are just of a few of the things that we have accomplished all while lowering the tax rate. As I see it, the proposed 8% rollback rate probably should not really have a significant impact on the day to day operations of the City. However, it may have an impact as we look at growth in the City and the potential for expanded public safety needs and/or infrastructure maintenance and improvements. As always we will continue to communicate these issues with you. Thank you for allowing me to serve you.

# What's on the Ballot for the May 4, 2019 Election

Also on the ballot will be the continuation of the Lucas Fire Control, Prevention and EMS District, along with the option to continue allocating a portion of the City's sales tax to the Lucas Fire Control, Prevention and EMS District. The City receives two percent (2%) of the sales tax collected, one percent goes into the City's General Fund, 0.5 percent is allocated towards street maintenance and the remaining 0.5 percent is allocated to the Fire District. The sales tax allocated to the Fire District helps to fund EMS and Fire Department expenses. Early voting will take place at the Lucas Community Center beginning April 22 through April 30 and on Election Day May 4. #### **Know What's Below - Call 811 Before you Dig**

Whether planting a tree, grading for a drive or walkway, installing sprinklers, replacing fence posts, putting in new garden beds, or drilling for oil .... You get the idea...call 811 at least 48 hours before you dig. This local one call utility service will arrange for marking underground utilities so you can stay safe, service is not interrupted, and you can avoid potential fines and repair costs. I know from personal experience.

A few years ago, I arranged to replace fencing along the back of my property. I was advised to call 811 before work began. I thought it was unnecessary, and made no sense to me that a cable would be buried in the remote corner of my pasture. Nevertheless, I called and watched various utility companies come mark their lines; all in the front of my property. With confidence we proceeded. Boy, were we surprised when we dug up and cut through a cable which in turn disabled service to a portion of the neighborhood. But not as surprised as the impacted utility company that discovered the cable in question had not been properly marked in the company documents, and thus wasn't marked on my property making the utility company, not me, liable for the repairs. Know what's below, before you dig and call 811. When you see flags around town or in your neighborhood, the color coding chart below is used for marking underground utility lines:

White: Proposed excavation

Temporary survey markings

Electric power lines, cables, conduit and lighting cables Gas, oil, steam, petroleum or gaseous materials

Communication, alarm or signal lines, cables or conduit

Potable water

Reclaimed water, irrigation and slurry lines Purple:

Sewer and drain lines

#### NTMWD Annual Change In Disinfectant to Treatment Process

The North Texas Municipal Water District (NTMWD) will temporarily change the disinfectant in its water treatment process from March 4 through April 1, 2019.

The annual, routine change is necessary to maintain the regional system and year round water quality. Disinfection is a critical part of the water treatment process that keeps drinking water free of harmful microorganisms, such as parasites and viruses. During the temporary change, NTMWD suspends adding ammonia and uses only free chlorine to keep water disinfected as it travels through pipes. NTMWD and the Texas Commission on Environmental Quality (TCEQ) confirm that NTMWD has maintained high water quality each year during its annual disinfectant change. The absence of ammonia during these few weeks may make the chlorine disinfectant more noticeable. There are simple steps to minimize taste, odor or skin sensitivities, including placing a pitcher of water in the refrigerator overnight or adding a slice of citrus to the water. Adding a crushed 1000 mg Vitamin C tablet to bath water will remove the chlorine. For more information, visit www.ntmwd.com/safewater.

# **Mosquito Prevention**

Not all mosquitoes are the same. Different mosquitoes spread different viruses and bite at different times of

the day. There are several viable options available to homeowners that can keep mosquitoes at bay. Remove mosquito habitat by removing any standing water so they don't have a place to lay their eggs. Keep swimming pool water treated and circulating. Use structural barriers such as window and door screens and cover all gaps in walls, doors and windows to prevent mosquitoes from entering your home. Plant herbs and flowers that give off scents that mosquitoes dislike and avoid, such as basil, lavender, mint, citronella, rosemary, and marigold. Use insect repellent that is safe and effective (www.epa.gov/insect-repellents/find-insect-repellentright-you). Treat clothing and gear with permethrin.

The City of Lucas uses "mosquito dunks" to assist in controlling the mosquito population. Mosquito dunks contain BTI which is a natural larvicide which kills mosquito larvae, but is harmless to birds, fish, wildlife, and pets. When a dunk is placed in standing water, it will control mosquito larvae for up to 30
