A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LUCAS, TEXAS, CANVASSING THE RETURNS AND CERTIFYING THE RESULTS OF THE MUNICIPAL OFFICERS ELECTION OF THE CITY OF LUCAS, TEXAS, HELD IN THE CITY OF LUCAS, COLLIN COUNTY, TEXAS, ON MAY 4, 2019 FOR THE PURPOSE OF ELECTING TWO CITY COUNCIL MEMBERS FOR SEAT NO. 5 AND SEAT NO. 6 TO SERVE THREE (3) YEAR TERMS, BEGINNING MAY 16, 2019; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 4, 2019, a municipal officer election was held in the City of Lucas, Collin County, Texas for the purpose of electing two (2) council members;

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LUCAS, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE SPECIAL ELECTION OF THE CITY OF LUCAS HELD MAY 4, 2019 REGARDING PROPOSITION (A) WHETHER THE CITY OF LUCAS FIRE CONTROL, PREVENTION AND EMERGENCY MEDICAL SERVICES DISTRICT SHOULD BE CONTINUED FOR 10 YEARS, AND THE FIRE CONTROL, PREVENTION AND EMERGENCY MEDICAL SERVICES DISTRICT SALES TAX SHOULD BE CONTINUED FOR 10 YEARS; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.
