> WHEREAS Thomas M. Buie, Caroline P. Buie, Mike Hanna and Beth E. Hanna are the owners of a certain tract of land situated in the State of Texas, County of Collin, City of Lucas, in the John Gray Survey, Abstract No. 349, being that same 5.000 acre tract of land conveyed to James Lewis as recorded in Volume 1720, Page 811 of the Collin County Deed Records, and being more particularly described as follows: BEGINNING at an iron rod set in Stinson Road marking the northeast corner of the said 5.000 acre Lewis tract;

> THENCE with the east line of the said 5.000 acre tract, South, passing at 22.00 feet an iron rod marking the northeast corner of a 2.500 acre tract conveyed to T. M. Buie as described and recorded in Volume 2121, Page 368, Deed Records of Collin County, in all on this line a distance of 322.86 feet to an iron rod found marking the southeast corner of the said 5.000 acre tract;

> THENCE with the south line of the said 5.000 acre tract, South 89°37'00" West, passing at 361.97 feet an iron rod marking the southwest corner of the said T. M. Buie tract, in all on this line, a distance of 676.02 feet to an iron rod set marking the southwest corner of the said 5.000 acre tract;

> THENCE with the west line of the said 5.000 acre tract, North 00°30'00" East, a distance of 322.89 feet to an iron rod found marking the northwest corner of the said 5.000 acre tract;

> THENCE with the north line of the said 5.000 acre tract, North 89°37'00" East, a distance of 673.20 feet to the point of beginning and containing 5.000 acres of land.


