MEMORANDUM OF UNDERSTANDING**



General Requirements

This Memorandum of Understanding is made and entered into between the City of Lucas Fire-Rescue and _____ (print name of volunteer emergency responder) to establish general guidelines and expectations. All volunteer emergency responders must abide by the Standard Operating Procedures (SOP), Standard Operating Guidelines (SOG), and the EMS protocols of the City of Lucas Fire-Rescue. A copy of the SOP manual is available to all responders and is located at <https://policy.lexipol.com/agency/login>. A printed copy of the SOG manual is located in the Fire-Rescue Ops/Watch Room and on the department's computer shared drive (S:\SOP_SOG). All volunteer emergency responders must comply with workplace policies and administrative procedures established in the City of Lucas Employee Policies and Procedures Handbook. However, if a Volunteer is dismissed from their duties for any reason, they shall have no right to an appeal. A copy of this handbook is available to all responders and is located in the Fire-Rescue Ops/Watch Room and on the department's computer shared drive (S:\Human Resources documents).

All volunteer emergency responders shall:

- pass a background investigation and drug test;
- be at least 18 years of age;
- have a valid high school diploma or GED;
- possess a valid Texas Driver's License;
- possess at least one fire certification (TCFP Basic or above or SFFMA Introductory or above);
- preference given to those with one EMS certification (DSHS EMT-Basic or above);
- understand the City of Lucas and the City of Lucas Fire-Rescue names and/or logos shall not be displayed in any manner unbecoming of the department; and
- understand gear and uniforms issued are property of the City of Lucas Fire-Rescue. If you leave the department, you must return all gear and uniforms.

In addition, all volunteer emergency responders shall agree to successfully complete the following City of Lucas Fire-Rescue training:

- emergency vehicles operator's course, which includes the department training to operate squads and ambulances;
- medical skills assessment, for those with an EMS Certification;
- fire skills assessment, which includes a live fire component;
- participate in a minimum of 60 training hours and 240 company training hours annually;
- document a minimum of 500 service hours annually;
- participate in a minimum of one live structural fire training annually;
- successfully complete the annual physical ability test;
- successfully complete the annual mask fit test; and
- all EMS certifications remain your responsibility to renew, including payment of certification and/or recertification fees.

Failure to meet the volunteer emergency responders' expectations as stated above will result in the volunteer being placed on an ineligible list, which disqualifies you from the benefits outlined below. Disciplinary action that may include the volunteer emergency responder being placed on a performance improvement plan, and/or up to being released from the department.

Volunteer emergency responders in good standing are eligible to receive a stipend in accordance with program guidelines, participate in the Texas Emergency Services Retirement System (TESRS) and the Length of Service Award Program (LOSAP). The goal of the volunteer emergency responder is to participate in the "City of Lucas Fire-Rescue Staffing Plan" in accordance with departmental strategies.

Stipend Program:

Volunteer emergency responders in good standing are eligible to receive stipends based on the following guidelines:

- Volunteer emergency responders with rank of Chief Engineer, Deputy Chief, or Night Incident Commander will receive a flat rate stipend of \$625 per month.
- All volunteer emergency responders shall agree to volunteer for at least 48 shift hours a month
- Volunteer emergency responder stipends are based on the following:
 - Day shift (7:00 am to 7:00 pm) = \$75
 - Night Shift (7:00 pm to 7:00 am) = \$45
- All volunteer emergency responders shall agree to sign up for 12- or 24-hour shifts on the department calendar. Once you sign up for a shift, it is your responsibility to be at that shift. If you are unable to be at that shift, it is your responsibility to find a replacement and notify the shift officer at least 24 hours in advance of that shift. If an emergency arises, notify the shift officer immediately.
- Sign-ups will be completed in the "FD Shift Calendar" in Outlook.
- The maximum stipend an individual may receive annually is \$7,500. Volunteer Emergency Responders may sign-up for additional shifts, but stipends will not be paid over the \$7,500 maximum.
- Sign-ups will be completed by the 15th of the current month for the next month. There will be two months posted for sign-ups.

This memorandum of understanding is valid from the date signed, and supersedes any previous document signed, by the volunteer emergency responder and accepted by the City of Lucas until dissolution by the volunteer emergency responder or the City of Lucas.
