





- 1. COMMUNICATION CONDUITS, EQUIPMENT, AND RELATED COMPONENTS ARE LOCATED ON THE WINNINGKOFF ELEVATED TANK. THE CONTRACTOR SHALL KEEP THE COMMUNICATION CONDUITS, EQUIPMENT, AND RELATED COMPONENTS IN PLACE DURING THE PAINTING PROCESS AND SHALL PROTECT THE COMMUNICATION CONDUITS, EQUIPMENT, AND RELATED COMPONENTS AT ALL TIMES DURING THE PAINTING WORK ON THE TANK.
- 2. CONTRACTOR SHALL PAINT THE INSIDE OF THE TANK FIRST AND SHALL BE PREPARED TO PLACE THE TANK BACK IN SERVICE WHILE PAINTING THE OUTSIDE, IF DIRECTED TO DO SO BY THE CITY.
- CONTRACTOR SHALL TAKE WHATEVER MEASURES NECESSARY TO PROTECT SURROUNDING AREAS FROM ANY ADVERSE IMPACTS FROM PAINTING PROCESS.
- 4. THE EXISTING ANTENNAS ON THE OUTSIDE OF THE RISER/PEDESTAL OF THE WINNINGKOFF ELEVATED TANK WILL BE REMOVED BY OTHERS PRIOR TO THE BLAST CLEANING AND PAINTING BY THE CONTRACTOR AND WILL BE REPLACED BY OTHERS AFTER THE TANK IS PAINTED.
