Agenda Item Request

Consider a City of Lucas sponsored Car Show to be organized by Lucas Citizen Tony Prutch.

Background Information

Tony Prutch met with city staff to discuss the creation of a local car show. The City of Lucas has many citizens that enjoy the restoration of unique cars that would support an opportunity to display their restored vehicles. Mr. Prutch has a relationship with Mustang Sally Productions located in Murphy, Texas that is owned and operated by the Forsyth/Winkler family. This family has a rich history in the custom vehicle business and expertise in the creation and management of car shows in the North Texas Region. The Mission Statement of Mustang Sally Productions is:

"We are here to bring fun, friendly competition, and a forum for gathering the family of show car enthusiasts together to promote a culture of beautiful creations and fun experiences with great people."

Mr. Prutch will organize a group of Lucas car enthusiasts to produce the event in partnership with Mustang Sally Productions. The City of Lucas would provide information to promote the event in the Lucas Leader and add the event to its liability insurance with TML Intergovernmental Risk Pool. The City would also enter into an agreement with Lovejoy ISD to hold the event at the Lovejoy High School Campus.

City of Lucas Parks and Open Space Board Request January 25, 2022

At this point in time, the only items that have been addressed is from the checklist dated October 7, 2021, except for the following items that were noted on this report:

- 1. There were several comments regarding the infield which is a multipurpose practice field. If a higher standard is preferred, this would need to be budgeted.
- 2. Sun protection for the bleachers, height of the dugout and a scoreboard was also mentioned and again, this would take funding.

Other pending items from the checklist dated October 7, 2021, include:

- 1. Cracks in the walls of the restroom are foundation issues with pavilion.
- 2. Additional pruning of trees throughout the park.
- 3. Adding dirt near concrete edge of pavilion to lessen drop-off

In response to the report dated November 1, 2021 regarding locked bathrooms at Kenneth R. Lewis Park, Public Works Director Scott Holden will follow up to ensure the facilities are more accessible.

In response to the report dated January 7, 2022 regarding the playground equipment in Forest Creek Park, in the fall 2021, the City submitted a grant application to Texas Parks & Wildlife Local Parks Grant Program for new playground equipment to be replaced at Forest Creek Park. If awarded, the grant provides 50% matching funds up to \$150,000. Texas Parks & Wildlife is currently reviewing grant applications and will announce grant recipients in spring or summer 2022.

The City will also work on ordering mulch which it does annually and was mentioned in several reports.

Scott,

All of the following items have been completed at the Kenneth R. Lewis Park:

- All the weeds have been pulled from the flower beds and from under the bleachers
- The door to the storage shed has been reattached and secured
- All the landscaping rocks have been put back in place to circle the trees
- All the trash cans have been emptied and cleaned
- All the trash has been picked up and discarded
- The parking block that was busted has been removed
- The trees down the walking paths have been trimmed(we will be doing more tree trimming as time permits but the walking path is clear for use)
- The softball infield has been cleared of all weeds and drug out nicely

Items that have not been or may not need to be addressed:

- 1. "The infield is dirt not grass"
 - It is a softball field and is intended to be sand
- "The pitcher's mound is only a pitcher's rubber"
 - Softball fields do not have mounds
- 3. "There is no sun protection or foul ball protection for the spectators in the bleachers"
 - Is this something that we would want to fund in the future? Currently there is a high fence behind the home plate that serves as a foul ball protection.
- 4. "There are no lights or scoreboard"
 - There used to be a scoreboard however it was never used and was removed. Would we like to add lights
 for the field? I think this would be a no but I am happy to get quotes if this is something we would like to
 do.
- 5. "There is no sun protection for the soccer spectators in the bleachers"
 - Is this something that we would want to fund in the future?
- 6. "Roof in dugout is less than 6ft tall"
 - The dugouts measure 6' 8" in the front and 6' 1" in the far back behind the bench seat. I have plenty of room to walk around and do not hit my head but I am not sure how tall there are supposed to be.

Pending Items:

- 1. Cracks in the walls of the restroom area and foundation of pavilion
 - Meeting set to observe on Friday with Joni to create a plan of action
 - Possibly look at replacement with separate bathroom structure
 - Possibly foundation repair(I will get estimates if this is what we choose to do)
- 2. Additional tree pruning throughout park as time permits
- 3. Add dirt near concrete edge of pavilion to lessen the drop-off
 - Will complete soon weather permitting

Agenda Item Request

Consider the appointment of Management Analyst Patrick Hubbard and Assistant to the City Manager Kent Souriyasak as the city staff liaisons to the Parks and Open Space Board.

Background Information

Management Analyst Patrick Hubbard joined the City of Lucas on April 26, 2021. Patrick is a graduate of the University of North Texas, Master of Public Administration program and has over five years of experience in Texas city government. Most of Patrick's experience is divided between Engineering, Development Services, and Grant Management. He has held front-facing, cross-departmental roles and has worked closely with most city departments and several boards in three Texas cities. This includes work with parks planning, parks grants and special events. Patrick currently serves in the Engineering Department where his responsibilities include such things as capital project administration, plan review, inspections, compliance reporting, department communications, long-range planning, and geographic information systems. ARTICLE 1.09 PARKS AND RECREATION

Division 3. Park Rules

See. 1.09.061 Penalty

Any person, firm or corporation violating any of the provisions of this division shall be deemed guilty of a misdemeanor, and upon conviction in the municipal court of the city shall be subject to a fine as provided in section 1.01.009 of this chapter for each offense.

Sec. 1.09.062 Conduct prohibited in parks

As used in this division, "city park" or "park facility" shall mean any area in the city owned or used by the city, or by the city jointly with any other governmental or private entity, devoted to active or passive recreation, and includes but is not limited to athletic fields, recreation areas, community center property, and those areas designated as city parks. The following acts, omissions or conduct are prohibited within the limits of all city parks and no person, firm or corporation shall engage in, commit, cause, or suffer the following acts, omissions or conduct:

- (1) To enter or remain in any park facility between the hours of 11:00 p.m. and 5:00 a.m. unless different hours for the park facility have been designated. All soft surface trails shall be closed from dusk until dawn where onsite signage is posted, unless different hours have been posted;
- (2) To allow any pet or animal to run at-large or fail to keep a pet or animal restrained by a leash, chain or cord not more than six (6) feet long;
- (3) To dump or litter any park. All persons shall use receptacles provided for the deposit of refuse;
- (4) To tie or restrain an animal by attaching its leash to fencing, trees, benches, bleachers, pole or other park facility infrastructure;
- (5) To operate a motor vehicle within any city park in any area not designated as a roadway for vehicular traffic (for the purposes of this subsection, "motorized vehicle" means any vehicle or conveyance which is self-propelled) which would exclude electronic wheelchairs or electric scooters for the disabled;
- (6) To use or ride on a skateboard within a city park;

(Ordinance 2014-12-00803 adopted 12/4/14)

- (7) To possess, use, discharge or employ any fireworks, firearm, BB gun, air gun, bow and arrow, or slingshot is prohibited with the exception of licensed holders who are authorized to carry firearms in accordance with state law; (Ordinance 2016-05-00838 adopted 5/19/16)
- (8) To sell, possess or consume any alcoholic beverage;
- (9) To erect, post, distribute, or place any advertising material, sign, circular, or handbill without the prior permission of the city;

(Ordinance 2014-12-00803 adopted 12/4/14)

- (10) (A) To practice, conduct, or carry on any commercial activity, trade or business activity unless said commercial activity has been approved through a facility use agreement issued by the city manager or designee.
- (B) In approving a facility use agreement for a commercial activity, the city manager or designee shall consider whether such activity is classified as a recreational activity that enhances the overall well-being of participants and includes but is not limited to the provision of physical fitness classes, athletic sports activities and services that promote healthy lifestyles. It does not include the sale of products and/or goods. While this activity may serve nonresidents, the provider must make the provision of recreational programming to city residents a priority. The number of city residents served may be taken into consideration on future applications for use of park facilities.

(Ordinance 2015-03-00812 adopted 4/16/15)

(C) City residents only may reserve the city park facilities for commercial residential activity daily from 5:00 a.m. through 8:00 a.m. and from 7:00 p.m. through 9:00 p.m. The community center is not available for use for

commercial residential activity and may only be reserved by city residents.

- (D) A city facility use agreement must be completed and submitted to the city manager for consideration along with the required fee as shown in the fee schedule set forth in appendix C. The applicant must provide documentation demonstrating the vendor's liability insurance coverage in the amount of \$1,000,000.00 and must name the city as an additional insured on the certificate of insurance. The applicant shall be responsible for any damage to the park facilities.
- (E) The applicant may reserve the park facility up to two months in advance of the event and must reapply for any subsequent use. If any park facility is left in a condition that is unacceptable to the city, the city reserves the right to not allow the vendor to use any of its facilities in the future.

(Ordinance 2019-12-00901 adopted 12/5/19)

- (11) To cause, create or maintain any nuisance or engage in any conduct or activity that unreasonably disturbs persons of ordinary sensibilities;
- (12) To use any type of sound amplification devices which include but are not limited to loudspeakers, amplifiers or microphones without the written permission of the city;
- (13) To ascend, descend, operate, or launch any aircraft, including but not limited to hot air balloons, airplanes, paraplanes, ultralight aircrafts, helicopters, drones, remote/radio controlled devices and gliders;
- (14) To hit golf balls of any type in a park facility;
- (15) To camp overnight in or upon any park facility;
- (16) To enter onto a reserved facility or area, or a location where scheduled activities are occurring, during the period that the area or facility is reserved or during the scheduled activity and remain or return there after the person has been given notice to leave. Reserved facilities and areas, and scheduled activities, include but are not limited to: athletic fields and pavilions;
- (17) To make or kindle a fire except in public stoves, grills, fire pits, or designated areas provided for that purpose. Fires shall not be left unattended and must be extinguished prior to departure. The city manager may prohibit all fires in public parks during those periods that he, in his sole discretion, determines that extreme dry weather, high winds or other conditions endanger public health and safety;
- (18) To use or consume any tobacco products within a park facility;
- (19) To destroy, damage, deface or remove shrubbery, trees, soil, grass, turf or other vegetation, rock, minerals or any other personal or real property.

(Ordinance 2014-12-00803 adopted 12/4/14)

Sec. 1.09.063 Reservation of Lucas Community Center

The Lucas Community Center shall only be reserved by individuals residing within the territorial limits of the city. Any city resident requesting a reservation of the Lucas Community Center shall provide proof of residency and submit a completed facility use agreement in the form approved by the city to the development services department for approval prior to reserving the facility. Any damage to the facility or property located within the facility caused by the applicant or attendees shall be the responsibility of the applicant. The applicant shall be responsible for the repair and/or replacement of the damage caused to the facility or property located within the facility. (Ordinance 2019-12-00901 adopted 12/5/19)

ARTICLE 21.000 PARKS AND RECREATION

- (a) Pavilion fee (nonresident): \$25.00/hour.
- (b) Pavilion rental (resident): \$25.00/4 hours; \$50.00/all day.
