Lucas Farmers Market Chairman Bill Esposito started the discussion regarding vendor selection and the spreadsheet was presented for review by both Parks and Open Space Board and Lucas Farmers Market Committee. Each vendor was reviewed, and a comprehensive conversation occurred regarding product quality, diversity of products being offered, preference to vendors who previously participated as well as those who were Lucas locals. Additional vetting will need to be complete for a select group of vendors.

A request was made by Pam Poteete to distribute the map and have a future discussion on space assignments and layouts. Kathrin will send information out and place on the March 1, 2022 agenda.

5. Discuss Vendor Recruitment.

The Lucas Farmers Market Committee identified a need for a bread vendor (not quick bread). The market also needs dairy and hard cheeses as well as additional produce.

6. Consider Special Events that will enhance the Lucas Farmers Market experience and create a schedule of events to boost market attendance.

7. Consider the Lucas Farmers Market Marketing Plan.

Laura Giles would like to have somebody assist with the website and additional promotion. John Elliott thought we should explore an internship with a Lovejoy High School student. The group agreed to reach out to the community to see if a member of the community wants to participate. Bill Esposito discussed the Lucas Farmers Market budget, and it is a break even with the revenue brought into the City with the fees and the expenses of approximately \$5,000. Laura mentioned that the whole group needs to be a marketing ambassador.

8. Consider the Market Share Program.

ACO will be featured in April and the Samaritan Inn will be featured in May at the Market Share Booth.

9. Consider the Youth Booth Program.

A discussion occurred regarding youth booths and the original intent of the Lucas Farmers Market Committee and whether to allow more than one youth booth per market. A recommendation was made to establish a youth area for the first market to accommodate multiple youth vendors.

Bill Esposito made a motion to approve the youth applications as present and it was seconded by Pam Poteete. Approved 4-0

10. Consider the GO TEXAN Program

Tammy Duke confirmed that we want to pursue the \$50 tier one membership for Lucas Farmers Market. She will continue to try to contact them and clarify the application process and whether a rule change will be necessary. For example, a vendor subcommittee may be necessary to qualify for this program and we direction on the composition of this subcommittee/advisory committee.
