Upcoming Trash and Recycling Transition

Beginning in October 2022, Community Waste Disposal (CWD) will become the new residential trash and recycling services provider. The new base residential trash and recycling services will include one free CWD trash cart and one free CWD recycle cart. All residents will receive weekly collection of trash, recycling, and brush/bulk. In addition, all residents will have the opportunity to request door side collection of household hazardous waste or used electronics twice per year. These services are included with your base residential rate of \$26.10 (including taxes and fees). A senior citizen discount rate of \$23.49 (including taxes and fees) is also available to request if you meet the requirements. There are also optional services you may request for an additional fee such as extra carts, concierge service, and manure/stable matter collection. In preparation for the upcoming residential trash and recycling services transition to Community Waste Disposal (CWD), please be aware of the following updates regarding the transition process from Barnes Waste Disposal and Republic Services to CWD:

NEW UPDATE: CWD Delivery of New Trash and Recycle Carts

CWD will be delivering one new trash cart and one new recycle cart to each Lucas residence early beginning September 26, 2022. Your new trash cart and recycle cart will be delivered on what would be your new service day. When you receive your new trash and recycle carts, you can begin to utilize them. The new CWD service will begin October 3, 2022. There will also be a CWD brochure attached to your new cart which provides information on the new available services and collection schedule.

NEW UPDATE: Look Up Your Service Day

CWD has developed an online search tool for you to easily look up your service day. To use this online tool, go to https://communitywastedisposal.com/view-my-schedule and enter your residential address. After entering your address, your collection schedule will show the day that will be your weekly pickup. Please note CWD service will begin the week of October 3, 2022.

Republic Services Recycle Carts Removal

The last day of subscription-based recycling service by Republic Services is September 23, 2022. Please leave your Republic

recycle carts out after your regular recycling pickup has been collected. Your Republic recycle carts will be removed beginning September 24, 2022. Republic Services will be sending out notifications to remind all subscribers to leave their recycle carts out so they can be removed. If your recycle cart does not get removed, please continue to leave the cart out until it is removed by Republic Services.

Barnes Waste Disposal Trash Carts Removal

The last week of trash service by Barnes Waste Disposal is September 26-30, 2022. Please leave your Barnes trash carts out after your regular trash pickup has been collected. Your Barnes trash carts will be removed throughout the weekend and the first week of October. If your trash cart does not get removed, please continue to leave your cart out as work crews will continue to remove any remaining carts.

Senior Citizen Discount Rate

The City will offer a senior citizen discount rate for seniors ages 65 or older on base residential trash/recycling services only. Seniors ages 65 or older can apply for the senior citizen discount rate. This discount does not apply to additional optional services such as extra carts, concierge service, excess bulk, or manure/stable matter collection. MAYOR'S MESSAGE

Thought we would talk about the City budget this month. Our City budget is adopted in September and the City Council has been going over the numbers for several months now. We have been looking at what we need for the upcoming year, as well as large items and capital projects several years into the future.

One of the things that I have asked City Council to consider is looking at more of a pay-as-you-go budget approach. Most governmental entities borrow money for large capital purchases using bonds or Certificates of Obligation to fund those purchases. Whereas a pay-as-you-go budget plans for future capital expenses and sets aside (or saves) for those upcoming expenses. This type of pay-as-you-go budget is extremely difficult to switch over to with recent changes made at that State level regarding tax rate increases. The upside to using bonds or Certificates of Obligations is that you can build that street or buy that piece of equipment now rather than waiting until you have saved up the capital for making that purchase. The downside of borrowing money is that we use tax dollars to pay interest. As the interest rates climb, this may be more of an issue affecting the total amount of what the City could borrow.

Let me give you an example that we are looking at right now. We know that we will need to replace one of our fire engines in six to seven years, but with a two-year lead time on fire engines, we will need to have that money in four to five years. A new fire engine is a \$1.2 million dollar purchase. So as a City Council, do we find a way to save \$250,000 a year for the next five years to pay for it outright; do we wait until that time and borrow the money not knowing what our interest rate will be and how long until we pay it off; or do we look at some combination of the above saving and borrowing?

As I mentioned earlier, with the State limiting how much of an increase can happen in our property tax rate without an election, it becomes very difficult for City Council to make a decision on how to fund these big purchases. Just as a side note, a one cent change (up or down) in the City's property tax rate equates to approximately \$150,000 increase or decrease in the City's property tax levy.

There is really not a right or wrong way in choosing which way to budget for capital expenses. There may even be a good hybrid mix of budgeting that can work for the City of Lucas. I just wanted y'all to know that your Council does study the budget in depth and they are always looking at what is best for the community and what will keep Lucas the gem that it is.

Please feel free to let City Council know how you feel about saving vs. borrowing for those known items. Once again, thank you for allowing us to serve you.

PUBLIC HEARINGS SET TO DISCUSS BUDGET AND TAX RATE

A public hearing has been set for September 1, 2022, at 6:30 pm to consider and approve the fiscal year 22/23 budget for the Lucas Fire Control, Prevention and EMS District. Immediately following the Lucas Fire Control, Prevention and EMS District meeting (approximately 6:35 pm), a public hearing to consider and approve the City of Lucas proposed fiscal year 22/23 budget will take place.

Setting the tax rate for fiscal year 22/23 will occur following adoption of the budget. If the proposed tax rate does not exceed the "voterapproval" rate (the lowest tax rate option of \$0.244823) no public hearing is required. If the proposed tax rate exceeds the "voter-approval" rate, a public hearing to consider and approve the proposed tax rate will be held September 1, 2022. The City Council will then take a record vote on the proposed tax rate. - From U.S. Highway 75, exit Bethany Road and go east for approximately 6 miles to FM 1378 (West Lucas Road).
- . Go on FM 1378 (West Lucas Road) to the stop light and turn left on FM 3286 (East Lucas Road) at the Lucas Food Store.
- 3. Drive 2.4 miles and go over the first bridge over Lavon Lake.
- 4. Turn left on Snider Lane, which is before the second bridge.
- 5. Drive and look for the white pipe fence on your right.
- 6. This is the Highland Park Trailhead.

All volunteers will receive cleanup supplies and City staff will safely transport volunteers to cleanup areas. After the cleanup event, a special volunteer lunch will be provided at the Highland Park Trailhead. The Blackland Prairie Raptor Center will have live raptors onsite with an educational, interactive experience. North Texas Municipal Water District will have an education stream water trailer. OUTDOOR WATER SAVING TIPS

Train your lawn to drink less.

You can encourage deeper roots and a more drought-tolerant lawn by spacing out irrigation days to no more than two days a week.

Know when to water.

Follow the weekly watering advice offered every Monday on SaveTarrantWater.com. The watering advice can keep their irrigation systems off an average of 25 or more weeks per year.

Timing is everything.

Avoid watering between 10:00 am and 6:00 pm. Up to 30% of the water sprayed during this time of day can be lost to evaporation.

Check your rain and freeze sensors.

Make sure your rain and freeze sensors are working properly on your sprinkler system. If you don't have one, install one. They are a proven way to reduce your overall outdoor water use by 5 to 10%.

IMPORTANT CITY ALERTS

New Public Information and Citizen Request Systems

The City is currently transitioning to GovQA/Granicus for new public records and citizen request management (CRM) systems that will be user friendly while ensuring you get the information you need. The new public records and CRM are expected to be implemented before the end of September and will be available to access on the City's website. This new system offers a more robust process for you to track your requests. The City will be offering the CRM as a new feature for residents to easily report and track issues online. Residents will be able to conveniently report issues such as potholes, noise, dumping, fallen trees, and more. With this new CRM system, the City will be able to track and provide updates to residents regarding reported issues. Please look out for more information on how to access the new public records and CRM systems after the City has completed the implementation process and goes live.

North Texas Municipal Water District Odor Control at the Wilson Creek Regional Waste Water Treatment Plant (3020 Orr Road)

North Texas Municipal Water District (NTMWD) has a dedicated crew to maintain odor control equipment and respond to any complaints. This team is trained to respond quickly, identify the source of odor, and make necessary adjustments. New Telephone System at City Hall and Fire Station

In early August, the City began the process of transitioning over to a new digital telephone system to replace the current outdated system at City Hall and the Fire Station. The outdated telephone system had aging hardware in which parts are obsolete and created voicemail system issues. The transition to the new telephone system will not cause any change to current city telephone numbers. The new digital telephone system and voicemail should be fully functional by or before September.

Republic Services Billing Issue

Republic Services' final bill shows billing through October 31, 2022. Republic's billing system has billed subscribers for this final quarter and will be issuing refunds after all accounts have been closed.
