# **COMPREHENSIVE PLAN REVIEW**

The City of Lucas is currently in the final stages of approving an updated Comprehensive Plan that help lay out the vision for the City moving forward. Comprehensive Plans are updated every 5 years, with the previous Comprehensive Plan being updated in 2017. The purpose of the Comprehensive Plan is to indicate the general locations recommended for various land uses, transportation routes, streets, parks/ trails, water infrastructure, and other public and private developments and improvements.

A review of the Comprehensive Plan began in January 2022 as the Planning and Zoning Commission was tasked with reviewing and providing recommendations and revisions to the City Council. From January to present, the Planning and Zoning Commission has meticulously reviewed each chapter of the Comprehensive Plan. At the November 10, 2022, Planning and Zoning Commission meeting, the Commission recommended that City Council approves the Comprehensive Plan. The City Council will conduct a review of the Comprehensive Plan at the December 1, 2022, City Council meeting.

The public will have an opportunity to speak on the Comprehensive Plan during the two public hearing sessions that will take place in January. The first public hearing will be held on January 12, 2023, by the Planning and Zoning Commission, while the second public hearing will be held on January 19, 2023, by the City Council for final approval.

# **CAPITAL IMPROVEMENT PLAN**

The City of Lucas is currently in the process of updating the Capital Improvement Plan (CIP). The CIP links local infrastructure investments with comprehensive plan goals, land use ordinances, and economic development efforts. The CIP bridges the gap between planning and spending as well as between the visions of the comprehensive plan and the fiscal realities of improving and expanding community facilities. Examples of capital projects include construction or expansion of public buildings, the acquisition of land for public use, planning, water system improvements, engineering costs, and street and drainage construction.

# **CONSTRUCTION PROJECT UPDATES**

### **Forest Grove Road Rehabilitation**

The City of Lucas rehabilitated the segment of road between Orr Road and Stonegate Boulevard in October 2022. This segment of thoroughfare was identified in the City's pavement assessment as a good candidate for rehabilitation based on condition and this segment serves a high volume of daily traffic.

### Hendrick Farms and Blondy Jhune Road

Construction has commenced on the realigned segment of Blondy Jhune Road from Country Club just to the east of 910 Blondy Jhune Road. The road alignment will be adjusted to allow for a gradual turn and the new surface will be concrete, resulting in Blondy Jhune being a fully concrete road. The developer of the Hendrick Farms subdivision is managing this project as part of their overall subdivision construction and is projected to complete construction by December 1, 2022. The road, water and drainage construction on the development will wrap-up shortly thereafter.

### **TxDOT Construction on Estates Parkway (FM2170) and Country Club (FM1378)**

TxDOT will soon commence construction on Estates Parkway (FM 2170) from Angel Parkway to Country Club Road and Country Club Road from Jessica Lane to SH 5. These sister projects will add three feet of shoulder, add a new surface, replace existing driveways, extend or replace existing culverts, and add rumble strips. The project is expected to commence soon and take 7-8 months to complete.

#### **Barratt Lake Estates**

Civil construction on the Barratt Lake Estates development, located near the intersection of Winningkoff Road and a Christian Lane, is in its final stages. It is expected to be released for home construction in the coming months.

## **COMMERCIAL ACTIVITY UPDATES**

#### **Tractor Supply**

The new Tractor Supply store is expected to complete their final inspections within the next couple of weeks. Once completed, Tractor Supply can move forward with their expected opening in mid-November. The Tractor Supply store will be located at 495 South Angel Parkway.

### **Golden Chick**

Golden Chick obtained a Specific Use Permit for the creation of a drive through restaurant at the December 9, 2021 Planning and Zoning Commission meeting. Construction of Golden Chick is ongoing and will be located at 451 South Angel Parkway.

#### Lucas Ranch

Construction on the Lucas Ranch development, located at the intersection of Country Club Road and Jessica Lane has resumed following a long pause. This development will feature light retail and office uses.


# **CWD REMINDERS FOR TRASH, RECYCLING & BULK/BRUSH**

## **CITY OF LUCAS 2023 GENERAL ELECTION Candidate Filing Begins January 18, 2023**

The City of Lucas general election will be held on May 6, 2023. There will be two City Council seats on the ballot, City Council Seat 1 and City Council Seat 2. Each City Council seat serves a three year term. Applications for a place on the ballot will be available from the City Secretary's office beginning January 3, 2023. Candidates may file an application with the City Secretary beginning Wednesday, January 18, 2023, through Friday, February 17, 2023. Please note that electronic application submittals will not be accepted.

To be eligible for office, the City Charter states the following criteria must be met:

- Resident of the City for twelve (12) continuous months
- Qualified voter of the city
- Have never been convicted or not currently charged with a felony or crime involving moral turpitude
- 18 years of age
- Not delinquent on ad valorem taxes due to the City
