ADDENDUM NO. 1

11. Refer to the **Bid Documents, Section 4, Forms**. This section has changed titles.
12. Refer to the **Bid Documents, Section 4, Forms**. Several forms have been added. Certificate of/Disclosure of Interested Parties (Form 1295), Conflict of Interest Questionnaire, Affidavit of No Prohibited Interest, Contractor's Affidavit of Bills Paid, Cooperative Purchasing Form, Supplemental Information, Schedule of Subcontractors are all forms that have been added.
13. Refer to the **Bid Documents, Section 5, Public Works Contract**, Section 2.2.1. 519 LF of 4" PVC has been changed to 521.

14. Refer to the **Bid Documents, Section 5, Public Works Contract**, Table of Contents. Early Completion Bonus has been deleted from title of Section 3.4.
15. Refer to the **Bid Documents, Section 5, Public Works Contract**, Article 3, Section 4 Liquidated Damages; Early Completion Bonus. Early Completion Bonus has been deleted from title.
16. Refer to the **Bid Documents, Section 5, Public Works Contract**, Article 3, Section 4 Liquidated Damages, 3.4.1. The Contractor shall pay the City the sum of \$1000 per day for each and every calendar day of unexcused delay.
17. Refer to the **Bid Documents, Section 6, Performance Bond**. Years and City Name within contract have been updated.
18. Refer to the **Bid Documents, Section 8, Maintenance Bond**. Project Name, Years, and City Name within contract have been updated.
19. Refer to the **Bid Documents, Section 10, Measurement and Payment**. Bid Item description for Bid Item 125 has been added.

B. Plans:

1. Sheet 4 shall be reissued.

C. Questions:

1. Please clarify general note #6 on plan sheet 4: "All water fittings and valves shall be flanged."
A: Water main fittings and valves shall be flanged.
2. Are the materials (ductile iron fittings & castings) on this project required to be domestic?
A: No.
3. The following from specs are missing: Instructions to Bidders, Compliance with Federal and State Laws & Cooperative Purchasing Form.
A: See reissued bid documents.
4. 4" service line is under a house.
A: See revised reissued Sheet 4.
5. Is this project going to be "Buy American" and monitored by TxDOT?
A: No, project is not going to be Buy American. Contractor shall comply with TxDOT permit.
6. Is there going to be a line item added from traffic control? That will be a big item.
A: Yes, see new bid item 125.

The Contractor shall acknowledge receipt of this Addendum No. 1 on the face of the sealed envelope in which he submits his bid and by signing this addendum and attaching it to his bid proposal.

NOTE: The City will NOT OPEN or CONSIDER any bids that do not acknowledge receipt of this addendum on the EXTERIOR of the BID ENVELOPE.
