The city is extremely thankful for all who reside here who continue to ensure that we provide the highest quality city services making Madeira Beach a truly wonderful place to live, learn, work, and play. We are also thankful for the thousands that visit our city enjoying our vast amenities that also contribute to the eclectic nature of our City. While we continued experiencing some additional road traffic and wait times at our stores and restaurants, I am reminded we can still enjoy our slice of paradise daily walking on our pristine sand, viewing spectacular sunsets and celestial views, or simply enjoying a peaceful fishing or other water excursion. Whatever your hobby or enjoyment, please take some time to enjoy our wonderful city and the many outdoor amenities.

Unlike last year, as of this writing in early April, we still have not encountered any of the dreaded *Karenia brevis* algal blooms, the microscopic, single-celled, photosynthetic organism, a marine dinoflagellate, responsible for our 'red tides' common in our Gulf coast. Thankfully it has decided to stay away from our shorelines; hoping that trend continues.

On March 19, an election took place that only had one Charter Amendment question for Madeira Beach registered voters. We did not have an election for the Commissioners in Districts 1 and 2, as incumbents David Tagliarini (District 1) and Ray Kerr (District 2) were the only ones who qualified in each district. Subsequently, both were automatically elected and were sworn in on March 27, 2024, for another two (2) year term expiring March 2026. The charter amendment question to change the election candidate qualifying period from the first two full weeks in December to the first full week in December did not pass. The total number of votes cast: 665 total

236 votes – YES 429 votes - NO

Also please remember: No dogs on the Sand. Fines are \$250 for littering and \$93 for dog on the sand/beach:



Beach Ordinances

Sec. 42-37 - Leave no trace

- Any unattended tent or property left on the Public Beach at night shall be deemed discarded by the owners and become the property of the City of Madeira Beach and may be removed and disposed of by the appropriate authority.
- All holes on the beach are to be filled in the same day they are created.
- Camping, bonfire, grilling and glass are prohibited.

Sec. 42-38 - Enforcement

- Violation of any provision of this article shall be subject to the following penalties:
 - ⇒ First violation: \$100.00 fine.
 - \Rightarrow Second violation: \$200.00 fine.
 - ⇒ Third violation: Fine not to exceed \$500.00 pursuant to F.S. § 162.22.

Sec. 10-5 – Animals banned from Public Beaches

- It shall be unlawful for any dog, cat, other animal, whether running at large, on a leash, or being carried, to be on any public beach within the city.

Sanitation-Trash Collection

REMINDER: Trash containers need to be stored somewhere other than curbside, and wheeled out to the curb for collection no earlier than 5:30 pm the day prior to collection, and removed away from the curb by sunset the day of collection. If your container is damaged or missing please contact the City of Madeira Beach Public Works/Sanitation department at 727.543.8154. The City of Madeira Beach greatly appreciates everyone's patience and participation with our current trash collection procedures designed to keep our City even cleaner.

GUIDELINES

Regular Trash Pick Up

The City is now utilizing a side loader garbage truck which only has one person. We will only pick up items in the can, Other items outside of the can will be considered bulk waste and will be picked up on Wednesdays.

Bulk Trash Pick Up

Every Wednesday Public Works will provide Bulk Trash Pick Up. Have items out by 7am. Yard Waste pile must not exceed 4ft in height and no longer then 8ft in length. Items must be 3ft away from object like mail boxes or vehicles. Contractors paid for service must haul all debris away Questions? Call Public Works

A reminder that the City began utilizing a side-loader trash truck to automate residential curbside trash collection/pick-up. This means we will only have a driver and possibly one additional employee emptying the 64 gallon trash containers on the container collection days. Please remember that only the 64 gallon trash container will be emptied, any trash that does not fit in the container such as boxes, furniture, larger items, etc., is to be placed out for the every WEDNESDAY bulk/yard waste collection on Tuesday from 5:30 pm on. We understand this is a change, but do ask for all to follow the posted processes.

RECYCLING

Please remember the following items may be recycled:

- **PAPER** newspaper, magazines, junk mail, computer/printer paper, catalogs, brown/white/colored paper bags, paperboard cartons, wrapping paper
- **CARDBOARD** cereal boxes (without plastic liner), soda cartons (without plastic wrap), cardboard boxes (flattened, no larger than a 4' x 4' square)
- **GLASS** all clear, brown, green glass FOOD and BEVERAGE bottles (must be rinsed out with no residue and lids/caps removed

- **PLASTIC** all plastic FOOD and BEVERAGE containers that have the Recycle symbol and a number 1 or 2 (must be rinsed out with no residue and lids/caps removed
- **METAL** aluminum FOOD and BEVERAGE cans (rinsed out with no residue and lids/caps removed), tin FOOD and BEVERAGE cans (rinsed out no residue and lids/caps removed), clean aluminum foil pans, empty aerosol cans
- *ITEMS NOT RECYCLABLE*: plastic bags, egg cartons, Styrofoam, pizza boxes (normally only the top/lid may be recycled if it is super clean-no cheese/grease/toppings)

ANY & ALL TRASH – please dispose of trash in appropriate trash bags and receptacles.

<u>PARKING</u>

A few reminders regarding **resident** and **visitor** parking:

 Residents can obtain up to 3 RESIDENT PARKING PASSES at no charge, that allow residents to park in any City of Madeira Beach lot while the lot is open as well as on streets that allow resident parking. No overnight parking is allowed at any City lot using the RESIDENT PARKING PASS (everyone can use the overnight parking lot areas by paying the \$3/hour fee). Property owners are also eligible to receive parking passes with a valid driver's license and vehicle registration.

2024 Resident Parking passes are available in-person at City Hall or on-line at the City's website, <u>www.madeirabeachfl.gov</u>. Please remember your driver's license and vehicle registration must be presented and must be valid.

- 2. VISITOR PARKING is available at all City of Madeira Beach lots and the John's Pass Boardwalk & Village on-street spaces and the lot adjacent to the VFW (entrance off 129th Ave E) by paying the hourly rate of \$3 (may pay using the ParkMobile app or at a kiosk/meter located at each lot). Overnight parking is only allowed at City of Madeira Beach lots located from 130th Ave to 136th Ave (entrances off Gulf Blvd) not allowed at the John's Pass Parking lot and the Archibald Park Parking lot by paying the \$3/hr rate (available for up to 7 days).
- Please keep in mind, particularly visitors, that there are other privately-run/managed parking lots throughout our City that typically charge \$4-\$8/hour as well as the occasional \$20 - \$45 full day rate/charge. These lots are NOT owned/managed/enforced by the City of Madeira Beach.
- 4. To alleviate various residential street congestion due to construction sites, we will be issuing parking permits to construction workers, contractors/sub-contractors, and related vehicles/trucks to ensure they park correctly, mainly not blocking any streets (particularly for emergency vehicle access). Information is on our City website under Parking.

Community Development

Plan review time is running at about two to three weeks with less than 20 in the queue.

Staff continues providing open hours on Wednesdays from 1 pm to 3 pm and continued to respond to various questions/concerns.

A redevelopment application (RDV 2024-02) was removed from the April LPA agenda on the advice of the city attorney because the house was demolished prior to the application being submitted.

Staff has scheduled three public workshops for April. The will be held on 4/13, 4/18, and 4/20. We are doing something a little different this time and organizing round table discussions after the staff presentation in hopes of getting more community input. We are mailing invitations to all addresses in the city.

Staff is working with MGO to transition BTRs in the next month or so. Data has been submitted to MGO and we anticipate the launch to go smoothly. We are sending letters to property managers and property owners in the city to make them aware of the change and let them know that there will be more compliance requirements.

Our Community Development Engineer will be attending the Florida Flood Managers Association in Destin in April.
