#### **CITY MANAGER**

May arrived with warmer temperatures, additional humidity, and a few thunderstorms, a sign that summer is near as many begin to turn to the Gulf and intracoastal for refreshing swims (at least for the next few weeks) as well as enjoying pools, boating, and the many outdoor excursions available here in Madeira Beach. While Memorial Day weekend weather yielded very sunny/warm days thousands visiting our waters were reminded of the need to be safe and encouraged to utilize all available safety precautions and devices from swimming in marked areas to wearing safety devices on boats (more on boating safety below) to following all posted signs and markers both on water and land.

We continued experiencing eclectic sunrises, sunsets, and everything in between reminding us why many call Madeira Beach home and why so many visit our city every year. As in prior months thousands enjoyed our vast and varied events including our 2<sup>nd</sup> annual Founder's Day Weekend Captain's Party that culminated with wonderful fireworks our weekly Wednesday Market on Madeira Way various youth softball tournaments and a spectacular final Friday at the John's Pass bell tower area. June 1 officially marks the start of the Atlantic basin Hurricane Season – a note from our Madeira Beach Fire Department:

As we enter the Hurricane Season, Madeira Beach Fire Department would like to encourage all of our residents and businesses to have a plan in the event a storm is heading our way. You can pick up a Hurricane Guide at City Hall or the Fire Station that will be able to assist you with shelter information, pet shelters, preparation of supplies and important numbers and resources for before and after the storm.

Some important reminders include:

- Keep a hurricane kit stocked with food, water, meds, flashlights, battery-powered radio, etc
- Make an evacuation plan for your family (remember to include your pets)
- Gas up vehicles
- Physically prepare/protect your home clear yard of furniture, debris, and potential projectiles
- Board up windows, put up shutters
- Be ready to turn off power in case of flooding
- Place important documents and valuables in watertight containers
- Keep calm & stay alert

## Ready Pinellas Emergency Planning Mobile App

# Introducing the new and improved Ready Pinellas mobile app!

**Ready Pinellas** is designed to help residents prepare themselves and their families before, during and after a storm. It is available for free download on the Apple <u>App Store</u> and <u>Google Play</u> store.

Note: Android device users who already had the previous Ready Pinellas app installed will need to download the new app from the Google Play store and remove the old app from their devices. Apple device (iPhone and iPad) users will see the app automatically updated.

The new app features a refreshed design and user experience, additional information and tips, and convenient checklists to make sure you and your family are prepared. App users can use emergency supply checklist, home inventory and emergency contacts tools to build a personal emergency plan.

As a storm approaches, the app will provide real-time updates to help keep you safe, including detailed information that is available at your fingertips even if you lose internet connectivity. It will provide resources to contact us year-round and during a disaster and give you tips to Stay Informed.



## **Ready Pinellas App Features**

- Know Your Zone: If you have your locator services on, the app will tell you if you are in a designated evacuation zone. You can also look up other addresses to see if they are in an evacuation zone. Remember: Evacuation zones were updated for the 2022 hurricane season, so you may have a new zone. When a storm is approaching, it will tell you if Pinellas County is in the 5-day or 3-day cone and if an evacuation order has been issued.
- **Make a Plan**: Use our emergency supply checklist, home inventory and emergency contacts tools to build a personal emergency plan that you can share. You can take pictures of items for your home inventory.
- Push Notifications: Through the app, you will receive informational and emergency notifications from Pinellas County Emergency Management, the National Weather Service and <u>Alert Pinellas</u>.
- <u>Special Needs</u>: You can learn more about special needs assistance, which is intended for those who need transportation or require minimal medical assistance while seeking public shelter. You can register from the app.
- **<u>Preparedness Tips</u>**: Learn how to prepare your family, pets, home, condo, mobile home, boat and more.
- Safety Tips: Find information on What to Do Now before, during, and after an event. Learn about year-round preparedness, how to clean up after a flood or food safety if power has been out.
- Report Damages after a storm has hit Pinellas County.

\*Under disaster conditions and the following recovery operations, access to Madeira Beach will be restricted to persons with identification showing they are a resident or property owner. <u>Emergency access permits are available to Madeira Beach Residents and</u> <u>Business Owners.</u>

\*Receive alerts about emergencies and other important community news by <u>signing up</u> for Alert Pinellas.

## What to do before a storm

There are many ways you can prepare your home and family prior to a storm.



- Sign up for alerts on storm tracking
- Prepare your home
  - o Clear your yard of furniture and potential projectiles
  - Board up windows or put up shutters
  - Be ready to turn off power in case of a flood
  - Fill containers with clean water for drinking
  - o Place important documents or valuables in watertight containers
  - Gas up vehicles and be ready if you need to evacuate
  - Identify a safe spot for potential tornado activity
    - o inside room without windows on the lowest floor (bathroom, closet, center hallway)
- Build/replenish your kit
- Make an evacuation plan
  - Make sure to include pets in your plan!
  - Prepare to execute your evacuation plan if needed, during the storm emergency personnel may not be able to help!

## What to do during a storm

Make sure you know what to do during a storm to stay safe.



- Stay indoors
- Stay tuned to the news or other alert outlets on storm tracking
  - Be prepared for tornadoes during a hurricane
- Turn off power if flood waters rise
- Do not drive or swim through flooded waters. Turn around don't drown!
- If needed call 911 for help
  - Keep in mind that depending on the storm and flood waters emergency personnel may suspend emergency operations until it is safe.
- Keep calm and wait for the storm to pass!

## What to do after a storm


Make sure you know what to do after a storm to stay safe.



- Listen to local officials for information
  - o If you evacuated make sure it is safe to come back from local officials
- When assessing damage be carful of down powerlines
- If there is still flooding turn around
- Do not touch electrical equipment if still wet
- Reporting Damage: it is important to do the following before clean up
  - $_{\circ}$   $\,$  Take pictures of water lines on the house
  - o Take pictures of any damage, more pictures the better
  - o Document estimated cost of damage

- Send information to Pinellas County (the Madeira Beach Community Development team can also help get information to the County)
- Contact your insurance company for further information on your policy and what information they need
- Debris Clean Up
  - Public Works will work hard to collect debris on the curb
    - Debris pick up will start with major roads and continue into neighborhoods
    - Garbage pick up might not be on a regular schedule as the dumping of debris takes a bit longer post storm
  - Dispose of sandbags properly
- Properly apply for permits for restoration (contact the <u>Building</u> or <u>Community</u> <u>Development</u> Departments for specific information)
  - FEMA 50% rule must be followed when repairing/restoring homes





#### SALES TAX HOLIDAY – DISASTER PREPAREDNESS SUPPLIES/ITEMS

Additionally, the FL legislature and governor approved a sales tax holiday on various hurricane/storm season preparation items and supplies that runs through June 8, 2024. Many items are included in the no sales tax period including:

- Portable generators costing \$750 or less
- Two-way radios, tarps, tie-down kits costing \$50 or less
- Batteries, coolers, ice-chests costing \$30 or less
- Gas or diesel fuel containers costing \$25 or less
- Battery-powered flashlights, candles, tiki-type torches \$20 or less

#### 2014 Hurricane Preparedness Sales Tax Holiday May 31 through June 8, 2014

The holiday begins at 12:01 a.m. on Saturday, May 31, 2014, and ends at 11:59 p.m. on Sunday, June 8, 2014. During this holiday period, qualifying items related to hurricane preparedness are exempt from sales tax. This holiday does **not** apply to sales in a theme park, entertainment complex, public lodging establishment, or airport, or to the rental or repair of any of these items.

The purpose of the proclamation continued to be to bring attention to important and useful life-saving tips for recreational boaters to enjoy safer and more fun experiences out on the various waterways. Thank you to the US Coast Guard Auxiliary for their continued support of National Safe Boating Week.



PROCLAMATION National Safe Boating Week May 18 – May 24, 2024

For nearly 90 million Americans, boating continues to be a popular recreational activity. From coast to coast, and everywhere in between, people are taking to the water and enjoying time together boating, sailing, paddling, and fishing. During National Safe Boating Week, we want to bring special attention to this pastime and remind recreational boaters of a few tips to ensure that they and their loved ones are safe and responsible while exploring our nation's waterways.

Proper planning for a day of boating begins even before leaving home and getting a free vessel safety check, taking a safe boating course at the beginning of the boating season, filing a float plan with a trusted family member or friend, and checking the weather before boating are key steps to enjoy boating. Everyone should always wear a U.S. Coast Guard-approved life jacket while boating. Drowning remains the number one cause of death for recreational boaters each year, and most drowning victims in recreational boating accidents are not wearing a life jacket. Safe and responsible boating includes never operating a boat while under the influence of drugs or alcohol and knowing basic navigation rules.

National Safe Boating Week is observed to bring attention to important life-saving tips for recreational boaters to have a safer, more fun experience out on the water.

Whereas, on average, 700 people die each year in boating-related accidents in the U.S.; approximately three-fourths of these are fatalities caused by drowning. The vast majority of these accidents are caused by human error or poor judgment and not by the boat, equipment, or environmental factors; and

Whereas, a significant number of boaters who lose their lives by drowning would be alive today had they worn their life jacket; and

Whereas, to combat these statistics, the National Safe Boating Council, in partnership with the U.S. Coast Guard and the National Association of State Boating Law Administrators, will launch the annual North American Safe Boating Campaign during National Safe Boating Week. The Campaign is designed to reach more than 70 million boaters around North America and communicates this year's life-saving message: Boat Smart. Boat Safe. Wear It: and The May 8, 2024, Commission Meeting also recognized **National Public Works Week** May 19 - 25, 2024, with the following proclamation recognizing the vast and varied contributions and daily work of our fabulous Public Works employees that regularly help to make our City shine and smile.

The next Fiscal Year (FY) 24 Budget Workshop will take place on Wednesday, June 26, beginning at 4 pm (at City Commission Chambers, 300 Municipal Dr) to discuss department personnel and operating expenditures, the City's tax (millage) rate, and various non-departmental expenditures including contributions to other agencies (Chambers of Commerce, Coast Guard Auxiliary, etc). A reminder that the City's fiscal year runs from October 1 to September 30 – so our fiscal year 2024,



#### **Community Development Department**

Number of permit applications have increased in number with an approximate 2 week timeline for review.

Traffic continues to be steady for open hours on Wednesdays.

The feedback that we received in our April Public Workshops for John's Pass Village Zoning has been compiled and presented to the Planning Commission.

Staff presented potential fence code amendments to the commission and received feedback and comments. The feedback was incorporated into a proposed ordinance change to be presented at the next LPA meeting to be sent to the BOC if approved.

Commissioners requested walking tours if the proposed Character Districts in order to have a better understanding of information presented at the April Workshops. Three of them have been conducted. They went well and some of the information gathered was very valuable.

Staff has been working with Kimly-Horn to create a public workshop for the new Master Plan. The goal is to gain information that the community has for the future of the city. We scheduled the first Worskhop for Thursday, June 27, 2024, at City Hall beginning at 6 pm.



#### **PUBLIC WORKS DEPARTMENT - Project Updates**

#### Patriot Park Dock Replacement

Project consist of the removal of both the East and West docks and replace with new in. The new docks are in the same footprint as the old but will consist of composite decking and aluminum handrails that will have drops for fishing.

- BOC Approved \$156,465.00 (Base contract price \$119,715.00 with possible unknown cost of \$750 per piling 48 total if drilling was needed) to Speeler Foundations on January 10, 2024
- Handrails have been provided from Gator Dock & Gator Bridge separately for the amount of \$20,257.94 to save cost on tax.
- A few handrails have been sent back to Gator due to being fabricated incorrectly staff anticipates project completion by July 2024.



The project will consist of 22 of the 37 existing beach groins to be fortified with vinyl sheets (seawall sheets) set on each side and through bolted to the beach groin and poured with concrete. Speeler Foundations was awarded the contract by the BOC at the April 10, 2024 BOC regular meeting for a total of \$3,838,677.99. The City has received a grant from FDEP for \$1,750,000. The contractor will work on the water or land side at a time leaving a pedestrian walk path open at all times. If anyone would like to see the permits or plans please visit <u>- DemandStar</u>

- Project Start May 6, 2024
- Anticipated completion date February 2025

• Current Beach Groin upland (approximately 60-100 feet) completed on 7 from 155<sup>th</sup> to Pinellas County Park skipping Archibald, Ocean Sands and Arie Dam (turtle nest)

• Sea Turtle Conditions

- No work is to start until Clearwater Marine Aquarium has cleared the beach each morning.
- No equipment is to be left on the beach over night
- All holes due to construction are to be filled each night
- If a turtle nest construction must stay 20 feet away at all times

#### <u>Area 3 – E Parsley, W Parsley, Marguerite, A Street, B Street, and Lynn Way. Roadway and</u> <u>Drainage improvement Project.</u>

The project will consist of removing and replacing all stormwater infrastructure, replacement of the concrete curbs, and Mill and Resurface the roadway. The BOC approved the Scope of work for Deuel & Association now known as Transystems to start the engineering on February 24, 2022, for the amount of \$165,000.00. A grant has been received from FDOT for \$549,400 for the construction portion of the project.

- Working on Temporary Construction Easements for the removal and replacement of all stormwater pipes.
- Permits received from SWFWMD March 2024
- Working on Putting the RFP together and plan to place out to bid in by June 2024

#### Area 5-131st Ave E and 129th Ave Roadway and Drainage improvement project.

The project will consist of removing and replacing all stormwater infrastructure, replacement of the concrete curbs, and Mill and Resurface the roadway. The BOC approved the Scope of work for Transystems to start the engineering on April 12, 2023, for \$52,000.00.

• Project is still in design at 90% plans and waiting on review and comments from Pinellas County for their utility replacement.

#### Gulf Lane and Beach Access roadway and drainage improvements

The project consists of Gulf Lane, Johns Pass Park, and the Public Beach Accesses from 130<sup>th</sup> North to 135<sup>th</sup> to be milled and resurfaced. The portion of the road from 130<sup>th</sup> parking lot north to 131<sup>st</sup> has pervious concrete along with a small section from 133<sup>rd</sup> South to the Bare Foot Entrance due to elevation and the remainder of the project is asphalt. The project was awarded to Keystone Excavators by the BOC on June 14, 2023, for a total cost of \$2,188,903.50.

• Completed May 2024

#### **Gulf Blvd Utility Undergrounding**

This Project will consist of the Final Phase of Gulf Blvd undergrounding from 144<sup>th</sup> Ave South to Johns Pass. Once permits and all signed easement documents are received the contractor will start a boring conduit along Gulf Blvd. There will be temporary land closures depending on the location and MOT will be set up. This project is funded by the Penny for Pinellas <u>https://www.pennyforpinellas.org/</u>

- Anticipated to start construction June 2024- FDOT Permit received May 2024
- Paid Duke Energy BCE June 2023 for \$2,574,433.93 Approved by the BOC at a special meeting on February 13, 2023.
- The Engineering Firm for this Project who is responsible for the oversight of the boring contractor is Utility Consultants of Florida.
  - Phase 1 proposal for the Design, planning, pre construction phase was approved by the BOC on 2-9-22 for \$99,670.00.
  - Phase 2 Proposal for the Construction phase Approved by the BOC 9-14-22 for \$2,348,589.31.

#### Area 6A Roadway and Drainage Improvement project

The project will consist of removing and replacing all stormwater infrastructure, replacement of the concrete curbs, and Mill and Resurface the roadway. The BOC approved the Scope of work for Transystems to start the engineering on April 12, 2023, for \$141,500.00. A grant has been received from FDOT for \$1M for the construction and construction engineering phase of this project.

• Engineering has begun, and estimated construction will start August 2024.

#### Archibald Park Restroom Project

Robin Gomez approved Engineering and Architecture services with Transystems for \$29,750.00 on 2-22-23. The project will consist of the demolition of the current restroom facility and the construction of new. The new restroom facility will have 4 fixtures in each, 1 of which will be an ADA stall. The new facility will have a water closet to keep all plumbing secured from any vandalism and an oversized janitorial room with a roll up garage door for equipment storage. The current facility has severe concrete spalling both underneath and inside, is not ADA complaint, and the water and sewer capacity isn't large enough for the volume.

- Plans have been completed and reviewed by all departments
- Placing out to bid June 2024
- Plan to be under construction October 2024

#### Beach Swim Area (Designated Swim Area on the Gulf) Permitted through FWC

Public Meetings Scheduled for June 18th at 6PM and June 29th at 11AM located at City Hall

The project consisted of replacing the floating Buoys with set pilings. The buoys are not permanently fixed and break loose during storm events or high surfs. The invention of this project was for safety to ensure the motorized vessels stay out of the designated swim areas and that they are more permanently in place.

- Project started and then removed Each piling will have a 3'X 3' Sign
