ORDINANCE 2018-13

AN ORDINANCE OF THE BOARD OF COMMISSIONERS FOR THE CITY OF MADEIRA BEACH, PINELLAS COUNTY, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR 2018 (BEGINNING OCTOBER 1, 2017 THROUGH SEPTEMBER 30, 2018) BY INCREASING THE GENERAL FUND AND DEBT SERVICE FUND APPROPRIATIONS AND EXPENDITURES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Madeira Beach Board of Commissioners adopted Ordinance 2017-11 on September 19, 2017, approving the Fiscal Year 2018 Budget; and adopted Ordinance 2018-01, amending the Fiscal Year 2018 Budget; and

WHEREAS, Florida Statutes 166.241 authorizes the governing body of a municipality to adopt a final amendment to the Budget within 60 days following the end of the Fiscal Year; and

WHEREAS, the City of Madeira Beach Board of Commissioners desires to adopt a final amendment to the annual Fiscal Year 2018 Budget; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF MADEIRA BEACH, FLORIDA, AS FOLLOWS:

- **SECTION 1.** The Board of Commissioners authorizes the Budget for Fiscal Year 2018 to hereby be amended to reflect an increase in the General Fund Appropriations and Expenditures (See Exhibit A).
- SECTION 2. The Board of Commissioners authorizes the Budget for Fiscal Year 2018 to hereby be amended to reflect an increase in the Debt Service Fund Appropriations and Expenditures (See Exhibit A).
- **SECTION 3.** The Board of Commissioners authorizes Director of Finance/City Treasurer to allocate the budget amendment pursuant to the account level detailed provided as Exhibit A.

SECTION 4. Ordinance 2018-13 shall become effective immediately upon final adoption by the Board of Commissioners.
