### **BUILDING OFFICIAL(S)- DEVELOPMENT REPORT- (January 2022)**

City Building Official, Frank DeSantis reports that our redevelopment/economic development continues at a fast pace including several large condominium projects on-going and/or under plan review.

- The Harbor at Town Center Condominiums project 212 150<sup>TH</sup> Ave
  - √ 1) Window/sliders @100%
  - ✓ 2) Storefronts will be complete the 2nd. Week of February
  - √ 3) M.E.P roughs for the 4th and 5th floor should be ready for inspection the week of February 7th
  - √ 4) Drywall is complete on the 2nd floor and 85% on the 3rd
  - √ 5) The county has not yet finalized the fire or potable water location and fees
  - √ 6) The pool sub is set to start February 4th
  - √ 7) Duke has provided us with the transformer location and the fees are paid
  - √ 8) Stucco is complete and exterior paint work has started
  - √ 9) Interior paint work will start on the 2nd and 3rd floors February 2
  - √ 10) Permanent hand railings will start on February 7
  - ✓ The project is at 75% completion.



#### FIRE DEPARTMENT- FIREFIGHTER OF THE YEAR 2021

With the start of the new year, 2022, Madeira Beach Fire Department will implement a Community Risk Reduction (CRR) Program. As defined in NFPA 1300, Standard on Community Risk Assessment and Community Risk Reduction Plan Development is a process to identify and prioritize local risks, followed by the integrated and strategic investment of resources to reduce their occurrence and impact. This program will allow MBFD to share vital information and provide life/property saving services through education, inspections and various services adopted into the program.

The proposed Community Risk Reduction Program for Madeira Beach consists of the following:

- Smoke Detectors American Red Cross donated; the fire department will be installing them
  in homes that need detectors. No more than 3 per home per ARC. The MBFD firefighters,
  the fire inspector or Fire Chief will provide the installation free of charge to the resident.
- Pre/post Hurricane Salvation Army, brochures, hygiene kits. It will be included in the City's Hurricane Summit.
- Water Safety life vests and brochures. Emphasize pool safety and the importance of supervision, educate on dangers of rip currents and how to swim out safely.
- Fall Prevention Brochures and safety house check by Fire Inspector. Residential fire
  inspection at no cost to the resident to locate and educate on the potential hazards on the
  property. This is not an inspection to fine the resident. With our elderly community, falls
  are one of the most common calls for service the department receives. Conducting such
  inspection may assist in preventing a fall from occurring either by tidying up the house and/or
  providing tips on how to avoid a fall.

January did not present boaters with optimal boating weather however there were a few gorgeous days mixed in. The Marina saw an increase of "Loopers" (boater's traveling the Great Loop through the United States) this year compared to 2019 and 2020. Also, many customers we have not seen in years have come back down from up north to escape the cold and enjoy or beautiful climate. We are all glad to see our neighbors from the north back down as this should increase business and work us all back to our normal routines. The Marina and City of Madeira Beach will be hosting their 11<sup>th</sup> Annual Great American Grunt Hunt fishing tournament, community fish fry and weigh-in on March 12<sup>th</sup>, starting at 4:00pm. Fishing will start the morning of March 12<sup>th</sup> at 6:00 am. There will be a captain's party held March 10<sup>th</sup> starting at 7:00pm. The captains meeting will offer food, raffle, 50-50, registration, and of course cocktails. Sponsorship opportunities are still available for this event. All donations are greatly appreciated.

Fishing has been a little tough this month mainly due to the weather and falling water temperatures. On calmer days anglers fishing in 80-100 feet of water have had a good mixed bag of red grouper, grunts, porgies, and lane snapper. Shrimp and squid are the most popular baits. Use small pieces of bait on a 3/0 circle hook fished on the bottom to get the smaller fish active. This will get the interest of the larger red grouper. Drop down a large piece of sardine or squid with a 6/0 circle hook attached to 60lb leader and patiently wait for a solid bite. Smaller fish will start pecking away at the bait but resist the urge to set



the hook. When you feel a solid thump start reeling fast and don't stop until you are sure the fish is clear of the bottom.



#### **NPDES NEWS**

Everyone living on the Pinellas County barrier islands lives in small, isolated watersheds.

What is a watershed you ask? A watershed is an area of land that drains to water. A watershed carries water "shed" from the land after rainfall. Drop by drop, water is channeled into soils, creeks, and streams, making its way to Boca Ciega Bay.

Water flowing over almost every bit of land on the barrier islands drains to the Bay. EVERYTHING you do on land has an impact on our water quality! Common items become pollution in our Bay, including:

Trash Yard Debris
Grass Clippings Pet Waste
Fertilizer Pesticides
Herbicides

Did you know that commercial landscapers are required to take a class with Pinellas County to become certified to operate anywhere within the County? A commercial landscaper must always have the following certification decal on their vehicle.
