Responsible for personnel, budget, policies, procedures, procurement, training, correspondence, certifications, and other related necessary functions for the continued operation of the Department.

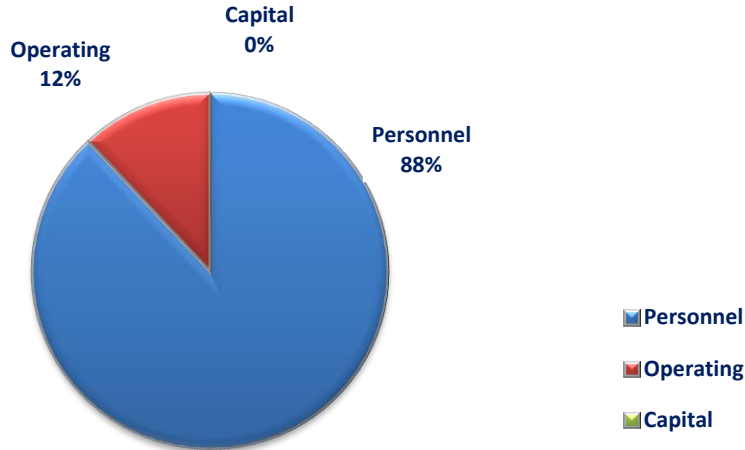

TRAINING

The Madeira Beach Fire Department, in its efforts to provide above standard service to the public, has taken part in the following educational opportunities:

- ✓ Personal Watercraft training (PWC)
- ✓ Continued training with “Rapid Dive” gear for underwater extrications.
- ✓ Annual training refresher on all water rescue apparatus and resources.
- ✓ Lt. Childers and Lt. McClave continued to take lead roles as mid-County CFE Instructors. Lt. McClave assigned as Training Officer.
- ✓ Lt. Hill continues as EMS Officer, coordinating Department’s EMS training, Capstone through Medical Director’s Office for new hire paramedics.
- ✓ W.E.T pack training at the Elks Lodge pool. All three shifts participated in a WET training at Maximo Boat Ramp with St. Petersburg, St. Pete Beach and Lealman Fire.
- ✓ Light Marine 25 annual training completed.
- ✓ MBFD coordinated training on an acquired vessel at Madeira Beach Marina including several surrounding fire departments. Training included below deck and swim platform rescues.
- ✓ Pinellas County CME; learned how to effectively respond to and mitigate the COVID-19 pandemic, as well as ground medical responses.
- ✓ Simulated fire attack evolutions and forcible entry at an acquired structure in St. Pete Beach prior to demolition.
- ✓ Training at an acquired structure at St. Pete Beach; vertical vent, overhaul, and VES (search).
- ✓ Training at an acquired structure in Seminole; vertical ventilation, primary search, VES, firefighter survival and firefighter onto roof training.
- ✓ All members completed the Fitness PAT (Job simulation Assessment) as well as the Cooper Standard (push up, sit up, and run).
- ✓ Breath down drill at SPC Fire Training College.
- ✓ Hazmat Recognition and hazmat training with H29.

PUBLIC EDUCATION/RELATIONS

The Department strives to educate all residents, visitors and school children in every facet of public safety. Due to COVID 19 some educational opportunities were canceled or adjusted to virtual events. The department turned to social media to emphasize fire prevention for public education. - ✓ CPR classes to residents were suspended due to pandemic. Instructor Perez completed CPR training to all Recreation staff.
- ✓ Blood pressure checks at the station for all walk-ins were made available.
- ✓ Home fire inspections/assistance with smoke detector installation and battery check/change out.
- ✓ 2021 Madeira Beach Hurricane Preparedness Expo, Pinellas County virtual expo hosted at Madeira Beach Commission Chambers.
- ✓ Visited Madeira Beach Fundamental School for a social distanced Fire Prevention Week presentation. The department participated in a County-wide informational video on fire safety. The video was presented to all the Pinellas County Schools.
- ✓ Our “School is Back in Session” campaign was conducted during the first three days of school. The 3-day public safety reach-out program reminds drivers to slow down and drive with caution in school zones.

- ✓ Movie and Trunk O' Treat at Church by the Sea with social distancing for all participants.
- ✓ Organized Legends Never Die 5K Run at Archibald Beach. Close to 100 participants attended to support the fundraiser in honor of Emilio Rivera. FF Rivera of Marion County committed suicide in 2019. A foundation was set up in his honor to assist first responders with mental health as well as a scholarship for future firefighters.
- ✓ EMS by Special Rescue 25 present at King of the Beach Tournament
- ✓ Safety assistance during the Veteran's Boat Parade by Light Marine 25 with Lt. McClave and FF Wasilewski as riders.
- ✓ A-shift assisted with delivery of new marine vessel – Zodiac Defender Marine 25 – delivery and set up.
- ✓ FF Sleppy was assigned responsibilities of training rescue crews in operation of recently acquired Zodiac Defender Pro - Marine 25 unit.
- ✓ Breakfast with Bob was hosted in the bays of the Fire Station.
- ✓ Mike Alstott and family visited the station and on behalf of his Foundation dropped off a Thanksgiving dinner for the shift on duty during the holiday.
- ✓ The Department participated in Santa delivery and tree lighting event at John's Pass. Truck 25 also delivered Santa to the American Legion, The Elks Lodge and Town of Redington Beach for the annual holiday events.
- ✓ Coordination of purchase and installation of electronics and equipment for Marine 25.

SIGNIFICANT RESPONSES

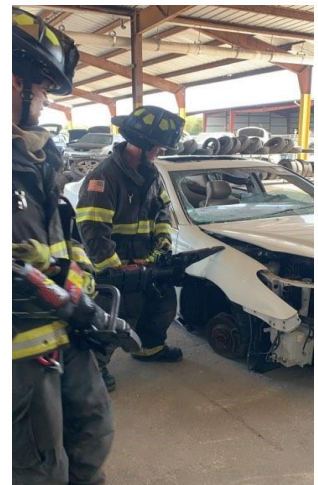
Structure Fires/Property Fires

- T25 dispatched to structure fire, reports of construction activity caught wall on fire. T25 found small smoldering fire in a 3-story wood frame residential home in the wall between the second and third floor. Fire very difficult to access, extensive salvage and overhaul completed to finally extinguish small smoldering fire.
- Vehicle Fire; a fully loaded garbage truck with fire in its trash compartment pulled up on the apron of Station 25 with PCSO escort. E25 was pulled out of the station and positioned between the garbage truck and the hydrant at the end of the apron. Water supply established, ground ladder extended to the top of the garbage truck. Moderate to heavy conditions were found in the fully loaded trash compartment. The fire was extinguished using copious amounts of water and class B foam. The garbage truck was taken by the company to the nearest “hot-dump” pad.
- Fatal Structure Fire; T25 dispatched on the first alarm for structure fire with reported entrapment. T25 arrived first on scene, to find light smoke showing from a small duplex with one occupant standing outside. L25 made contact with the occupant and quickly confirmed that one victim was still inside the structure. T25 entered the structure and located one victim inside unconscious, the victim was removed, assessed as cardiac arrest and CPR was initiated immediately. Patient care turned over to E24. T25 crews returned to the fire, quickly locating and extinguishing the fire which mostly contained to the mattress on which the victim was located.
- Structure Fire; T25 handled water supply and fire attack with second attack line. Seminole and Lealman units also on scene. 2 mobile homes, 1 travel trailer and 2 cars were destroyed.
- Truck Fire; Upon arrival T25 found a pickup truck smoldering, owner put out majority of fire with garden hose. T25 pulled pre-connect and complete extinguishment. Cab of truck destroyed, truck is a total loss, no injuries.
- Structure Fire; T25 handled water supply and fire attack with second attack line. Seminole and Lealman units also on scene. 2 mobile homes, 1 travel trailer and 2 cars were destroyed.
- Structure Fire; upon arrival crews found light smoke from rear of structure. The fire was in a wall. T25 extinguished fire and overhauled wall, while other units assisted to complete search and ventilation of structure. MB400 responded and completed investigation. Significant property damage, no injuries.
- T25 was dispatched for an outside fire. Upon arrival, crews found one telephone pole with moderate fire involvement and active arcing from an underground transformer next to the pole and high voltage lines at the top of the pole. Duke Energy was requested. An exposure/protection line was stretched and charged, both houses on either side of the pole were evacuated. A safe perimeter of approximately 100’ was established for approximately one hour before Duke Energy arrived on scene. Once overhaul was complete T25 overturned scene over to the electrical company.



Motor Vehicle Collision (MVC)

- T25 responded to MVC (vehicle vs bicyclist), T25 found one male on sidewalk with obvious lower leg injury. Patient was declared a trauma alert; 2 MBFD medics rode-in to Bayfront.
- T25 leaving the hospital after cardiac arrest, T20 and R20 working a MVC near hospital and called for extrication upgrade. T25 responded to serious crash (vehicle vs vehicle vs construction equipment) with 3 injured victims, one being trauma alert. T25 stabilized the vehicle and was preparing to relocate metal when crew was able to remove victim on passenger side. T25 crew stood by to assist and was released by command.
- T25 was dispatched to motor vehicle accident which was upgraded to an extrication/hazmat emergency incident. Upon arrival crews found a pick-up truck that had gone through the front wall of a single story concrete block house. The small pick up had the driver trapped and had multiple types of pool chemicals reacting with each other in the back of the cab of the truck. Crew pulled a protection/decon hose-line and made entry into the house. Heavy structural damage was encountered in the house upon entry. Lieutenant 25 made contact with the driver, who had an altered level of consciousness and numerous lacerations from the crash. Lieutenant was able to extricate the driver through the driver side window as the crew assisted him out of the structure and brought him to Squad 26 for medical attention. Patient was transported to Bayfront Trauma Center. T25 along with other units were able to secure the building and power and begin to identify and isolate chemicals involved.
- Trauma Alert MVC; upon arrival T25 found one patient sitting on the ground, he had been ejected from his scooter after being hit by a car. Assessment revealed multiple lacerations and a fractured foot. A trauma alert was declared and treatment initiated immediately. Patient was transported to Bayfront.
- Reports of a vehicle driving erratically and hitting a fence. Upon arrival bystanders and PCSO had both patients out of a vehicle. PCSO gave both patients Narcan as both were apparent overdose. T29 and E29 handled the care of the passenger who had a pulse and was breathing. T25's patient was in cardiac arrest; crews were able to revive the patient once on scene but patient coded again. Patient transported to St. Pete General with 3 MBFD riders. Care was transferred to ER staff who continued to work the cardiac arrest. Efforts were seized and patient declared deceased.
- MVC; upon arrival crews found a motorcycle vs. vehicle crash with one rider down in the roadway. Patient was awake and breathing with a head injury. Trauma alert was designated, patient was transported to Bayfront with FD rider.
- Trauma Alert after patient was found ground prone and unresponsive after a crash from an electric scooter. T25 quickly evaluated the patient and declared a trauma alert due to the mechanism of injury and significant injuries noted. Patient transported to Bayfront with 2 FD medic riders.



Water Rescue

- LM25 dispatched with SR25. E24 on scene and assumed command on Treasure Island side. When units arrived the victim was found floating allowing the current to guide him. SR25 was at South Beach and pushed victim towards rocks, a Good Samaritan was in the water and grabbed the victim. SR25 and the good Samaritan assisted victim up the rocks. ALS unit evaluated the patient. After investigation it was determined that the patient was swept out into the Pass by the naturally strong current in the John's Pass. Patient states he is not a strong swimmer and decided to float on his back waiting for help.
- Late night dispatch unable to utilize LM25 due to protocols. Upon arrival T25 was able to access the rear of school where D29 was located. A male and child were swimming back to shore relating another adult (father of child) was still out in the water after a small vessel capsized. Body of victim was found in early morning hours by PCSO marine unit & dive team.
- John's Pass Bridge - T25 was dispatched with multiple units. Upon arrival crews found 4 swimmers out past swim buoys and getting tired. T25 deployed rescue swimmer and rescue board. Rescue swimmer made contact with the 4; PCSO marine unit showed up and loaded all including the rescue swimmer on the boat bringing them to shore. E25 completed medical evaluations, no injuries were noted. Before leaving the scene, a person on the beach needed medical attention and was treated by T25, R24 and SS for a seizure. Patient was transported to St. Pete General.
- T25 & LM25 responded for a water rescue. Upon arrival, LM and the other marine units found a jet ski with heavy damage and 2 patients that had been removed from the water and put onto a boat by bystanders. Both patients were taken to a nearby dock and assessed. Evaluation revealed a trauma alert in one and the other met trauma transport criteria. Trauma alert patient was immediately immobilized and packaged for transport. Crew of T25 accompanied Sunstar throughout transport to Bayfront.
- T25 was dispatched to water rescue. LM25 was placed on the call due to notes and T25 was placed delayed. Upon arrival found a 74 year old female in a small sailboat in critical condition. LM25 quickly grabbed PPE supplies and went to evaluate the patient further. It was determined that the patient went into cardiac arrest. Crews called for more supplies and manpower due to the location of patient. Patient was packaged and further treated after being rescued from the boat by Marine 31 and Engine 29. Patient was transported to St. Pete General via Sunstar.



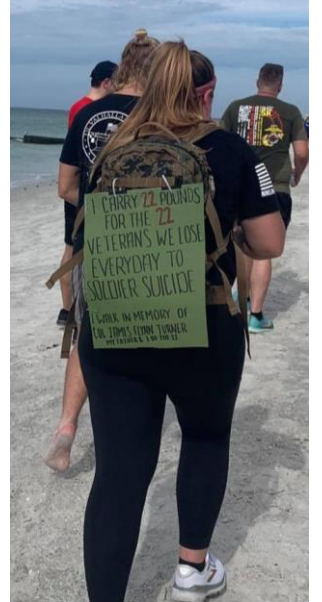
Other

- Possible overdose. Patient was found unresponsive in restroom of a 7-11. PCSO on scene and administered Narcan to pt. T25 found the male in respiratory arrest with possible heroin overdose. Patient was treated with ALS care and additional Narcan with successful reversal of overdose. Patient was transported to St. Pete General.
- T25 responded to reports of a person that fell off a bike in roadway and was unresponsive. T25 found a male on sidewalk being attended to by friends. The patient was found with a head wound and became combative. Patient was declared trauma alert and transported to Bayfront Medical Center.
- Unconscious Person; T25 was dispatched for an unconscious person. Upon arrival T25 found the patient unconscious and on the verge of respiratory arrest. T25 initiated ALS care immediately and maintained it throughout transport to Northside Hospital.
- SEPSIS Alert; T25 dispatched to pandemic. Upon arrival T25 found a 63 year old female with a cc pandemic/clue like symptoms. Pt. was quickly evaluated and found to be septic. Pt. was quickly treated, packaged and brought to Palms of Pasadena.
- T25 dispatched for a person down on the sidewalk. T25 found unresponsive male on sidewalk with no obvious signs of trauma, possible OD or alcohol toxicity. Patient transported ALS to Palms of Pasadena Hospital with 1 MBSFD medic. Patient remained with no response from Narcan. PPH reported Blood alcohol level extremely high.
- Psychiatric; upon arrival T25 found TIPD with an overdosed patient going into cardiac arrest. TIPD stated it knows that the patient took oxycodone but no other information. T25 treated patient, got ROSC and transported to Palms of Pasadena with 2 FD riders. Patient transferred to hospital staff in critical condition.
- Overdose; patient found unresponsive. Sunstar started CPR and once found out that it was potential overdose gave Narcan. Patient brought back to stable condition and treated enroute to Palms of Pasadena with 2 FD riders.
- Cardiac Arrest; upon arrival T25 found patient pulseless and apneic with family performing CPR. T25 initiated treatment immediately and obtained ROSC. Patient transported to Northside with FD assistance, upon arrival patient breathing on his own.
- Fall; upon arrival E25 found patient unable to get off floor and the door was locked. Crew exhausted all efforts for non-destructive entry and patient gave verbal permission to force entry. PCSO was notified, force entry was made. Patient was evaluated and transported non-emergency to Palms of Pasadena.
- Pediatric Trauma; upon arrival T25 found 6-yr old boy on the ground after being run over by a bicyclist who fled the scene. Assessment revealed compound fracture and associated lacerations with patient's lower left leg. A trauma alert was declared, and treatment initiated immediately. Patient was transported to All Children's with FD riders.
- Trauma Alert; Upon arrival T25 found patient prone on waters edge with facial trauma and altered mentation. T25 declared Trauma Alert and transported emergency to Bayfront with 2 FD riders.
- Overdose; upon arrival crews found patient to be in critical condition breathing approximately 3 times a minute. E25 found out it was an opioid overdose and gave Narcan to counteract the opioid. Patient was brought back to stable condition. E25 turned over patient care to Sunstar.
- Trauma Alert; T25 was dispatched for traumatic injuries. Upon arrival T25 located 2 patients, a father and young child who had been involved in jet ski accident. T25 requested additional units and the initial assessment revealed both patients to be trauma alerts, with the father being more critical than the child. T25 immobilized and packaged the father for transport while R24 cared for the child. Crew of T25 accompanied Sunstar through transport to Bayfront. R24 accompanied Sunstar to All Childrens.

- Signal 7; E25 was dispatched for a gunshot wound. E25 arrived on scene, once scene cleared by PCSO, E25 entered and found adult male with a shotgun wound to his chest. A Signal 7 was quickly declared and scene turned over to PCSO.
- Trauma Alert; T25 was dispatched for an unconscious person. Upon arrival the patient was found on the dock at a jet ski rental business with an alerted mental status. Assessment revealed that the patient had been thrown from a jet ski and hit their head. A trauma alert was declared, patient was immediately immobilized and packaged for transport to Bayfront Trauma Center.
- Overdose; T25 was dispatched for a person down. Upon arrival, T25 found one person unconscious on the beach. Assessment revealed the person to be suffering from an apparent opioid overdose. Treatment was initiated immediately and crew of T25 accompanied Sunstar throughout transport to Palms of Pasadena.
- STEMI Alert; T25 dispatched to an overdose. Upon arrival, PCSO was on scene and related that the senior patient has been known to overdose time to time due to eyesight and forgetting whether the medication was taken or not. Patient was found in critical condition. An initial sepsis was called. Patient was quickly packaged and transported to Northside.
- T25 dispatched for an occupant trapped in elevator on 5th floor. Elevator was stuck one foot below 5th floor. Normal attempts to remove occupant did not work. T25 was able to get attic ladder to 6th floor which was approximately 12 feet above 5th floor. FF climbed down to elevator car and opened top hatch, placed attic ladder into the car and occupant climbed out, reposition ladder and occupant able to climb to 6th floor. No medical issue.
- Signal 7; T25 dispatched for a possible death. Upon arrival, crew met with PCSO and was led to a large construction dumpster where the patient was located. Patient was found pulseless with massive multi-system traumatic injuries that were incompatible with life and signal 7 was declared. Patient appeared to have fallen from an upper floor of the under-construction condominium located on the property. Scene was turned over to PCSO.
- T25 dispatched to drowning on beach, upon arrival crews found bystanders and PCSO deputy doing CPR on victim in shallow water. The victim was observed to be floating in water, unknown how long. Crews dragged victim out of water to begin treatment. Patient had pulse but was agonal respirations. T25 began treatment then was assisted by R24 and SS to remove patient off beach. Patient transported to St. Pete General with 2 medics with little improvement.
