I hope everyone continued to enjoy their summer as we continued experiencing the typical heat and humidity that forces many of us and thousands of visitors/tourists to our sand and water destinations as well as indoors into cooler locations including restaurants, retail stores, and various entertainment venues. As the heat/humidity continue, it is important to remember that our fluid levels can drop by 2-3% of our body weight before we even realize we are thirsty. Consequently, we must remember to drink fluids (water is a great one) even before we are thirsty particularly before, during, and after outdoor activities. Please remember our four-legged friends (pets) particularly dogs are very susceptible to heat stroke as well as burning their paws on hot pavement/asphalt. One way to remain cool on a hot day is to enjoy some ice cream which thanks to our Recreation, Public Works, and Sheriff Deputies, we distributed ice cream sandwiches to visitors on the sand on Monday, July 18 to celebrate National Ice Cream Day.

Additionally, it is important to remember that as we continue enjoying the gulf, the various waterways, and pools, that we exercise safety by utilizing all available safety precautions and devices from swimming in marked areas to wearing safety devices on boats to following all posted signs and markers both on water and on land.





As we celebrated our Independence Day Holiday, a very big thank you to various City departments including Recreation, Public Works, and Fire for coordinating our Fireworks show (Sunday, July 3), distributing 75th anniversary commemorative drink koozies containing a trash bag to help keep our beach clean (Monday, July 4), and participating on the Tuesday, July 5th sand clean-up. The July 5th clean-up again saw the participation of various groups including Keep Pinellas Beautiful, the Trash Pirates, and numerous City of Madeira Beach employees residents. The City very much appreciated the work and certainly all who participated in the various ongoing efforts to keep our slice of paradise as clean and beautiful as possible.



An additional important reminder is to take shelter when hearing thunder. If you are outside such as on the sand, please move away from the water to the nearest shelter. Storms particularly in the afternoon tend to develop rather quickly and contain lightning. Yes, storms tend to dissipate almost as quickly as they formed; however, avoiding being outside during lightning is something we all need to do. A few lightning tips from the National Weather Service:

Lightning: What You Need to Know

- · NO PLACE outside is safe when thunderstorms are in the area!!
- . If you hear thunder, lightning is close enough to strike you.
- When you hear thunder, immediately move to safe shelter: a substantial building with electricity or plumbing or an enclosed, metal-topped vehicle with windows up.
- Stay in safe shelter at least 30 minutes after you hear the last sound of thunder.

Indoor Lightning Safety

- Stay off corded phones, computers and other electrical equipment that put you in direct contact with electricity.
- · Avoid plumbing, including sinks, baths and faucets.
- Stay away from windows and doors, and stay off porches.
- Do not lie on concrete floors, and do not lean against concrete walls.

Last Resort Outdoor Risk Reduction Tips

If you are caught outside with no safe shelter anywhere nearby the following actions may reduce your risk:

- Immediately get off elevated areas such as hills, mountain ridges or peaks
- · Never lie flat on the ground
- · Never shelter under an isolated tree
- Never use a cliff or rocky overhang for shelter
- · Immediately get out and away from ponds, lakes and other bodies of water
- Stay away from objects that conduct electricity (barbed wire fences, power lines, windmills, etc.)

-More safety tips for pedestrians . . . many residents and visitors daily enjoy walking our city streets including our main N/S route of Gulf Blvd. Very important when crossing Gulf Blvd as well as any other busy/high traffic/multi-lane road/street to utilize marked crosswalks. Vehicle drivers, bicyclists, and pedestrians must always exercise caution as listed in the below information:

<u>Pedestrian</u>: Always use marked crosswalks

• Vehicle: Always stop for pedestrians in crosswalks until all have left the crosswalk

• Bicyclist: Always wear a helmet

• **Bicyclist**: Always check for oncoming traffic before entering an intersection

• **Pedestrian**: Always use available sidewalks, if no sidewalk, walk on the side facing traffic

Vehicle: Always drive attentively, cautiously, avoid texting or other distractions

Vehicle: Always obey all traffic laws; follow posted speed limits, watch for road signs

• Pedestrian: Always use marked crosswalks

• Bicyclist: Always signal your turns

Bicyclist: Always stop at stop signs, red lights, crosswalks with pedestrians

Vehicle: Always signal your intentionsPedestrian: Always stay alert and attentive

SAFETY WHILE WALKING

Think Ahead

Will that car turn? Is that truck backing up? Look around and think ahead.

Be Sure

Make eye contact with the driver before crossing in front of any vehicle.

Be Seen

Wear bright-colored clothing during the day. At night, wear white or reflective clothing, and carry a flashlight.



Ensure all lanes of traffic have stopped for you at the crosswalk before you cross, not just the lane closest to you.

Be Predictable

No surprises! Never step into the road suddenly or from behind a parked car or other obstacle.

Use the Crosswalks

Use the pedestrian crossing signals at busy intersections; they make crossing the street safer.

Be Part of a Group

Cross the street with a group or a crossing guard. A group is easier for a driver to see than just one person.

Use Sidewalks

If there are no sidewalks, walk on the side of the road facing the traffic so you can see the cars coming and step off the road in a hurry.



A School Crossing is ahead – these are crosswalks for children crossing the street. Approach any crosswalk with caution.

SAFETY WHILE BIKING

- · Wear a helmet.
- Remove headphones to hear traffic.
- Cross at corners and watch for turning traffic.
- Check for oncoming traffic before entering every intersection.
- Walk your bike across the street using the crosswalk.
- · Signal your turns.
- Cross with a crossing guard whenever possible.
- Don't ride between cars even parked cars.
- Stop at all stop signs and red lights.
- Ride with traffic, not against it.
- Always ride as if drivers don't see you!

SAFETY ON THE BUS

- Stay alert for cars when getting off the bus.
- Stay seated until your stop.
- Obey the bus driver.
- Be on time! Running to or from the bus leads to accidents.



City staff continued our daily provision of various services including the daily cleaning and maintenance of our sand and our parks as usage continued to be as high as in May and June particularly on the weekends. City contractor Keystone Excavating began street/road repairs damaged by Frontier Communications contractors on Crystal Dr and Lillian Dr and a City contractor continued installing curbing and some sidewalk repairs at R.O.C. Park. Parking and building permitting activity continued to be above normal throughout July, a month in which historically activity begins to slow down. City staff and Commission held a Fiscal Year 2023 budget workshop on July 20 to review personnel and department operating costs. The next FY 23 Budget Workshop will take place on Wednesday, August 27, beginning at 4 pm to discuss and finalize the total City



budget. A reminder that the City's fiscal year runs from October 1 to September 30 – so our fiscal year 2022, will conclude this September 30, with the fiscal year 2023, beginning the following day on October 1, 2022.

CITY OF MADEIRA BEACH MOBILE APP



Launched in early November 2021, remember to download the free City of Madeira Beach mobile app, *My Madeira Beach*, from the Apple App or Google Play stores. Residents, businesses, visitors can utilize the app to communicate service requests and/or report concerns/issues such as potholes, trash, graffiti, or any other area needing City attention. The app is also a great resource with links to the City website, news, and ongoing/upcoming events.

PARKING

A few reminders regarding resident and visitor parking:

- Residents can obtain up to 3 RESIDENT PARKING PASSES at no charge, that allow residents to park in any City of Madeira Beach lot while the lot is open as well as on streets that allow resident parking. No overnight parking is allowed at any City lot using the RESIDENT PARKING PASS (everyone can use the overnight parking lot areas by paying the \$3/hour fee).
- 2. RESIDENT PARKING PASSES are only for residents physically living within the City of Madeira Beach City limits not for businesses, visitors, or tourists MUST prove City residency and provide a driver's license and a valid vehicle registration.
- 3. VISITOR PARKING is available at all City of Madeira Beach lots and the John's Pass Boardwalk & Village on-street spaces and the lot adjacent to the VFW (entrance off 129th Ave E) by paying the hourly rate of \$3 (may pay using the ParkMobile app or at a kiosk/meter located at each lot). Overnight parking is only allowed at City of Madeira



Beach lots from 130th Ave to 136th Ave (entrances off Gulf Blvd) – not allowed at the John's Pass Parking lot and the Archibald Park Parking lot – by paying the \$3/hr rate (available for up to 7 days).

- 4. For safety reasons/concerns the John's Pass Parking lot on the West side of Gulf Blvd closes at 9:30 pm. Visitors and residents can park at the 130th Ave W lot or on Village Blvd (closest alternate parking locations) and still fish.
- 5. Please keep in mind, particularly visitors, that there are other privately-run/managed parking lots throughout our City that typically charge \$5-\$7/hour.

<u>HURRICANE SEASON BEGAN – JUNE 1</u>


The Atlantic Hurricane Season started last month. Please continue to be prepared.

BUILDING OFFICIAL(S)- DEVELOPMENT REPORT- (June 2021)

Building Official(s) – Development Report (JULY - 2022)

City Building Official, Frank DeSantis reports that our redevelopment/economic development continues at a fast pace including several large condominium projects on-going and/or under plan review.

- The Schooner Resort is under review
- The Tiki Docks Bar & Grill is under review
- 15405 Gulf Blvd Azul Townhomes Phase I (6-units) is under review.
 - √ Foundation permit has been issued
 - ✓ Waiting for Duke Energy to finish (2) directional bores to re-route several overhead and underground power supplies from the site.

• 300 150th Ave. The Residences at Town Center

- ✓ Foundation permit issued and test pile has been delivered. Pile driving equipment is on site.
- ✓ Waiting for Duke Energy to remove the overhead and underground power and associated transformers from site before pile can begin.

200 150th Ave. Harbor at Town Center Condominiums project

- ✓ Insulation and drywall is complete with the exception of the ground floor lobby.
- ✓ Paint work continues on the upper floors.
- ✓ Cabinets and flooring install is progressing on the upper floors.
- ✓ Elevator (2) install is complete. Block work at each front should be complete in approx. 12 days.
- ✓ Construction power has been removed.
- ✓ Pool coping is complete. Power and water are currently being connected. Pool deck pavers are on site.
- ✓ D.O.T. permit is in hand for the directional bore. Work scheduled to begin Monday, June 6.
- ✓ Electrical trim is progressing on 2nd. And 3rd floors and should be ready for insp. soon to facilitate power release to Duke Energy.



TO THE QUALIFIED ELECTORS of the City of Madeira Beach, Florida, in accordance with the provisions of the City Charter, City of Madeira Beach, Florida and the State of Florida Election Code, PUBLIC NOTICE is hereby given and published that the City of Madeira Beach has two (2) Charter Amendments as referendum on the November 8, 2022 General Election Ballot for the electors of the City of Madeira Beach to vote on.

The Charter Amendments shall only become effective upon approval by a majority of the electors voting on each of the individual ballot questions in the November 8, 2022 election and shall be incorporated into and become a part of the Charter. If a majority of those voting in the election vote "no" to any particular individual Charter Amendment, that particular Charter Amendment shall not be adopted and its provisions, as adopted in Ordinance 2022-15, shall be of no force or effect.

For the November 8, 2022 General Election, the polls will be open from 7:00 a.m. to 7:00 p.m. and the polling locations for the City of Madeira Beach electors to vote in the November 8, 2022 General Election are as follows:

- Precinct 415 Madeira Beach Municipal Building, City Centre Room, 300 Municipal Drive, Madeira Beach, Florida;
- Precinct 301 Calvary Church Seminole (Combined), 6155 113 Street, Seminole, Florida 33772.

Qualification and Term of Office

This amendment is to avoid a conflict with Charter, Section 4.8, Induction of Board of Commissioners into office; meetings.

This amendment avoids a conflict with Charter, Section 2.2, Board of Commissioners; qualifications; term of office; and vacancies; Qualifications and Term of Office.

A LOS ELECTORES CALIFICADOS de la Ciudad de Madeira Beach, Florida, de conformidad con las disposiciones del Estatuto de la Ciudad, Ciudad de Madeira Beach, Florida, y del Código Electoral del Estado de la Florida, por el presente se notifica y publica que la Ciudad de Madeira Beach va a colocar dos (2) enmiendas al Estatuto como referéndum en la boleta electoral de la Elección General del 8 de noviembre de 2022, para que electores de la Ciudad de Madeira Beach voten sobre ellas.

Las enmiendas al Estatuto solo entrarán en vigor una vez aprobadas por la mayoría de los electores que voten en cada pregunta individual en la boleta electoral en la Elección del 8 de noviembre de 2022, y se incorporarán y formaran parte del Estatuto. Si la mayoría de los electores que votaron en la Elección votaron "no", en contra de que se enmiende una sección individual del Estatuto, entonces esa particular enmienda al Estatuto no se adoptará y sus disposiciones, tal y como se adoptaron en la Ordenanza 2022-15, no tendrán vigencia ni efecto.

Para las Elección General del 8 de noviembre de 2022, las urnas permanecerán abiertas desde las 7:00 de la mañana hasta las 7:00 de la noche, y los centros de votación para que los electores de la Ciudad de Madeira Beach vayan a votar en las Elección General del 8 de noviembre de 2022 son los siguientes:

- Precinto 415 Edificio Municipal de Madeira Beach, Salón City Centre, 300 Municipal Drive, Madeira Beach, Florida.
- Precinto 301 Iglesia Calvary Church Seminole (combinado), 6155 113 Street, Seminole, Florida 33772.

La Junta de Escrutinio del Condado de Pinellas fungirá como la Junta de Escrutinio de la Ciudad de Madeira Beach, para escrutar los resultados de esta Elección General, el martes 8 de noviembre de 2022.


On July 22nd the Marina hosted a waterway clean-up together with Waterways Warrior Alliance, Freedom Boat Club and Gulfport Dive Center. This was a snorkeling-SCUBA clean-up focused on the local waterways and Johns Pass sandbar. Several different items were removed from old dock lines to the ever-present plastic bottles and aluminum cans. This was a great event, and we plan to coordinate several more like it in the future. We are planning an Amphibious Clean-up Tournament; this will be held on September 17th in conjunction with the Nautical Flea Market at the City Rec Center. The plan is to get people signed up and collect trash that morning around or local beaches, parks, and waterways. Then our "trash anglers" will bring back there catch and judges will determine who wins in the several different categories. Local shops and restaurants are donating gift cards and other items for prizes. Lunch will be provided for all clean-up participants.

Grouper and Snapper fishing has been productive this summer, but the recreational Red Snapper season will close on August 1st. Red Snapper are scheduled to reopen for recreational anglers on weekends in October; 8-9, 15-16, 22-23, also Nov. 11-13, and Nov. 25-27. Be sure to check MyFWC for any changes before you head out.

While boating this month, make sure to keep an eye out for storms. Don't hesitate to make the call to head back in. Be safe and enjoy the paradise we live in.

PUBLIC WORKS

Public works would like to ask residents and business owners to please be mindful of the amount of liquids that ends up in the garbage especially with the amounts of rain recently. The liquid from the garbage is filling up the hopper and compaction area of the garbage truck. The liquid then splashes out onto the driveways, streets, and sidewalks. In most cases, this is a violation of Pinellas County Stormwater and Surface Water Pollution ordinance, which prohibits any discharge other than clean water to the right-of-way, drainage system, or receiving waterways. Violators of the County Stormwater Ordinance may be fined up to \$10,000 per day and held responsible for



cleanup. Elimination of liquids entering the waste stream is mandated by both the City of Madeira Beach and Pinellas County.

Common practices for reducing liquids in solid waste include:

- Empty ice and liquids into a sink with a drain.
- Draining all cups, containers, and bottles into the sink before discarding.
- Do not put grease or oils into solid waste: commercial kitchens are required to use and maintain a grease trap/interceptor system.
- Keep dumpster/garbage can lids always closed to prevent rainwater from entering.

Please remember, residents must have a garbage can (maximum of 2 per household) no larger than 32 gallons and must have a tight-fitting lid. Please bring your garbage cans to an easily accessible (visible from the street / curb) location for collection the night before your scheduled collection day or no later than 7 AM.

A few reminders of collections day are as follows

Wednesday Pickups

- Brush Pickup Piles may not be any larger than 8x4 area and cut into 4-foot sections.
 Brush may not exceed 4 inches in diameter. Piles must be out no later than 7 AM
 Wednesday morning and placed on private property DO NOT PLACE ON THE ROAD OR ON TOP OF STORMDRAINS
- **Bulk Item pickup** All items must be scheduled with public works prior to pick up. Additional fees will be assessed for items that are not regular refuse. See below for items not picked up by Solid Waste.
- Recycling Bins must be out at the curb no later than 7 AM to ensure pickup.

Sanitation does not pickup concrete material, pavers, paint, chemicals, or interior or exterior demolition material. Please make arrangements with your contractor for disposal or items may be taken to the Pinellas County Solid Waste dump site.

Stormwater Reminder

We would like to remind you, that the catch basins and grates you see on the side of your streets convey the stormwater runoff directly into Boca Ciega Bay. Please do not put anything into these drains that could harm the waters or wildlife that depend on these waters.

It is illegal to dump toxic chemicals or waste into storm drains or anywhere else that may expose waste in the environment. To report illegal dumping, Call the public works department at 727-543-8154.

Please remember that yard trimmings should not be blown into the streets and consequently down the stormdrains.

Project Updates

Beach Groin Renourishment Project

• Engineers are working on the storm event model design and will be submitting permit applications to FDEP and Army Corp as soon as possible.

<u>Area 3 – E Parsley, W Parsley, Marguerite, A Street, B Street, and Lynn Way. Roadway and Drainage improvement Project.</u>

Surveying is complete, working on preliminary design

140th Roadway Repair Project

Project has been completed

Gulf Lane and Beach Access roadway and drainage improvements

- The project will consist of Milling and resurfacing Gulf Lane along with 135th to 130th Beach access parking lots and improving the stormwater drainage.
- Surveying has been completed and the design plans are at 90%, project will be put out for bid within the next couple of months

Gulf Blvd Utility Undergrounding

- Waiting for the Binding Cost Estimate (BCE) from Duke Energy, should have it by early August. This consist of quantities of materials needed for the project
- Anticipated construction starts date October 2022
- Anticipated date for completion August 2023

Crystal Island Repairs

- Keystone has repaired all damaged fabric and compacted the road base
- Milling and resurfacing scheduled for the week of August 8th.
