
- **Property Taxes** continue to be the City's single largest source of revenue at \$4,667,264

#### **CITY RECYCLING**

On August 12, the City issued the below request for proposals (RFP) for continued recycling services. City staff will be presenting the results of the RFP process to the Commission on the date indicated.

#### PURPOSE & INTRODUCTION

This Request for Proposals (RFP) is for The City of Madeira Beach to receive responses from qualified firms/companies capable of assisting the city in meeting its recycling collection and processing service needs. The collection is the pickup of recyclable material; processing is sorting, baling, and selling recyclable material so it can be made into new material.

Recyclable Materials are defined as follows:

- a. <u>Recyclable items accepted</u>- metal food and drink cans, glass bottles and jars, plastic bottles and jugs, and paper and cardboard (and cartons).
- b. <u>Recyclable items not accepted</u> plastic bags and plastic wrap, food and liquid waste, and Styrofoam containers. Items that are not accepted are typically considered "contamination" in recycling programs because they must be disposed. There is a cost to handle and dispose of contamination.

The City currently has a contracted vendor, and the contract is expiring at the end of the year.

#### PROJECT DESCRIPTION

The city is in search of a company to:

- Pick up and process residential recyclable material once per week and Commercial based on volume.
  - Containers to be provided by contractor
    - Residential Minimum of 64-gallon cart with a lid and wheels.
    - Commercial 96-gallon cart with a lid and wheels.
  - Single Family 1,222
  - Multi Family 539
    - Prior to the contract agreement staff and contractor will agree on the number of residential and multi-family.
- Potential bidders are welcome to visit by appointment only.


#### **HURRICANE SEASON CONTINUES**



**TO THE QUALIFIED ELECTORS** of the City of Madeira Beach, Florida, in accordance with the provisions of the City Charter, City of Madeira Beach, Florida and the State of Florida Election Code, PUBLIC NOTICE is hereby given and published that the City of Madeira Beach has two (2) Charter Amendments as referendum on the November 8, 2022 General Election Ballot for the electors of the City of Madeira Beach to vote on.

The Charter Amendments shall only become effective upon approval by a majority of the electors voting on each of the individual ballot questions in the November 8, 2022 election and shall be incorporated into and become a part of the Charter. If a majority of those voting in the election vote



"no" to any particular individual Charter Amendment, that particular Charter Amendment shall not be adopted and its provisions, as adopted in Ordinance 2022-15, shall be of no force or effect.

For the November 8, 2022 General Election, the polls will be open from 7:00 a.m. to 7:00 p.m. and the polling locations for the City of Madeira Beach electors to vote in the November 8, 2022 General Election are as follows:

Should Section 4.8 of the Charter be amended to provide that the first meeting of each newly elected member of the Board of Commissioners for induction into office shall be held at a meeting on or before the last day of the month in which the election was held? This amendment avoids a conflict with Charter, Section 2.2, Board of Commissioners; qualifications; term of office; and vacancies; Qualifications and Term of Office.

August has continued to be quite busy despite the closer of Red Snapper season and the start of the school year. We have seen almost double the amount of transient business than this time last year and visitors still seem to be coming out to the beaches. The lower fuel prices over the last month have been a factor as well, dropping around a dollar per gallon since the start of July. On September 17th in conjunction with the Nautical Flea Market held at the Madeira Beach ROC Park, we will be hosting the first Mad Beach Amphibious Trash Roundup. This will be a land and waterway cleanup focused on our coastal areas with a tournament style "weigh-in". We will be having a light Q&A Captains meeting on September 16th at 6:00pm to hand out free trash buckets to our first 50 registered trash anglers. We will also have a map displayed showing the areas that seem to accumulate trash. To register go to madeirabeachmarina.com and click the link below the trash cleaning octopus. On Saturday the 17th starting at 12:00pm we will begin our trash "weighin". Anglers will receive prizes in eight different categories, however all anglers who participate in the cleanup will be entered into a raffle for a Big Green Egg grill. Following the Awards Ceremony there will be live music and participants can enjoy the other festivities in the park. This event is geared toward keeping our most precious resource pristine and educating future generations to be good stewards of the environment. 


event, Madeira Beach Recreation Center, Old Salts Fishing Foundation, Trash Pirates and The Waterway Warriors Alliance.

If you plan on fishing, you should plan on staying up late. Daytime fishing has been slow but the nighttime fishing for snook and redfish around bridge and dock lights has been quite productive. I like to see a high tide that starts falling out in early morning hours. Medium action spinning tackle with 30lb braid, 30lb fluorocarbon leader and a 3X 1/0 hook will work best. Quietly approach the light with a trolling motor as to not spook the fish and being courteous to the neighbors, also stay at least 30' feet from the light for maximum stealth. A medium size live shrimp or pilchard freelined quietly into the shadows of the light will get the attention of some big snook and reds. This is combat style fishing so have your drags locked and for extra help point the trolling motor away from the dock on high to help you pull the fish away from the structure. 

7/04/22	Seminole	T25 dispatched for dumpster fire, upon arrival found one dumpster with fire showing and exposing power pole to heat and flame. T25 stretched slop line and extinguished fire with approximately 300 gallons. Inside dumpster there were multiple used fireworks that were improperly disposed of. Fire extinguished without incident.
7/15/22	Bay Pines	STEMI Alert; T25 responded to chest pain, patient assessment revealed STEMI and treatment was initiated immediately. Patient was transported to Northside Medical Center.
7/20/22	Madeira Beach	T25 was dispatched to a stroke, upon arrival found the patient in distress unable to communicate. Crews quickly evaluated the patient and deemed the patient a stroke alert due to multiple deficits. Patient was quickly packaged and T25 crews assisted

Sunstar to transport patient to Largo Medical.

7/24/22 Seminole Structure Fire; T25 responded on the first alarm for a working structure fire. Station 29 units arrived first on scene, reported heavy fire in the garage and made transitional attack. Upon arrival, T25 was tasked with assisting with the water supply and assigned to the interior once the operation transitioned into offensive mode. T25 assisted with locating and extinguishing the remaining interior fire, confirming no occupants were in the house and eventually overhaul

7/27/22 Madeira Beach Water Rescue; M25 and SR25 responded on the first alarm for a water rescue. SR25 arrived first on scene, established command, and was able to get a visual on one person in obvious distress near the swim buoy, approximately 200 yard offshore. SR25 passed command to D29 and entered the water with the rescue board. The victim was clinging to the swim buoy and advised that he was exhausted and unable to swim anymore. The victim was then placed on the rescue board and swam back to shore, where the medical group (E29 and Sunstar) and ground units were waiting. The patient was physically exhausted, vomiting from swallowing sea water, had numerous minor lacerations from the barnacles on the buoy. Treatment was initiated immediately, and the patient was transported to Palms of Pasadena Hospital.

7/29/22 Madeira Beach T25 was dispatched to breathing problems. Upon arrival crews found female patient laying in bed in respiratory distress. Patient was quickly evaluated and was found to be a sepsis alert. Patient was transported to St. Pete General with FD rider. Patient was treated enroute with improvement.
