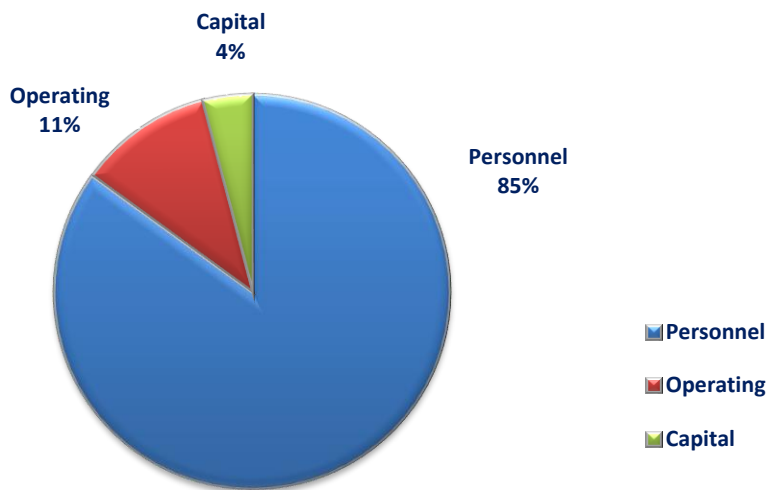

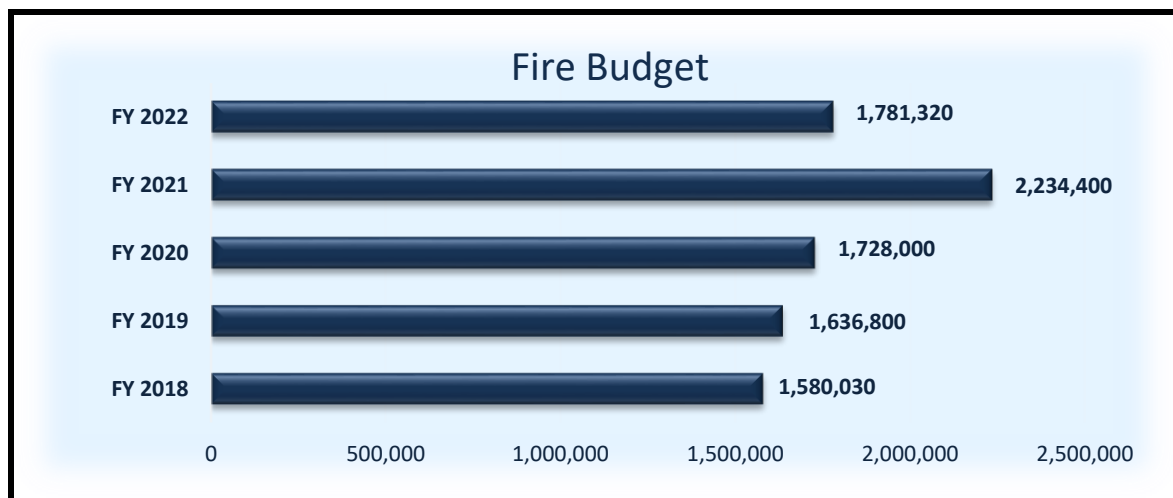

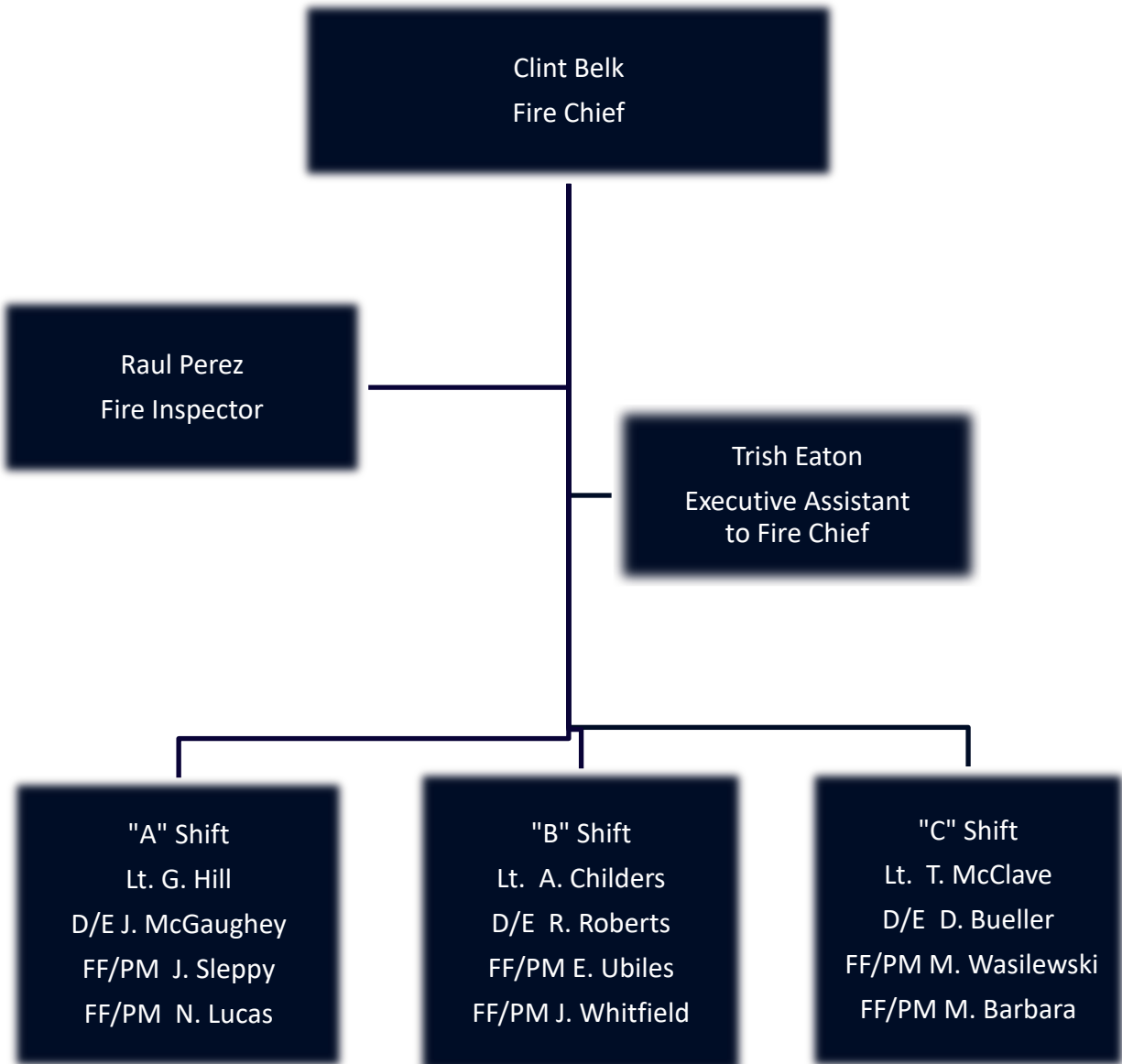

- ✓ Engine Strike Team Deployment to assist communities in Southwest Florida with Rescue and Recovery to areas affected by Hurricane Ian. Engine 25 was deployed for approximately 3 weeks with crew members switching periodically. Lt. Childers, FF Sleppy, FF Ubiles and D/E Bueller completed the assignment.

- ✓ Took delivery of Rosenbauer Aerial - Truck 25 (2022) on October 3, 2022. Apparatus was delivered by George Biggs. Lt. McClave completed an unofficial inspection on behalf of Lt. Childers who was deployed to the hurricane task team days before.

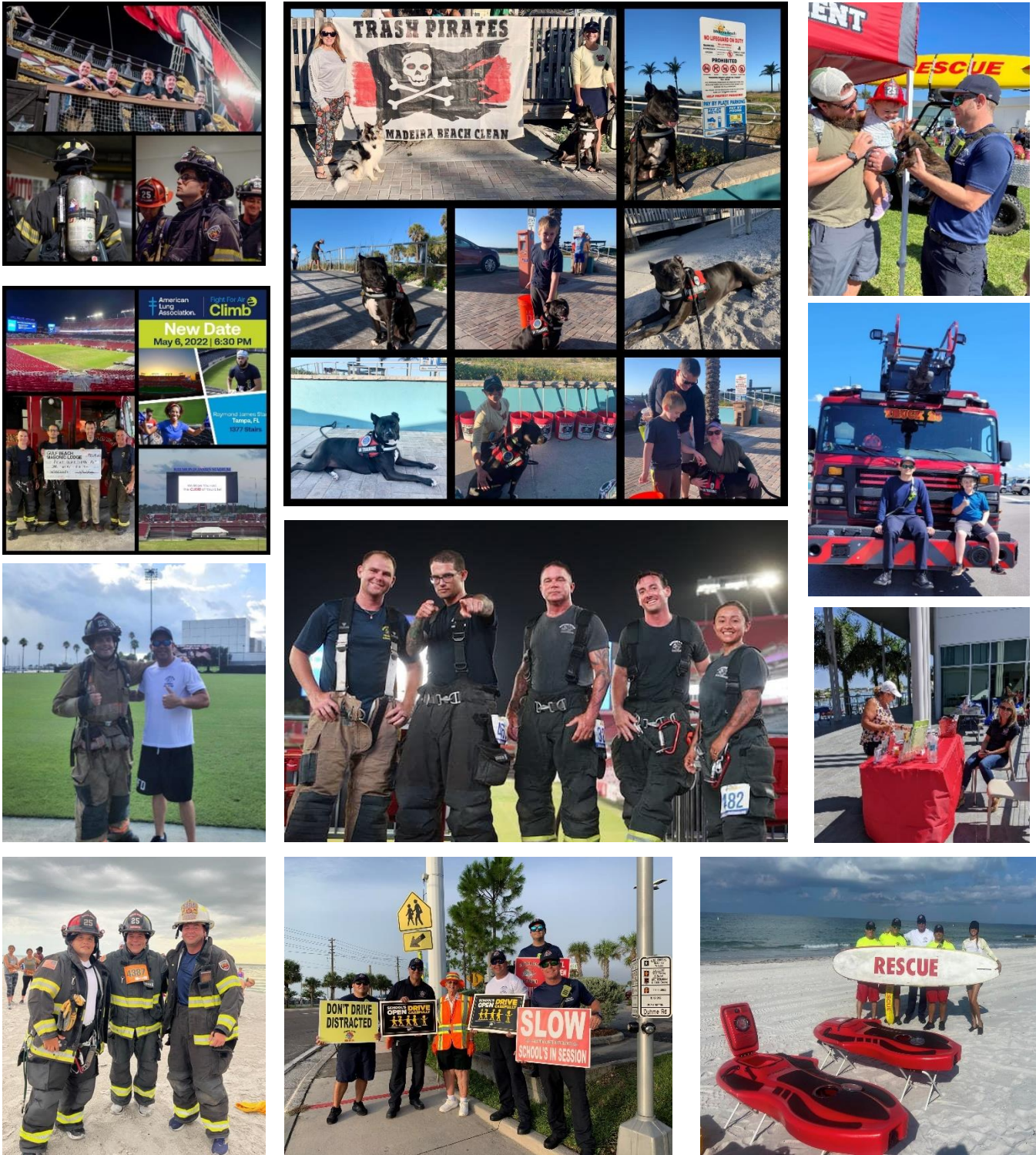

## COMMUNITY EVENTS AND PROJECTS

- ✓ Administrative Assistant Eaton participated in the Dog Park event where discussion was held on park improvements.
- ✓ Crew, Fire Inspector Perez and Clover participated in the Annual Kite Day event.
- ✓ Coordinated and participated in the September 11<sup>th</sup> Day of Remembrance Ceremony at Patriot Park and Friendship Park at Redington Beach. City staff and crews placed USA flags representing each life lost during September 11<sup>th</sup> tragedy at the 9/11 Memorial days prior to the ceremony.
- ✓ Lt. Childers, Lt. McClave, FF Ubiles, FF Wasilewski and FF Whitfield participated in the American Lung Association Fight for Air Stair Climb @ Raymond James Stadium. FF Wasilewski placed overall first place in the Firefighter category at a total time of 8:39.4.

- ✓ Mike Alstott and family visited the station and on behalf of his Foundation dropped off a Thanksgiving dinner for the shift on duty during the holiday.

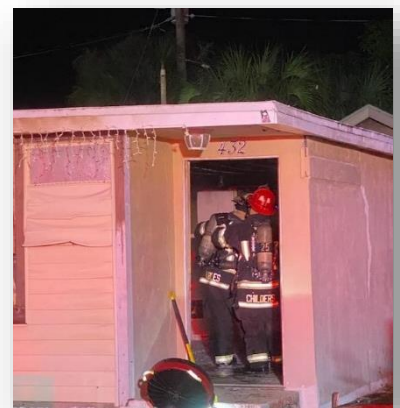
- ✓ The Department participated in Santa delivery and tree lighting event at John's Pass. Truck 25 also delivered Santa to the American Legion, The Elks Lodge, Town of Redington Beach and North Redington Beach for the annual holiday events.
- ✓ The Department replaced the 2014 Ford Explorer Fire Inspector vehicle with a 2022 Toyota Tacoma. Once the installation of electronics and equipment for MB400 was completed the 2014 Explorer became Utility 25 and is designated to be used as a department vehicle.
- ✓ Madeira Beach Fire Department staff with their families gathered for a Christmas breakfast with Santa arriving on the fire truck with gifts in hand.



## SIGNIFICANT RESPONSES

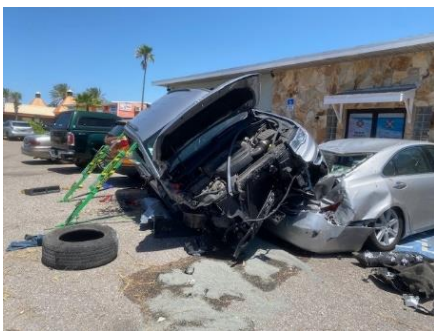
### Structure Fires/Property Fires

- Crews were dispatched to a vehicle fire. While responding dispatch advised house is catching fire and upgrade to structure fire. Upon arrival, crews found one vehicle with engine compartment on fire with slight exposure of fence. Fire extinguished with pre-connect. T29 and D29 assisted and PCSO was called for owner of vehicle arguing with neighbors. Scene turned over to PCSO.
- Truck 25 was dispatched to a structure fire. Upon arrival the crews had a one-story residential rental fully involved. T25 assisted with exposures and providing an additional water supply. After the fire was out T25 began salvage and overhaul within the structure.
- T25 responded on the first alarm for a working structure fire. Station 29 units arrived first on scene, reported heavy fire in the garage and made transitional attack. Upon arrival, T25 was tasked to assist with the water supply and assigned to the interior once the operation transitioned into offensive mode. T25 assisted with locating and extinguishing the remaining interior fire, confirming no occupants were in the house and eventually overhaul.
- T25 was dispatched for dumpster fire. Upon arrival found one dumpster with fire showing and exposing power pole to heat and flame. T25 stretched the line and extinguished fire with approximately 300 gallons of water. Inside the dumpster there were multiple used fireworks that were improperly disposed of. The fire was extinguished without incident.
- T25 responded on the first alarm for a house on fire. T25 arrived as the first unit on scene and found a small one-story single family residential structure with fire through the roof. Truck 25 made an offensive fire attack and was able to successfully extinguish the fire, limiting major damage to the kitchen and bathroom areas of the structure. Primary search revealed the house to be vacant and undergoing renovations. The scene was turned over to MB400 upon his arrival.
- T25 dispatched with Seminole units for report of RV on fire in backyard and fire to be close to the house. E29 was first on scene and reported fully involved RV behind house. T25 was the first due truck and was assigned to assist with water supply to E29. Two crew members assisted with water supply and three members went in to assist crews with fire attack. T25 forced entry to RV, completed primary search, followed by completion of overhaul with member of E32. Once completed with overhaul T25 ventilated the RV.



## Motor Vehicle Collision (MVC)

- Upon arrival T25 found a single vehicle crashed into a telephone pole. An upgrade to Trauma Alert was made with patient transport to Bayfront ER.
- Trauma Alert; T25 was dispatched to a motor vehicle crash by John's Pass Boardwalk. Upon arrival the crew found a motorcyclist down on the ground. T25 evaluated the patient and deemed trauma alert due to the injuries sustained. Patient was transported with 2 FD riders to Bayfront ER without incident.
- Trauma Alert (x2); T25 responded for extrication, upon arrival crews found 2 patients were trapped in a heavily damaged pick-up truck on its roof. Assessment revealed both to be trauma alerts and both were extricated after a prolonged extrication operation by approximately 45 minutes. Both patients were transported to Bayfront Trauma Center.
- Motor Vehicle Crash; upon arrival T25 found one male patient down in the roadway, with bystanders helping him. Patient was on his trike motorcycle and was struck from behind at unknown speed. Patient was declared a trauma alert and transported with 2 MBFD medics to Bayfront Trauma Center.
- Trauma Alert; T25 responded for an extrication. Patient self-extricated prior to FD arrival after his vehicle flipped several times and landed on top of two parked cars. Assessment revealed patient was a Trauma Alert. Patient was transported to Bayfront Trauma Center.
- MVC; upon arrival T25 found a male laying in the roadway in critical condition. Patient was quickly evaluated, and a trauma alert was called due to the patient's injuries. Patient was quickly packaged and transported to Bayfront as Trauma Alert.
- Truck 25 and E24 were dispatched for a Motor Vehicle Crash. T25 arrived first on scene to find 2 vehicles in the roadway with moderate damage. T25 arrived first on scene to find 2 vehicles in the roadway with moderate damage. T25 quickly triaged the patients, finding the driver of vehicle 1 with moderate injuries to his extremities and the 3 occupants of vehicle 2 all ambulatory with no obvious injuries. T25 began treatment of the driver of vehicle 1, eventually determining him to be a Trauma Alert and transporting him to Bayfront Trauma Center. E25 evaluated the occupants of vehicle 2. Scene was eventually left with PCSO after all hazards were mitigated.
- Extrication; T25 responded for a possible extrication. T25 arrived first on scene to find one pickup truck on its side resting against a building, investigation revealed the patient to be category green, standing up in the truck. Vehicle was stabilized and the patient was assisted out of the rear window after its removal.
- T25 dispatched for traumatic injury. Upon arrival crews found one male patient down in the roadway and a bystander doing CPR. The patient had large head injury and was in cardiac arrest. Witnesses at the scene stated the patient fell off a moving golf cart. T25 initiated treatment and rapid transport, ROSC obtained enroute to St. Pete General, crew diverted to Bayfront Medical Center. Patient care transferred to Bayfront's staff. Scene turned over to PCSO for investigation.



## Water Rescue

- Marine 25 was dispatched to a water rescue of 2 males in a john boat that appeared to be in distress. Upon arrival M25 found one male on the rocks and one male holding on to a capsized john boat. Crew made contact with the male clinging to the boat and got him secured onto M25. Marine 24 got the second victim to the dock at Crabby's (TI side of JP bridge) and called for PD support. When the police arrived, the patient was escorted to R24. The second patient was also taken to Cabby's and transferred to ALS crew for evaluation. M25 went available after transfer of care to TI.
- Truck 25 was dispatched to a water rescue. Upon arrival crews were able to quickly rescue 2 patients struggling in the water with Good Samaritans' help. Truck 25 was then told by the patients that there was still one person missing. T25 along with M31, PCSO, Coast Guard, and FWC begin to search through the John's Pass area. After several hours on water unit was unable to locate patient. The scene was turned over to PCSO and Coast Guard.
- Water Rescue; M25 and SR25 responded on the first alarm for a water rescue. SR25 arrived first on scene, established command, and was able to get a visual on one person in obvious distress near the swim buoy, approximately 200 yards offshore. SR25 passed command to D29 and entered the water with the rescue board. The victim was clinging to the swim buoy and advised that he was exhausted and unable to swim anymore. The victim was then placed on the rescue board and swam back to shore, where the medical group (E29 and Sunstar) and ground units were waiting. The patient was physically exhausted, vomiting from swallowing sea water and had numerous minor lacerations from the barnacles on the buoy. Treatment was initiated immediately, and the patient was transported to Palms of Pasadena Hospital.
- At 04:43 am Marine 25 responded to reports of a person that could not get on-board of a sailboat from a raft. Station 29 units arrived as the first ground units on scene at the boat ramp, with D29 establishing command and the ALS units establishing the Medical Group. M25 arrived as the first Marine unit on scene and found an unconscious adult male in a half-submerged inflatable dinghy with bystanders on the sailboat and a second inflatable dinghy attempting to keep his head out of the water. The bystander on the sailboat advised that the patient had COPD and a broken arm in a cast and had been trying unsuccessfully for approximately one hour to climb from the dinghy aboard the sailboat. FF/PM Ubiles was deployed as the rescue swimmer immediately upon our arrival and was able to access the patient from the water, confirming him to be unconscious and advising that he was tangled in several mooring lines and the half-deflated dinghy. DE/PM Roberts, functioning as the operator of M25, was able to get within 15' of the dinghy and patient and maintain his positioning throughout the operation. FF Ubiles was then able to swim the patient and the dinghy over to M25,



while keeping the patient's head out of the water; where Lt. Childers and FF/PM Whitfield were able to untangle the mooring lines and lift the patient high enough for FF Ubiles to swim to the patient. He then moved the dinghy with the patient to M25 while keeping the patient's head out of the water. Crew was able to untangle the mooring lines and lifted the patient high enough for patient with his head and torso out of the water while the stokes basket and backboard was prepared. Once the stokes basket was in place, the patient was lifted out of the water, onto the stokes basket and loaded onto M25.



- FF Whitfield immediately assessed the patient, finding him to be pulseless and apneic, and started CPR. FF Ubiles assisted back onboard M25, DE Roberts expertly proceeded to the boat ramp, with CPR in progress. The Medical Group was standing by. M25 docked and the patient was transferred to the dock and stretcher via stokes basket. ALS care was initiated immediately. The medical group was able to obtain ROSC and the patient was transported to the hospital in critical condition.
- Marine 25 responded with other first alarm units for a water rescue. M25 arrived as the first FD marine unit on scene to find Treasure Island PD marine unit assisting one adult male with a fractured ankle onboard of their boat. The crew of M25 boarded the PD vessel and provided BLS care until the patient was dropped off to the waiting medical group at nearby John's Pass Marina. The medical group quickly determined the patient to be a trauma alert and transported him to Bayfront Trauma Center.



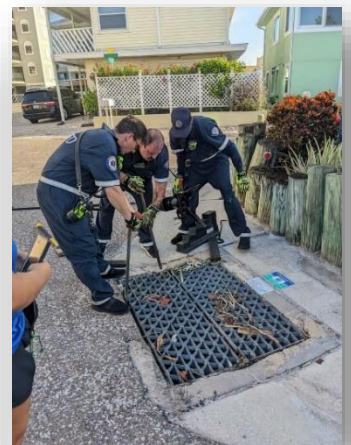
### Other

- T25 was dispatched to assist PCSO evaluate a patient. Crews found an elderly male having a stroke. A Stroke Alert was declared, and patient was transported with 2 medics to Northside Hospital.
- T25 was dispatched for suicidal male on beach with a gun. Prior to crews arriving subject shot himself. T25 treated and transported male patient to St. Pete General with single gunshot wound to the head. Patient was in cardiac arrest throughout the entire call. The hospital pronounced Signal 7.
- T25 was dispatched to seizures, while enroute the call was changed to possible overdose. Upon arrival T25 found adult male in respiratory arrest inside a vehicle. Bystanders stated they put the vehicle in park and took the keys when the patient was seizing. Strong smell of marijuana in the vehicle and drugs/paraphernalia was found also. Pt. was given Narcan and removed from vehicle to the stretcher. ALS procedures were started and more Narcan given during transport to Palms of Pasadena with 2 FD riders and EMS student. The patient was transferred to hospital staff fully awake, talking.
- Truck 25 dispatched to male patient who fell off the ladder. Upon arrival crews found a patient at back of business with bilateral fractured forearm and minor lower leg injuries due to an approximately 8-foot fall. Patient transported to Bayfront.
- T25 was dispatched to unconscious person on sidewalk; upon arrival PCSO was on scene and advising male patient cut his wrist and they applied on tourniquet to left arm. Because the patient was violent, PCSO and MBFD personnel restrained the patient before administering treatment. Patient was transported to Bayfront with two MBFD riders and one PCSO Deputy without incident.
- T25 self-dispatched to a walk-in patient at City Hall. After evaluation of the patient, it was found he was having a heart attack. T25 activated a STEMI-alert and assisted Sunstar enroute emergency to Northside Hospital.
- Marine 25 responded to a water rescue. Upon arrival, M25 found one person deceased, floating in a dinghy near Hurricane Hole. Signal 7 was declared, and the dinghy was towed to the docks at the Bay Pines VA complex where PD was standing by.
- Crews responded to lacerations; further information revealed patient sustained injuries from jumping off a boat at a sandbar. Patient's injury was caused by a cleat on the boat. The patient was brought to John's Pass Marina on Treasure Island side by a Good Samaritan on a jet ski. FWC made patient contact and applied tourniquet to the large laceration on back of the knee. Patient was a young adult male. T25 crew-initiated ALS care and transferred patient care to Bayfront Medical Center staff.
- T25 was dispatched for seizures. Upon arrival, T25 found a City Sanitation employee unconscious in the roadway. Co-workers advised that the patient had a seizure and had been unconscious since. Treatment was initiated immediately, and the patient was transported to Palms of Pasadena Hospital.

- Truck 25 was dispatched to an overdose. Upon arrival crew members found an adult patient hallucinating. After examining the patient, it was noted that T25's CO monitor was alarming. Crews quickly figured out that the patient had CO poisoning second to their hookah pipe that was burning slowly throughout the day. T25 transferred patient care to Sunstar and provided ventilation inside of house to mitigate the hazard.
- Upon arrival T25 crews found an adult patient with severe traumatic injuries from a fall. T25 quickly examined the patient and deemed the patient a trauma alert due to the severity of the injuries. T25 packaged the patient and rode in with Sunstar to Bayfront Medical Center.
- T25 was dispatched to a stroke, upon arrival found the patient in distress unable to communicate. Crews quickly evaluated the patient and deemed the patient a stroke alert due to multiple deficits. Patient was quickly packaged and T25 crews assisted Sunstar to transport patient to Largo Medical.
- Truck 25 was dispatched to person passed out at South Beach access. The patient had fallen and was declared trauma alert with possible head injury. Patient transported to Bayfront Medical Center with MBFD personnel and Sunstar. Patient remained in critical condition at transfer to BMC staff.
- Crews from MBFD and Treasure Island helped young and frightened kitten, Plum, get down from a pine tree. The crew was thanked by all the bystanders including the family's dog.
- T25 responded to assist PCSO with an unconscious male found under the deck of a local business. The patient was unconscious and in respiratory failure. Treatment was initiated immediately, and the patient began breathing on his own after Narcan was administered. The patient was transported to Palms of Pasadena Hospital with care continuing enroute.
- T25 was dispatched to assist S26 and Sunstar with a cardiac arrest at Redington Shores Town Hall. Upon arrival, S26 and Sunstar had begun treatment, the patient had a pulse and was breathing but was having serious cardiac issues. The patient was shocked approximately 5 times due to lethal arrhythmias. T25 medic, S26 medic and Sunstar transported patients to Largo Medical Center. Enroute to the hospital, the patient regained full consciousness and had a conversation with crew. The patient was declared a STEMI and was having significant heart attack. Patient care transferred to hospital staff.
- Crews responded for an unconscious person in the restroom of a restaurant in John's Pass Village. T25 found an adult patient on the bathroom floor unresponsive with agonal respiration. T25 initiated Advanced Life Saving (ALS) care and treatment for possible overdose. The patient was revived and care transferred to Sunstar for transport to Palms of Pasadena.
- T25 dispatched to a fall. Upon arrival crews found patient sitting against the wall with cc of head pain and bleeding due to a laceration on her forehead. Crews quickly evaluated the patient and deemed the patient a trauma alert due to the multiple injuries that the patient sustained and how she was presenting. The patient was quickly packaged and transported emergency to Bayfront ER. T25 assisted patient transport to the ER without incident.



- Truck 25 was dispatched to an Animal Bite; upon arrival T25 found adult patient with a severe right arm injury and puncture wounds to the face from a dog attack. The patient was treated and declared a Trauma Alert and transported to Bayfront Medical Center with 2 FD riders and Sunstar.
- T25 was dispatched to diabetic problems. Upon arrival the patient was found laying on the couch confused. Patient was quickly examined and found to be in critical condition with a very high glucose. 2 FD riders assisted Sunstar with patient transport, the patient was found to be having a hart attack enroute to the hospital. Patient care was transferred to ER doctor without incident.
- Truck 25 was dispatched to a fall, when crews arrived they found a male patient in critical condition from a 2-story fall. T25 quickly packaged the patient and called a trauma alert due to the injuries sustained. T25 assisted Sunstar enroute to Bayfront Medical Center.
- PCSO arrived on-scene and reported cardiac arrest. T25 responded to reported overdose. Upon arrival, T25 found a male in cardiac arrest ALS treatment initiated and ROSC was obtained in less than 10 minutes. Patient transported to Northside Hospital with 2 FD riders. Patient care transferred to NSH staff without incident.
- T25 was dispatched for laceration, while enroute dispatch advised that the patient was located on the roof and unable to get down. Upon arrival, T25 located one patient on a single-story residential roof with a large laceration to his lower leg that was caused by an angle grinder being used to cut material for roof repairs. Access to the roof was made with 14' roof ladder and care was initiated while the reminder of the crew set up for a ladder ram rescue Once the patient was bandaged, he was loaded into the stokes basket and lowered down the ladder using 2 lifelines and body-belays. Once safely on the ground, care was transferred to Sunstar, and the patient was transported to Bayfront Trauma Center.
- T25 responded to a hemorrhage emergency. Upon arrival T25 found a patient sitting in the house with chief complaint of bleeding and weakness. T25 quickly examined the patient and realized this was a very critical patient due to the patient's condition and vitals. Patient was quickly packaged and treated enroute to Palms of Pasadena with 2 FD riders. The patient was stabilized and patient care with report was given to ER doctor without incident.
- T25 dispatched to a sick person, upon arrival found the patient to be sitting on a floating dock with chief complaint of weakness. The patient was quickly evaluated and was found to be having a heart attack. FD Medics assisted with Sunstar transport to Northside.

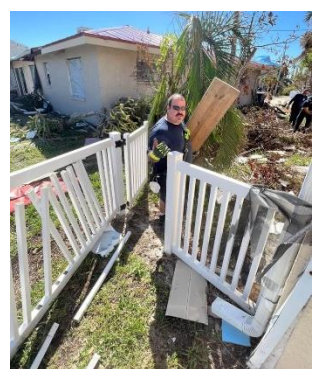
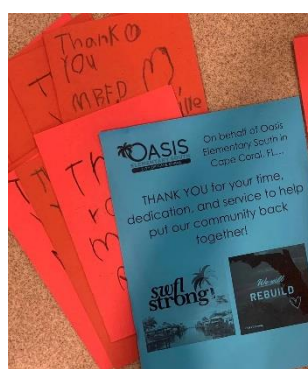
