NOTICE OF AVAILABILITY AND NOTICE OF PUBLIC HEARING FOR THE FINAL ENVIRONMENTAL IMPACT REPORT FOR SIR FRANCIS DRAKE BOULEVARD REHABILITATION PROJECT

NOTICE IS HEREBY GIVEN that a Final Environmental Impact Report (FEIR) has been completed for the project identified below, and is on file with the office of the Marin County Department of Public Works, 3501 Civic Center Drive, Room 304, San Rafael, California, and is available for public review between the hours of 8:00 a.m. to 4:00 p.m., Monday through Friday. The FEIR can also be accessed online at https://www.marincounty.org/depts/pw/divisions/transportation/transportation/sir-francis-drake-boulevard-rehabilitation. All relevant documents incorporated into the EIR by reference are also available for public review at the Department of Public Works Office.

Sir Francis Drake Boulevard (SFDB) is an east-west arterial roadway going from Interstate 580 in eastern Marin County to the Point Reyes lighthouse. The portion of SFDB to be rehabilitated is a two-mile segment between U.S. 101 and the Ross Town limits.

The project proposes several traffic flow, pavement, and safety improvements, as well as water main replacement and installation along Sir Francis Drake Boulevard between Highway 101 and the Ross Town limits. Proposed improvements include:

- Intersection geometric modifications, including adding or reconfiguring turn lanes
- Modernization of traffic signals, phasing, and synchronization in the corridor
- Striping modifications to increase circulation efficiency
- Sidewalk widening, school connectivity improvements, and crosswalk enhancements.
- Replacement and installation of water supply mains in portions of the corridor in conjunction with Marin Municipal Water District (MMWD)
- Accessibility improvements compliant with the Americans with Disabilities Act (ADA)
- Installation of drainage improvements and conduits for future projects, including adaptive signal controls and a fiber optic spine for data transmission

Construction is planned over two spring-to-summer periods to minimize traffic impacts during construction. Specific details of the project are provided online at http://www.marincounty.org/depts/pw/divisions/transportation/transportation/sir-francis-drake-boulevard-rehabilitation.

NOTICE IS HEREBY FURTHER GIVEN that this Notice of Availability of the FEIR commences a 14-day public review period beginning on Monday, March 26, 2018. Interested persons are invited to review and comment on the FEIR. Written comments on the FEIR must be submitted to the Department of Public Works, PRIOR TO THE CLOSE OF THE PUBLIC REVIEW PERIOD, NO LATER THAN 4 p.m., Monday April 9, 2018. Commenters are advised to mail written comments postmarked on or before April 9, 2018 to the attention of Dan Dawson, Principal Transportation Planner at Box 4186, San Rafael, CA 94913-4186. Comments can also be submitted via email to sfdrakeimprovements@marincounty.org before the end of the comment period deadline. <a href="mailto:Comments received after the April 9 deadline will be forwarded to the Board of Supervisors for their consideration as public comment for the May 8 public hearing on the FEIR.

The Final EIR finds that the projects would result in significant or potentially significant environmental impacts related to topical issues #3, 5, 6, 7, 9, 10, 11, 13 and 14 and recommends the implementation of feasible mitigation measures to either avoid or reduce to a level of insignificance the identified environmental impacts. The EIR finds that the proposed project would not result in any significant unavoidable cumulative impacts.

A public hearing by the Board of Supervisors for certification of the FEIR is scheduled for Tuesday, May 8, 2018.
