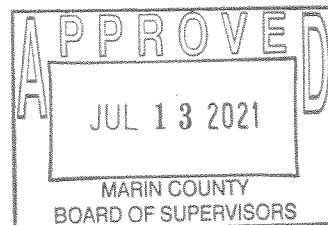

**SUBJECT:** Traffic Resolution Establishing Parking Fines for Muir Woods Road, Muir Beach, Stinson Beach, and Bolinas areas

Dear Board Members:

**RECOMMENDATION:** Adopt the Traffic Resolution Establishing Parking Fines for Muir Woods Road, Muir Beach, Stinson Beach, and Bolinas areas.

**SUMMARY:** Your Board has previously adopted no parking zones in Stinson Beach, Bolinas, Muir Beach and along Muir Woods Road through Marin County Code Chapter 15.33, and established fines of \$99.00 for violations. Traffic Resolution 2078 set the penalty at \$99.00 and included parts of Terrace Avenue and Park Avenue in Bolinas by including Resolutions 1055 and 1044. The Bolinas Fire Protection District has recently recommended the locations in Resolutions 1055 and 1044 as fire lanes. Fire lanes by Traffic Resolution 2057 have a higher penalty of \$163. This traffic resolution removes the Terrace Avenue and Park Avenue locations (covered in Resolution Numbers 1055 and 1044) in Bolinas from the \$99 penalty.

**TRAFFIC RESOLUTION NO. 2145  
RESOLUTION OF THE MARIN COUNTY BOARD OF SUPERVISORS  
ESTABLISHING PARKING FINES FOR MUIR WOODS ROAD, MUIR BEACH, STINSON  
BEACH, AND BOLINAS AREAS**

**WHEREAS**, Marin County Code Chapter 15.33 establishes no parking zones and authorizes the Board of Supervisors to establish fines for violations thereof for Muir Woods Road, Muir Beach, Stinson Beach, and Bolinas areas; and

**WHEREAS**, Traffic Resolution No. 2078 establishes \$99.00 fines for parking violations for Muir Woods Road, Muir Beach, Stinson Beach, and Bolinas areas; and

**WHEREAS**, Traffic Resolution No 2078 included parts of Terrace Avenue and Park Avenue in Bolinas which have been recommended as fire lanes by the Bolinas Fire Protection District; and

**WHEREAS**, Fire lanes by Traffic Resolution 2057 have a higher penalty of \$163; and

**WHEREAS**, the Board of Supervisors desires to delete the Terrace Avenue and Park Avenue locations (covered in Resolution Numbers 1056 and 1044) in Bolinas from the \$99 penalty.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Marin that parking fines for violations of the Marin County Code and Traffic Resolutions shall be established as set forth herein:

<u>Section</u>	<u>Fine</u>
1. Marin County Code Section 15.33.030 Stinson Beach Parking	\$99.00 (Ninety-Nine Dollars)
2. Marin County Code Section 15.33.031 Muir Beach Parking	\$99.00 (Ninety-Nine Dollars)
3. Marin County Code Section 15.33.032 Bolinas Parking	\$99.00 (Ninety-Nine Dollars)
4. Marin County Code Section 15.33.033 Muir Woods Road Parking	\$99.00 (Ninety-Nine Dollars)

The fines established herein supersede any previous established fines for any violation set forth herein. Traffic Resolution No. 2078 is hereby repealed.
