2021 Road Sealant Project, Phase 2
County Project No. 2021-09

Dear Board Members:

RECOMMENDATION: 1) Approve plans and specifications; 2) Direct the Clerk to advertise the Notice to Bidders on July 20 and July 27; and 3) Authorize the Clerk to call for bids to be opened at 2:00 p.m. on Thursday, August 5, 2021.

SUMMARY: The County's unincorporated road network condition has improved dramatically in the last decade due to concerted efforts to invest in our infrastructure. One of the most important aspects of managing a road network is continual investment towards preservation of recently rehabilitated roads. These types of preservation projects represent relatively low-cost improvements that prolong the effective life of roadways in good condition.

This referenced will include the application of various pavement preservation treatments that include microsurfacing, rubber cape seal and rubber chip seal on a total of 22.9 centerline miles of roadway that are beginning to show signs of weathering and light to moderate pavement cracking. The project includes various roadways in the Black Point - Green Point and West Novato neighborhoods in Novato as well as in the Point Reyes, Nicasio and Fallon / Tomales neighborhoods in West Marin.

Construction will take place during the daytime hours with traffic control measures. Ten-minute delays during lane closures, and short duration (typically 6 hours) residential road closures are expected; however, access will always be provided for emergency vehicles. Every effort will be made to provide advanced notice and minimize inconvenience to residents.

Staff has evaluated this project in conformance with the Department's multi-modal policy.

FISCAL IMPACT: There are no net impacts to the General Fund net County costs as a result of your Board's action. The engineer's estimate for this project is \$1,920,000.00. Actual project costs are unknown until the contractor bids are opened. Funding for this project is available in current year Road & Bridge Program, Fund (1430).

2021 ROAD SEALANT PROJECT: PHASE 2
County Project No. 2021-09

Project Description: The improvements for the 2021 Road Sealant Project: Phase 2 will include applying pavement preservation treatments to 22.9 miles of roadway in Novato and West Marin that show signs of weathering and pavement cracking. Project areas include Black Point - Green Point, West Novato; Lucas Valley, Point Reyes, Nicasio and the Fallon / Tomales area. One, or a combination, of the following pavement preservation treatments will be utilized on each street: Type II Microsurface, Type III Microsurface, Rubber Cape Seal, Rubber Chip Seal, edge grinding and crack-sealing.

Work shall be done in accordance with plans and specifications which may be acquired at no cost in electronic format via email download. Bidders can request bid documents by e-mailing bids@marincounty.org or by completing a **bid document request form** here: <https://bit.ly/358JICx>. The Engineer's estimate for this project is **\$1,950,000**. Bids are required for the entire work described herein. The Contractor shall possess a valid Class "A" License at time of bid submittal. A Bid Bond in the amount of 10% of the total bid amount payable to the County of Marin shall accompany the Proposal.

Pursuant to Section 1773 of the California Labor Code, the general prevailing wage rates for Marin County where the work is to be done have been determined by the Director of the California Department of Industrial Relations. These wages are set forth in the General Prevailing Wage Rates for this project, available at the Department of Public Works.
