- Additional Plan Review Fee will be due at the time of permit issuance per MCC§3.48.020(14)
- Field Inspection Fee will be due at the time of permit issuance per MCC§3.48.020(15)
- Additional fees will be required for California Environmental Quality Act (CEQA) review and determination

**8. State of California Hazardous Waste and Substances Sites List (C.G.C. § 65962.5)**
