RECOMMENDATION: 1) Accept FEMA Hazard Mitigation Grant Program (HMGP) funds in the amount \$2,301,750 for the Veterans' Memorial Auditorium Seismic Retrofit; and 2) Authorize the Director of Finance to increase Capital Improvement Fund appropriations for the Veterans' Memorial Auditorium Seismic Retrofit Project by \$3,069,000.

SUMMARY: On September 15, 2020, your Board accepted a FEMA Hazard Mitigation Grant in the amount \$248,250 for Phase 1, recommended costs incurred to complete the design of seismic retrofits to the Veterans' Memorial Auditorium. On November 10, 2021, staff completed and submitted final design documents for the project, satisfying the requirements for Phase 1.

On April 15, 2022, the County was awarded a second installment of the FEMA Grant (FEMA-4353-8-78R, CalOES-PJ0008) to provide financial support for Phase 2, construction, costs for the Veterans' Memorial Auditorium Seismic Retrofit Project. Specifically, the Phase 2 grant provides \$2,301,750, or a 75% cost share, of the total construction phase budget of \$3,069,000.

The following Phase 2 activities have been approved by FEMA for grant funding:

- Permit costs
- Project Management costs
- Bid related costs
- Construction Contract costs
- Construction Management, Inspection and Abatement Monitoring costs
- Closeout related costs

Phase 2 tasks, as outlined above, shall be completed within a 19-month timeframe, during which time FEMA will review the project's progress to confirm that it complies with the HMGP Grant Program Guidelines.

FISCAL/STAFFING IMPACT: There will be no net impact to the General Fund net County costs as a result of your Board's actions. Approval will increase Department of Public Works Capital Fund (1420) expenditure appropriations by \$3,069,000 in the Veterans' Memorial Auditorium Seismic Retrofit project (41C2103) for construction and related work on the project, partially offset through increased grant revenue for \$2,301,750, or 75% of the Phase 2 costs. The remaining 25% of the Phase 2 costs, or \$767,250, will be covered through a corresponding decrease in Department of Public Works Capital Fund Project Contingency (41CAP96991, 900010).

We approve and issue Hazard Mitigation Grant Program (HMGP) funds for the Marin County, HMGP DR-4353-008-008R, Marin Veterans' Memorial Auditorium Seismic Retrofit, Phase 2.

The total project cost for Phase 2 is \$3,069,000.00. As shown in the enclosed Obligation Report - Supplement 91, we are obligating \$2,301,750.00 for the 75 percent Federal share; the 25 percent non-Federal share is \$767,250.00. These funds are available in SmartLink for immediate and eligible disbursements. The following is a summary of the approved funding:

This HMGP project approval and obligation of funds are subject to the following conditions:

1. Scope of Work (SOW) – This grant will fund the seismic retrofit of the Marin Veterans' Memorial Auditorium located within the Marin Center Campus in Marin County, California. The grant will correct seismic deficiencies and improve the seismic performance to meet the performance objectives for State-owned buildings of the California Building Code. Seismic deficiencies will be corrected by strengthening of the roof diaphragm, adding supplemental supports, isolating concrete masonry unit (CMU) walls from the roof and improvements in connections of CMU walls to the supporting floor, and additional seismic bracing of the suspended plaster ceiling and projection booth.

- 2. Project Completion Date The work schedule included with the project application indicates that Phase 2 will take 19 months to complete. Please inform the sub-recipient that work completed after this date is not eligible for federal funding, and that federal funds may be de-obligated for work completed outside the completion date when there is no approved time extension.
- 3. Project Closeout Within 120 days of project completion, all project funds must be liquidated and final closeout documentation for the project must be submitted to FEMA. Please note the project must comply with Code of Federal Regulations Title 2, Part 200 reporting requirements at the time of closeout.
- 4. Record of Environmental Considerations (REC) This project has been determined to be Categorically Excluded from the need to prepare either an Environmental Impact Statement or Environmental Assessment in accordance with FEMA Instruction 108-1-1 and FEMA Directive 108-1-1 as authorized by DHS Instruction Manual 023-01-001-01, Revision 1. Historic Preservation Office (SHPO), and the California Governor's Office of Emergency Services.FEMA conducted a pedestrian architectural history survey to evaluate NRHP eligibility and to analyze character-defining features. By letter dated November 23, 2021, FEMA stated concurrence with a Caltrans and Marin County of Public Works study that found the Auditorium individually eligible for listing in the National Register of Historic Places. The letter also stated that the project will be consistent with the Secretary of the Interior's Standards (SOIS) and will not adversely affect the character-defining features of the Exhibit Hall building. - 18. **NEPA and Changes to the Scope of Work (SOW).** To comply with the National Environmental Policy Act (NEPA), and other Laws and Executive Orders, any change to the approved SOW shall be re-evaluated before implementation. Construction associated with a SOW change, prior to FEMA approval, may be ineligible for funding. Acceptance of federal funding requires environmental permits and clearances in compliance with all appropriate federal, state and local laws, and failure to comply may jeopardize funding.

Within their authority, the Recipient and Subrecipient must use of all practicable means, consistent with other essential policies, to create and maintain productive harmony for people and nature, and fulfill the social, economic, and other needs of present and future generations of Americans.
