Questions and comment to Marin Flood Control District 7

- **1.** Are there other residential communities in Marin County that rely on both a sea wall or levee <u>and</u> a system of emergency pumps behind the levee to provide flood protection for the community? Please list them.
- **2.** Are there other Marin communities below sea level, such as parts of Santa Venetia, (minus three feet), during high tide and storm conditions? If so, please identify the community, list elevation, levee height, and number of residences in possible jeopardy.
- **3.** In the world of priorities, who will get the grant funds first? For example:
 - a) Does the market value of the properties prevail or does the number of homes and thus residents that could be protected prevail?
 - b) Is the elevation of the protected properties taken into account?
 - c) Is Marin County in competition with other Bay Area Counties for the same kind of grant funds?
- **4.** Have you resolved the TRB access easement issue? The TRB was first built in the 1980's and the access easement didn't seem to be such an obstacle, what has happened? From the obscured view from the outside looking in, it appears to be just a case of leverage.
- **5.** Will the TRB community matching fund ballot issue be reintroduced? Losing by only two or three votes was painful to witness for such a critical project.
