## Item 5. Stinson Beach Nature-Based Adaptation Feasibility Study

Marin County's Community Development Agency (CDA) staff Leslie Lacko provided an update on the feasibility study which is looking at the possibility of encouraging dune formation in the context of climate change and sea level rise. Thus far the study has studied sediment transport and characterized some trends such as more erosion at the Seadrift end of the beach. The next public meeting will discuss alternatives.
