James Jacobs of the SASM and TCSD Board provided information on a groundwater study being pursued in Manzanita.

## <u>Item 4. Marin City People's Plan Update</u>

June Farmer provided an update on the People's Plan project at the First Missionary Baptist Church with implementation scheduled for November and announced upcoming workshops for planting landscaping.

#### Item 5. Marin City Climate Resilience & Health Justice Update

Hasani Dominoe provided an update on the project to restore the historic wetland and lagoon in Marin City. They are concerned that Caltrans highway runoff and legacy contaminants in Marin City are contributing to the community's shorter life expectancy than surrounding communities.

In response they started the We Choose to Live campaign, a youth program working with local schools – training middle schoolers on environment, pollution, watersheds and wetland restoration. The students came up with beautiful designs that they are trying to incorporate into the restoration process. On November 14<sup>th</sup> at Rocky Graham Park at 12pm there will be an unveiling of the students' designs and they will seek community input on restoration renderings.

## Item 6. Zone 3 Project Updates in Marin City

See staff report for information. The advisory board voted on the following actions for Items 6 c and d:

**Action by Board:** Recommend the District Board of Supervisors increase the Zone 3 Professional Services budget by \$50,000 for the proposed Feasibility Study for Bypass Drainage Project on Donahue with the qualification that staff come back to the Marin City subcommittee (TG, KC, KR) halfway through and give a report on feasibility.

**Action by Board:** Recommend the District Board of Supervisors increase the Zone 3 Professional Services budget by up to \$600,000 for the proposed comprehensive planning effort. If actual proposals are higher than this budget, staff will return to the board to evaluate alternative proposals that are consistent with that budget. #### Item 7. Lomita Drive

See staff report for information. JB expressed concern about impacts to the Sutton Manor drainage. Staff will follow up with JB and GL to confirm no negative impacts to drainage elsewhere before finalizing design.

**Action by Board:** Recommend the Board of Supervisors increase the Zone 3 Engineering division interfund budget by \$170,000 to pay for the section of storm drain upgrades that pass through the City.
