SUBJECT: Comments regarding two items on the Agenda for the Oct. 10 meeting of the Board

The following comments could be applicable to either or both of two items on the Agenda:

- Item 3 ("Open Time for Items Not on the Agenda") and/or
- Item 5 ("Crest Marin Pump Station Condition Assessment" 'Assessment').

Specifically for this meeting, as part of the Assessment (Item 5) or to supplement it: What could be done to reduce or remove any issues in the Creek?

As I recall, the flooding that occurred in the neighborhood around/near the Crest Marin Pump Station this past winter (2022/2023) was impacted (that is, made worse) in part due to drainage, that is blockage, issues in Crest Marin Creek ('Creek') 'up stream' from the Pump Station.

Since sections of the Creek are on public property (perhaps Marin County, in particular MC Floor Control) and on private property, I think it would be helpful to the neighbors in that area and to the entire Tam Valley community to understand:

- what entity is responsible for maintaining various sections of the stream,
- what guidelines are to be followed in order to do appropriate maintenance, and
- what assistance might be available or applied for in order to perform any approved and necessary maintenance.

Understanding roles and responsibilities is very important since sections of the Creek are on individual private properties and other sections perhaps on County property, specifically MC Flood Control (that is, 'property' designated as "Natural Waterway" on the Marin County Assessor Map).
