 Chief Hommel told the council that he had presented these last week, and there was a mistake on the actual body cams. He charged tax and only put 11 cameras on there. The difference was around \$72. Last week's quote was \$8,749.39 and this one is \$8,772 and this is for all 12 cameras. Those are the Axon 2 body Cameras. The quote for the 4 in car video cameras is \$6,780. Councilmember Porter said that I would love to see us get the body 3s but we can't afford them. Chief Hommel said the body 3s you have to buy their cloud server that is the only way you can get it. I don't know if I told yall but if you get the server they give you one terabyte of storage and then \$70 for a 100 gigs. Councilmember Porter said that is where they get you. Chief Hommel said the body 2s are good, I used them when I worked for Oakwood for 5 years, and the only problem is after 2 years the lithium batteries had to be replaced, they are \$20 apiece, and are a 5 min change out.

Councilmember Porter made a recommendation that the city purchases the body cams and in car video for the Police department so they can get back out on the road.

Councilmember Moore seconded the motion and the motion carried as follows:
