 Mayor Lofton wanted the record to note that Martinez called to say he couldn't make it.

Kyle Simmons gave a suggestion on how to blow out sludge and how to turn off and on water valves. A thank you card was received form Mrs. Culpepper.

6. Discussion and or Take Action Update MRB Group on TWDB CWSRF & DWSRF Projects

Gil told the council that he has provided them packets. There has not been a ton of change. Updates are in red, the reason there are not a lot of changes the Water Development has not move. There is still not a cleared environmental and categorical exclusion. These are holding us up. Gatesville is also being held up, as well as Hillsboro. On the CWSRF, there are no changes, they are looking at audit tracking items. Beth and Judy will get together to look over items. Mayor Lofton stated that on one item it looks like the city has not paid she wanted it clarified that the city has paid. Gill said correct, he will get a correction to the council. On the DWSFR there are no updates or changes, form the water development board on anything that has been submitted to them. Judy and Beth are putting together a tracking program to track issues. Mayor Lofton stated that she wanted the citizens to know that there is no money in holding and that the reason there is no working being done is because there has been no approval for the next steps. Gil said that is correct. We can't do anything, we are waiting on the Water Development Board. Gil said that drainage projects 1 and 2 which is in the 1st street area. And the pond area, for the clean water portion of the project, will be the first things they go after. On the water treatment side, it will be the filters, the first thing the are looking at. In attrition the pipes in the ground. In the back of the packets is a projection schedule, until we get a start date, we can't fill in the mild stones. Everything is on a state schedule. Davis stated that the citizens thought the city was given a 10 million lump sum at one time. Gil explained the city

citizens. The city also has the authority to issue tax notes, which do not require a citizen vote, but are limited to a 7-year term. These are backed by the ad valorem taxing authority of the city. The CO can be issued for up to 40 years, you don't want eh term to outlast the materials. If you would like to put it to the citizens, they can vote on the tax rate to fix the roads, this is a council decision. He had suggested that you want streets that last you go with concrete. He had given the suggestion of smaller tax notes, they will allow you to address the most urgent need. The next year you can issue another and work on another street. You need to fix the utility infostructure before the streets. You can go to the citizens for a big bond or just do smaller ones. The process of tax bonds was explained. If the city does a election that the work might not start till July of August, it is all a matter of timing. Other cities and how they had roads fixed was discussed. The amount it would take to fix roads was discussed. There was an engineer analysis done on some roads, it was presented to the coucnil at a previous meeting. There were town hall meetings on the subject. A survey of the streets would produce a study to decide on the streets that are most beneficial. Not giving the citizens a choice is why it came back to the coucnil. Funds were discussed. The drainage project will fix some streets. The debt ratio has to be looked at when going for matching grants. Temporary fixes will not fix the problem.

Councilmember Porter motioned to table Resolution 21-002 calling for a bond election. Councilmember Henderson seconded the motion and the motion carried as follows:

10. Discussion and or take action CWSRF Project 2 #73868 documents for additional loan amount

Cedric told the coucnil that James had stated that the project would add an extra hundred thousand a year to the city debt, it is a 30-year note. The money being put back can be used to pay the project. If it was by tax, the city could go up an extra 3%. This would put the city at a million in payments a year. But in a year, it would drop bac down since a previous project would drop off. The city revenue is up. The possibility to put in an interest baring account was discussed. The history of the 5% account was revisited. The first payment would not be due till a year after issuance. The forgiveness and interest was discussed.

Mayor Pro-Tem Milton moved that a workshop be set up so that they could discuss the CWSRF Project 2 #73868 documents for additional loan amount, on the next scheduled cournil meeting in April and come in an hour prior or an hour and a half prior to the regular scheduled meeting, around 4:30.

11. Discussion and or take action Mitamura & McMullen Bill
Dave Mitamura told the council read a prepared statement. They accepted the project
2 years for a 404 permit. Not all cities are successful in getting the permit. He gave

expenses. They will help compile a project list. Their fee is covered 100% within the funds as admin cost, for reimbursement. Individual citizens would have to submit their own, they can provide support. Other programs to help citizens were discussed. The Deadline is April 23rd, for the application. 100% of the cost of working with them is covered. If it cost \$1,000 you have to pay upfront, but you get the money back at 100%. City Attorney Parker looked at the contract, he had some comments and recommendations over. On the contract there needs to be a clear scope. There needs to be some clean up and rate sheets need to be attached. Brandy, said that it was written that way because they didn't want to be subjected to a cretin scop, they want it to be broad. Other cities they have worked with were mentioned. The city attorney has spoken with Oncor attorneys. This is not a monthly contract; we only pay for the services rendered. If Oncor covers the cost, then we let FEMA know, and they determine how to handle the mitigation. Budget questions were asked. They will file with the insurance first and when insurance denies then FEMA will take over.

Mayor Pro-Tem Milton moved to approve the contract with Brandy Brown and Associates, for providing emergency management / disaster recovery services.

The Hospital has a COVID clinic and there is info on their web site. The groups that the shots are available to were reviewed. If employees are interacting with the public, they need mask, those who are vaccinated do not have to wear one.

15. Discussion and or Take Action Notice of right of first refusal on property 503 FM 147. This is over the Amory outside of town. Gene Brown told the coucnil that the city has first right of first refusal. He plans to use the facilities to produce his wind turbines, he is looking for grants to help, but he would like the chance to purchase the property. He has backers for his project. James said that the city has the right to the property and purchase the property, it is not known why the city has not been involved before in the sale. The city has 45 days to accept, to purchase, they can let the 45 days run out, or they can waive the 45 day and exercise the right of refusal.

Councilmember Henderson motioned to waive the 45 days and refuse the property 503 FM 147.
