

RESOLUTION NO. 21-024

A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF MARLIN, TEXAS, CASTING THE CITY OF MARLIN'S VOTES FOR CANDIDATES TO SERVE ON THE BOARD OF DIRECTORS FOR THE FALLS COUNTY APPRAISAL DISTRICT; AND PROVIDING FOR EFFECTIVE DATE AND OPEN MEETINGS CLAUSES.

WHEREAS, under Section 6.03 of the Texas Tax Code, the City of Marlin ("City") is entitled to cast a vote for one or more candidates to serve on the Board of Directors of the Falls County Appraisal District; and

WHEREAS, the City Council for the City of Marlin ("City Council") adopts this Resolution casting the City Council's votes on behalf of the City of Marlin for candidates to serve on the Board of Directors for the Falls County Appraisal District;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARLIN, TEXAS:

Section 1. City Council Vote for Candidates to Serve on the Board of Directors. The City Council, by and through this Resolution, casts the City's ballot containing the City's votes for the candidate or candidates for the Board of Directors for the Falls County Appraisal District, as set forth in the attached *Falls County Appraisal District Board of Directors 2022-2023 Ballot*.


Section 2. Effective Date. This Resolution shall take effect immediately upon its adoption by the City Council and its publication as required by the Texas *Local Gov't. Code*.

Section 3. Open Meetings. That it is hereby officially found and determined that the meeting at which this Resolution is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapt. 551, *Tex. Gov't. Code*.
