6. Workshop with Public Facilities Investment Corporation for a discussion of financing the construction of street and multi-housing projects in the City.

PFIC presented the council with information on Street and Housing Projects. Multi-Housing Project

- Need study will be done (by a third party)
- 100-150 units(determined the study)
- The city can manage or
- hire a management company to manage,
- \$160,000 A UNIT, a total of \$20 million for the project
- 7-9 acers in needed
- The financing can be stretched for 30 years, average payment would be \$1,179,034 a year and an interest rate of 3.58%

Next step would be contracting for design, financing, and management. Interest rates depend on inflation. The land is free and clear, when the lease is paid. there would be no payments due until construction is finished It would take 5months on designing, 20-24 months for construction.

Street project

- · A road study would be done
- Will work with yearly city expenditures on road repairs
- Project will include engineering, construction, and financing
- Will update PMS and use GIS to create a support for PMS
- The project can cost from 10 million -30 million
- Payments would be for 30 million, at 30 years payback, \$1,765,200 a year.

A "how to maintain" would be provided to city staff. A phase one planning was provided.

The City Attorney has some concerns. He will need to look at the contract, it will need to be reviewed for wording on terms. If there is any dealing with a state entity there are certain requirements. City Manager stated that the company will send over the contract, the city attorney will review, and the council will reconvene. Attorney Parker said council can take action and make it conditional on legal review. If there are legal issues then it can be brought back to council if there are questions.
