

7. Conduct Public Hearing on Tax Increase (proposed tax rate) for the City of Marlin for FY 2022 2023:
  - a) Speak in favor
  - b) Speak in opposition
  - c) Questions by citizens
  - d) Close public hearing
8. Discussion and or Take Action: Approval of the M&O (maint. and oper.) Component of the Tax Rate of .78544 per \$100.00 of taxable valuation of property.
