1. Call to order – JW

- a. Meeting took place in the upstairs office at the Mebane Arts and Community Center and was called to order at 6:02pm
- 2. Approval of minutes JW
 - a. J.W. asked if anyone had any changes to the meeting minutes
 - b. J.W. asked to have members approve both sets of meeting minutes, previously, there was not a quorum to approval the February meeting minutes.
 - c. T.D. made motion to approve the meeting minutes from the February and March meeting minutes
 - i. $J.W. 2^{nd}$
 - ii. All in attendance approved.
- 3. Updates from Council Meeting A.D.
 - a. A.D. mentioned that both the Mebane Trail Rangers (MTR) and Triangle Off Road Cyclists (TORC) MOUs were approved by council
 - i. A.D. also mentioned that both Sherri Seagroves from MTR and Matt Engwall (TORC) were present at the meeting.
 - ii. A.D. mentioned that there were few questions, and the two representatives were not needed to speak on the matter.
 - b. A.D. brought up the mentions of the Juneteenth holiday from the council meeting. He mentioned that the city was considering making it a paid holiday for all leaders.
 - i. A.D. mentioned that he was asked how the Juneteenth event would fit into the equation, to which he replied that he wanted to discuss the options with the planning committee for the event.
 - ii. A.D. mentioned that since the council meeting, he brought this up to the planning committee and they would like the event to take place on the Saturday BEFORE the actual holiday.
 - iii. A.D. lastly mentioned that this would be a council item for the next meeting in May.

4. Budget Update – A.D.
