- i. Sent it to between 4,800-6,800 residents.
 - ii. Once we get a certain number of responses that will be released to the general public.
 1. Data sets
 - a. Original Postcard Survey Group
 - b. General Public Survey Group

 - iii. Concern about postcards getting lumped in with Election mail and therefore maybe getting tossed and not responded to. – E.P.
 1. That concern will be mentioned to our consultants. – A.D.
 2. This survey should go into November. – A.D.

4. Cates Farm Grant Opportunity Update – A.D.
- a. At last month's Council Meeting there was a budget amendment to increase fund balance for Cates Farm Park now at about \$1.2 million.
 - i. A that same meeting we also asked for council's blessing to apply for a grant.
 1. Accessibility for Parks Grant
 - a. For this grant we need to present to several stakeholders including boards and commissions, outside groups as well as the general public.

- a. \$10 million being allocated for this grant
 - b. Spoke with our Representative and she mentioned there were not that many technical reviews, hopefully that means there are not that many applicants.
 - c. This is a 5 to 1 match grant; we are looking at about \$450,000 with about \$75,000 for our match
 - d. Apply by November 1 and will hear back in early 2023
 - i. That timeline might allow for the project to be completed in entirety before grand opening
 - e. Selection based on a universal design (ADA accessible and inclusive)
 - f. Phase 1 will include parking lot, entry way, shelter, paths, and part of the playground (4 towers, interconnecting bridges, sky hammock, other play elements and wheelchair swing).
 - g. Shared pictures
 - h. Phase 2 will include zipline, 5 more towers, connection to subdivisions and further connect paths to other parks (Lakes Michael, Mebane Community Park)
 - i. Subdivisions would build paths and then city would maintain them
 - i. Likes the design of the playground and that it is inclusive for all – T.D.
 - j. Trail rerouting has already begun
