 - Sherri Wendy Day and I went to Lake Michael to look at the Lantern Festival setup. May need some help getting it ready from a safety perspective. Wrap up the hose, and take down leaves.

1. Sherri obtained a Rec and Parks Month proclamation for the July council meeting. Aaron will invite the full-time employees to the meeting.

4. Budget Updates
