Discussion on Proposed Mebane Tax Increase

Proposed 3% tax increase to fund the fire station, police facility, and recs and parks project with a pool; Committee discussed ways to solicit feedback from the community.

Tax increase will not affect the members of the ETJ.

Impact will be different for Alamance and Orange county properties; actual tax impact very nuanced. REAC highlighted the fact that the tax increase is the type of decision that the City Council should have used the Racial Equity Assessment to review and discuss.
