Sealed Bids for the construction of the indicated project will be received by Kyle Smith, PE, Public Utilities Director for the City of Mebane, at which time the Bids received will be publicly opened and read at that time and location by the City of Mebane. All Bids submitted shall include one original set of Bid Documents including all required documents listed in Section 00 20 00 – Instructions to Bidders.

The Work is located at 1420 South Third Street Extension, Mebane, NC, 27302. The Work consists of the following:

- Construction of a 1.0-million-gallon elevated water storage tank and miscellaneous appurtenances.
- Construction of all other site, access road, and utilities improvements in the Contract Documents.

The Work will be partially funded by a grant from the Economic Development Administration (EDA), in the amount of \$2,000,000, and shall be subject to all regulations and statutes of that program. The EDA Award Number is 04-79-07717.

Bids will be received for a **SINGLE** prime Contract. Bids shall be on a **LUMP SUM BASIS** as indicated on the Bid Form. The Contract Times for the Work are set forth in the Agreement.
