Ms. Kohli presented the minimum qualifications and selection procedures for the Recreation Operations Coordinator. This position will help coordinate day camps and the traveling playground.

Ms. Kohli presented the minimum qualifications and selection procedures for the Finance Clerk in the Finance Department. The Finance Clerk position will cross train in accounts payable, tax and water billing.

A motion was made by Mr. Grainger, seconded by Mr. Gilkison to approve the minimum qualifications for the Finance Clerk in the Finance Department. Motion carried.
