Mayor/Chair Dutrey congratulated the Montclair High School (MHS) boys' water polo team for making it to the California Interscholastic Federation (CIF) Southern Section play-offs; announced the 2020 General Plan Update will be considered by the City Council on December 2nd; advocated for the Council of Governments of the San Bernardino County Transportation Authority (SBCTA) to assist with cooperative efforts between cities on the NPDES permit issue discussed this evening; reported that landscaping along the I-10 freeway ramps should be completed in 2026; spoke on the passage of Proposition 36; and wished all a Happy Thanksgiving.

- 1. Council Member/Director Martinez reported she was proud to serve as a panelist at a recent **Girl Scouts** event at **Montclair Place** alongside **Assembly Member Blanca Rubio** and a criminal judge from West Covina, where topics of discussion included women working in male-dominated fields.
- 2. Mayor Pro Tem/Vice Chair Johnson commended MHS seniors for displaying professionalism at mock interviews held during the school's *Ready-to-Launch* program, which prepares students to enter the workforce as "Junior Executives"; and reported her attendance last week at the National League of Cities annual conference in Florida.
- 3. Council Member/Director Lopez relayed resident complaints of heavy diesel trucks traveling on Monte Vista where it's not permitted, thanked staff for hanging lighted Christmas decorations on light posts around the City; and wished everyone a happy Thanksgiving, acknowledging active-duty members of the military and public safety workers who are unable to come home and spend the holiday with their families.
- 4. Council Member/Director Ruh commented on the election; reported that California is losing young adult residents under the age of 30 due to the high cost of living and home prices in the state; and spoke on the history of the federal proclamation of the Thanksgiving holiday.
