Mayor Dutrey announced this as the time and place set for a public hearing on the above listed matters and requested a staff presentation prior to the acceptance of public comments and consideration by the City Council.

Community Development Director Diaz provided an overview of the history, efforts, and actions taken in preparation of the 2020 General Plan Update (GPU), which began in 2018. He also discussed the mandated elements required by state law.

Kaizer Rangwala, President, **Rangwala Associates**, summarized the public participation efforts throughout the process of developing the GPU and the contents of each chapter of the document.

Greg Martine, Planner, **Rincon Consultants**, discussed the Environmental Impact Report (EIR) and CEQA analysis for the GPU.

Kaiser Rangwala reviewed the proposed Arrow Highway Mixed-Use District Specific Plan (AHMUD Specific Plan) and Corridors Code, and

discussed how they relate to the GPU.

Erika Linard, Project Manager, **Rincon Consultants**, discussed the proposed Climate Action Plan and its relation to the GPU.

Council Member Lopez requested clarification on the project alternatives in the Environmental Impact Report, questioning why the "no project" alternative provides fewer new units.

Special Counsel Alisha Winterswyk of Best Best & Krieger indicated that the City is required to evaluate alternatives to mitigate the substantial environmental impacts identified in the EIR. She noted that a "no project" alternative suggests that fewer new units would be built under the current more restrictive zoning regulations.

Council Member Ruh questioned the four percent waste reduction goal in the Climate Action Plan, and how the City could reduce water consumption.

Erika Linard suggested that the City's contracted waste hauler could be assigned the responsibility of diverting waste from landfills. She also noted that water consumption could be reduced through policies that promote drought-tolerant landscapes and water-efficient appliances.

At 9:03 p.m., Mayor Dutrey called for a brief recess.

The meeting was reconvened at 9:08 p.m., with all Council Members present.

City Attorney Robbins advised that, pursuant to the Political Reform Act, certain members of the City Council must recuse themselves from the discussion and consideration of specific segments of the aforementioned items due to disqualifying financial conflicts of interest related to real property. She clarified that a disqualifying financial interest in real property includes ownership or an interest in any property located within 1,000 feet of the plan areas or their segments. Additionally, she advised that if a quorum of members without conflicts for a particular segment of an item is not present, those with conflicts will draw straws to determine who can be requalified, thereby ensuring a quorum for participation in discussions and votes on each item or segment thereof.

She advised that staff has divided the matters into segmented discussions to facilitate the disqualification, requalification, discussion, and voting process.

- 2. Mayor Pro Tem Johnson: proximity of her personal residence.

- 3. Council Member Lopez: proximity of his personal residence, which is owned by his parents.
- 4. Council Member Ruh: proximity of his personal residence.

The four disqualified participants drew straws to establish a quorum, resulting in the requalification of Mayor Dutrey and Mayor Pro Tem Johnson to participate in the discussion and vote related to the proposed changes to the Land Use and Official Zoning Maps within the 2020 General Plan Update and related components of the EIR.

At 9:13 p.m., Council Members Lopez and Ruh were recused from the meeting.

Council Member Ruh noted mandating healthy food establishments would contribute to gentrification and price out low-income families.

Kaizer Rangwala advised the General Plan serves as guidance for the City Council, and does not implement regulations. He emphasized that focus groups with residents and stakeholders in the community

overwhelmingly voiced support for more options of healthy food establishments.

Mayor Dutrey stated if there is no opposition from the City Council, he will make a motion to adopt the General Plan with the removal of A5.1a and A5.1b.
