D. Mayor/Chair

Mayor/Chair Dutrey acknowledged the holidays and causes observed in April and announced the recent appointment of Carrie Schindler as Executive Director of the San Bernardino County Transportation Authority (SBCTA). He advised of potential bus service disruptions due to ongoing negotiations between Omnitrans and its bus operators. Additionally, he reported that during a recent Inland Empire Utilities Agency (IEUA) Sewerage Program Policy Committee meeting, which he attends as a representative for Montclair, the Committee did not take action on making a recommendation to the IEUA Board regarding a proposed 18 percent sewer fee increase over two years. He also noted his upcoming trip to Europe will result in his absence from the next meeting, and he requested tonight's meeting be adjourned in memory of Mary Fondario, a former Community Activities Commissioner from when the Commission was called the "Community Action Committee".

E. Council Members/Directors

1. Council Member/Director Ruh expressed his apologies for missing several City events due to work-related travel. He provided an update on the Gold Line's construction to Montclair, noting the bids came in 50 percent over the estimated cost, which led to the Construction Authority's decision to re-bid and delay the project. He also acknowledged the 70th anniversary of the Polio Vaccine's approval on April 12, 1955, and commented on California's robust economy and its status as a net donor state for the federal government in response to recent remarks referring to the state "Cali-Failure".

- 2. Council Member/Director Lopez .announced his attendance at the Firefighter Recognition Luncheon and congratulated Firefighter of the Year **Zachary Granzow**. He commended the Montclair Police Department for participating in the Baker to Vegas run in collaboration with the Upland Police Department and thanked staff for securing a second school crossing guard at the Benson Avenue and San Bernardino intersection.
- 3. Council Member/Director Mendez recognized the Firefighter of the Year and reported his attendance at the Ontario State of the City event. He also congratulated his son Wyatt and daughter-in-law Maya on their recent wedding ceremony.
- 4. Mayor Pro Tem/Vice Chair Martinez encouraged residents to volunteer at the next C.A.U.T.I.O.N. Clean Up event on May 17, from 8:00 a.m. to 12:00 p.m. at the alleyway between Kingsley and Bandera Streets.
