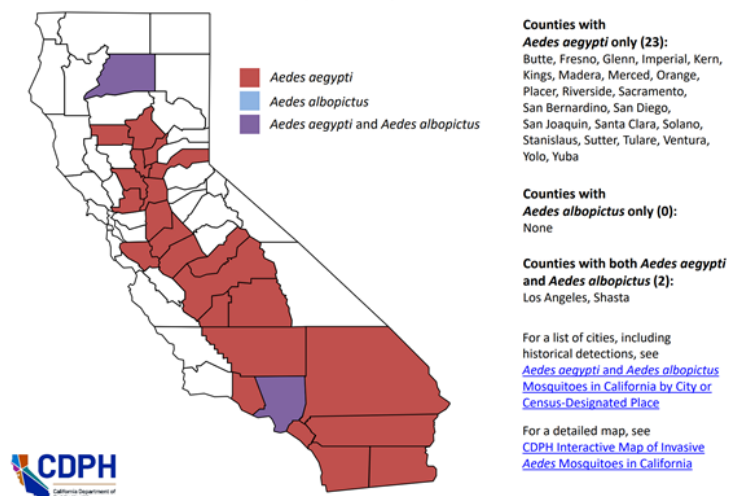

- West Valley Mosquito Vector Control District Takes Bite Out of "Ankle-Biter" Mosquitoes**

For the first time in a decade, the West Valley Mosquito Vector Control District (WVMVCD) and [California Department of Public Health, Vector-Borne Disease Section](#)¹ report a drop in "ankle-biters," more formally known as the *aedes aegypti* mosquito, or Aedes. According to the WVMVCD, a pilot program aiming to reduce the invasive mosquito population in Southern California seems to be working, making for a notable decrease in the nuisance so far this year. The program [releases millions of sterilized mosquitoes](#)² into troubled areas, as indicated in the below chart:

In some especially dense areas in San Bernardino County, the Aedes population has dropped by 44%. In the Tujunga area of Los Angeles County, the Greater Los Angeles County Vector Control District reports a [decline of 82%](#)³. Other vector agencies in the state are now looking to duplicate the reductions seen in the Inland Empire and Los Angeles County.

The Aedes mosquito, originally located in tropical climates, have been found on nearly every continent in the world, and are believed to have arrived in California just over a decade ago via cargo ship. From there, they [migrated in mass to the Southland](#)⁴, spreading throughout the San Fernando Valley, Inland Empire and San Diego.

The Aedes is small and black, covered with white stripes on their legs and body, enjoys shady spots, and can breed with a minimal amount of water. Aedes are also notably more aggressive than other mosquitos, preferring to bite humans over other mammals or birds, and their bites can go through clothing. The mosquito often strikes rapidly and in succession, instead of just once, and does not stick to the traditional early morning/early-evening habits of other mosquitos-instead; they are on the hunt throughout the day.

Aedes are poor fliers, giving rise to the "Ankle-Biters" nickname-the majority of their bites are on the lower leg because they hover just above the ground. The Aedes has been known to transmit diseases like yellow fever, dengue and Zika, but it is not linked to the West Nile Virus. The mosquito is also resilient to many common pesticides.

Male mosquitos raised in a lab are zapped with X-rays, making them sterile and unable to bite or spread disease. Released into the wild, the sterile males mate with female mosquitos, and any sperm she collects is then stored for all of her batches of eggs, making the eggs not viable

- **State Proposes Model Ordinance for Clearing Encampments.**

On May 12, 2025, the Office of Governor Gavin Newsom released a [model ordinance](#)⁵ for cities and counties to use as the basis for clearing encampments of homeless persons. Provisions in the ordinance would make it illegal for a person to do the following:

- Build or maintain semi-permanent structures on public property;
- Camp on the same public property for three consecutive days or nights, or within 200 feet of a notice prohibiting such activity; or
- Sleep, lie or camp on a sidewalk in any way that obstructs traffic.

The request by the state for local agencies to adopt the ordinance follows last year's [Executive Order N-1-24](#)⁶ directing state agencies, including the California Department of Transportation (Caltrans), to remove encampments. Caltrans reportedly spent more than \$51 million addressing encampments in Fiscal Year 2023-24. Nonetheless, city officials often contend that [Caltrans takes too long to sweep a camp](#)⁷, at times taking months to respond.

Local government employees are currently prohibited from entering onto Caltrans property in their jurisdictions to clear camps themselves. To address this issue, the State Legislature is considering a bill that would make it easier for [Caltrans to cooperate with local governments](#)⁸. The measure would require Caltrans to hire a liaison to work with cities and counties, and to arrange clear timelines when Caltrans should respond to a city's request to clear an encampment. It would also allow Caltrans to reimburse cities for when they use their own resources and personnel to clear encampments on Caltrans property. By some estimates, it can cost up to \$10,000 to clear and secure an encampment.

A number of cities also cite lack of state coordination as a barrier to removing encampments on state property. The League of California Cities is [co-sponsoring legislation](#)⁹ to increase communication and coordination between state agencies and cities when addressing encampments on state property.

Adoption of the state's model ordinance would require local government officials to "make every reasonable effort" to provide shelter to people living in homeless encampments and, except under exigent circumstances, provide 48-hours written warning before clearing encampments.

Following the U.S. Supreme Court decision in *City of Grants Pass v. Johnson* (06/28/2024), [which gave the green light to local governments to arrest people for sleeping in public](#),¹⁰ even when there are no shelter spaces available for them, Governor Newsom started applying pressure on local governments to proactively address homelessness in their communities. His first step was to issue [Executive Order N-1-24](#)¹¹, declaring that [California cities had "no more excuses" when it comes to removing homeless encampments](#)¹². The proposed model ordinance is the next step in that evolution.

According to a [League of California Cities Fact Sheet](#)¹³, eight in 10 cities already have policies in place to address homeless encampments, and nearly 40% of cities recently updated their local ordinances to align with Executive Order No. N-1-24. Montclair does have a camping ordinance (Chapter 6.25 of the Montclair Municipal Code); however, the ordinance does not address the standards promoted in the state's model ordinance. City staff will review the model ordinance for appropriateness and applicability for the Montclair community.

Some cities, like [Riverside](#)¹⁴, have adopted anti-camping ordinances that are more strict than the model ordinance proposed by Governor Newsom. Riverside's ordinance calls for a 24-hour notice ahead of encampments being cleared, and it blocks camping near schools or shelters and bans camping in parks. However, homelessness remains for Riverside because, according to Riverside officials, an estimated 95% of unhoused persons refuse services.

In addition to promoting a model ordinance for the clearing of encampments, [Governor Newsom](#)¹⁵ has announced that the state would release \$3.3 billion to "communities statewide"

to combat homelessness. The money comes from the \$6.4 billion [Proposition 1](#)¹⁶ funds that voters approved in March 2024.

Proposition 1 requires that approximately two-thirds of a 2004 voter-approved tax on millionaires be spent on housing and drug treatment programs for the homeless. According to the [California Department of Health Care Services](#)¹⁷, the Proposition 1 funds are scheduled to go to 124 projects across California, including 214 facilities, adding more than 5,000 residential treatment beds and more than 21,800 outpatient treatment slots.

In San Bernardino County, the San Bernardino County Department of Behavioral Health is designated to receive funding for an Adult Residential Substance Use Disorder (SUD) Treatment Facility with Incidental medical services with Level of Care 3.5 Designation only. Level of Care 3.5 Designation refers to Clinically Managed High-Intensity Residential Services. It is one of the designations used for different levels of care in the context of addiction treatment.

The Department of Health Care Services (DHCS) is required to adopt the American Society of Addiction Medicine (ASAM) treatment criteria, or an equivalent evidence-based standard, as the minimum standard of care for licensed adult alcoholism or drug recovery or treatment (AOD) facilities. DHCS has adopted the ASAM treatment criteria as the standard of care required of all licensed residential AOD facilities as follows:

- DHCS Level 3.1 – Clinically Managed Low-Intensity Residential Services;
- DHCS Level 3.2 – Clinically Managed Residential Withdrawal Management;
- DHCS Level 3.3 – Clinically Managed Population-Specific High-Intensity Residential Services; and
- DHCS Level 3.5 – Clinically Managed High-Intensity Residential Services.

All licensed AOD facilities must obtain at least one DHCS LOC Designation and/or at least one residential ASAM LOC Certification consistent with all of its program services.

In addition, the San Bernardino County Department of Behavioral Health is also designated to receive an office-based Outpatient Treatment and Community Wellness Center, Psychiatric Residential Treatment Facility, and Adolescent Residential SUD Treatment Facility. Together, the programs will provide a total of 84 beds serving 900 people annually. Specific dollar amounts have not yet been announced.

- **2025 Point in Time Count for San Bernardino County Shows Decline in Homeless Residents.**

According to the 2025 Point in Time Count for San Bernardino County, released on May 15, 2025, for the first time since 2017, the County saw a drop in the number of residents experiencing homelessness. The number of homeless residents counted in January's Point in Time Count was 3,821, [down from 4,255 in 2024](#)¹⁸, representing a drop of 10.2% in one year.

The number of homeless residents considered “unsheltered”—those living on the streets, in tents or cars or otherwise without a roof—also dropped in this year’s count from 3,055 in 2024 to 2,620 in 2025. Ongoing outreach efforts and increased state and federal funding have been credited for the decrease.

Point in Time Count data is used by the U.S. Department of Housing and Urban Development to distribute funding for programs to combat homelessness and to measure the effectiveness of efforts to reduce homelessness nationwide.

Release of the data came a day after Governor Gavin Newsom [announced more than \\$3 billion in funding to fight homelessness](#)¹⁹ in California. The money comes from [Proposition 1](#)²⁰, backed by voters in 2024. Funds will go to housing and drug treatment programs for the homeless. In announcing the funding, Governor Newsom called homelessness “the crisis of our time.”

With 3,821 homeless residents, about 172 of every 100,000 residents in San Bernardino County are homeless. It is estimated that more than one-third of all homeless people in the United States live in California. Statewide, about 455 people per 100,000 California residents are homeless. The national average is 195 homeless people per 100,000 residents.

- **Do you have your Real ID?**

Starting Wednesday, May 7, 2025, a requirement went into effect for adult passengers (18 and over) to present a federally accepted identification to board domestic flights and to enter some federal facilities. However, the Department of Homeland Security announced before the May 7 deadline that travelers who are not REAL ID compliant would still be able to fly, for now, but will face extra scrutiny, including diversion to different lines for additional security evaluation.

Formulated in the wake of the September 11, 2001 terrorist attacks, [H.R.418](#)²¹, the REAL ID Act, was passed by Congress in 2005 to set standards for the issuance of sources of identification, such as driver's licenses.

The act established minimum security standards for state-issued driver's licenses and identification cards, and prohibits federal agencies from accepting licenses and identification cards for official purposes from states that do not meet these standards. The REAL ID Act was aimed at thwarting airline terrorism by increasing requirements to obtain documents that grant access to domestic planes.

State agencies that issue licenses and identification cards, such as department of motor vehicle offices, require office visits and some documents to standardize licenses under the new act. Real ID Cards also use new technology that makes them more difficult to forge.

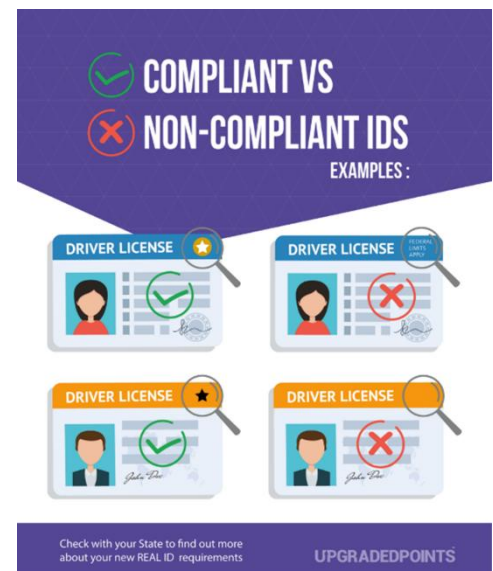
A number of roadblocks, including the COVID-19 pandemic, delayed implementation over the past two decades. The original date of compliance was October 1, 2020, which was delayed by the COVID-19 pandemic to October 1, 2021, then to May 3, 2023, and now to May 7, 2025.

Persons without a REAL ID can continue to use their regular license or identification to drive without obtaining a REAL ID or engage in other forms of U.S. travel, including driving within and across state lines or riding on a train. However, to fly domestically in the U.S., an alternative form of [TSA approved identification](#)²² will be necessary.

The change will only impact domestic travel in the U.S. To fly internationally, all passengers will need a valid U.S. passport.

In California, a Real ID driver's license features the silhouette of a gold bear, with a white star on the body of the bear. An easy way to know if an ID card is not compliant is if it says "Not for Federal Identification," "Federal Limits Apply," or "Not for Real ID Act Purposes."

The REAL ID is not a substitute for a [U.S. passport for international travel](#).²³ The only exception is when a person possesses an enhanced driver's license. Some states issue a form of REAL ID called enhanced IDs which allow land and sea border crossings to Canada, Mexico, and the Caribbean. Instead of or in addition to a star, enhanced driver's licenses feature a U.S. flag symbol on the front of the card. Enhanced IDs are not a substitute for passports for air travel, and can only be used for land or sea travel. California does not issue Enhanced IDs.

[H.R.22 \(2025-2026\), the SAVE Act](#)²⁴, which passed the House of Representatives in April 2025 but has yet to face a Senate vote, would require proof of American citizenship for anyone to register to vote in the U.S. The legislation lists REAL ID-compliant documentation as an acceptable form of identification to register to vote as long as it “indicates the applicant is a citizen.” However, this latter requirement would effectively mean that a California REAL ID would probably not be usable for voter registration under the SAVE Act.

To date, more than 18.6 million Californians are reportedly REAL ID ready, having transitioned their driver’s license or state-issued ID to a Real ID card.

Obtaining a REAL ID is not required; however, a REAL ID is required for the following purposes:

- You want to fly domestically with only a state-issued ID.
- You need to visit a secure federal facility, such as a military base and don’t have a military ID.

The REAL ID Modernization Act is designed to assist California residents to [submit identification documents electronically](#)²⁵. Applicants will, however, still need to bring documents in person to a California Department of Motor Vehicles office. California will not renew a REAL ID-compliant license if the driver’s license or ID card is renewed online.

The illustration shown above provides steps to receiving a compliant REAL ID—visit the [California DMV](#)²⁶ for additional information. Applicants with questions or concerns related to obtaining any of the required documents should check directly with a local DMV office. California provides a [list of documents](#)²⁷ necessary for obtaining a REAL ID. Federal requirements do not allow for the transfer of a REAL ID license between states. Each state is required to view and image all documentation to issue a REAL ID-compliant card.



STEPS TO OBTAIN A REAL ID

1 • Make an appointment to visit a DMV field office before your state’s deadline.

BRING TO YOUR APPOINTMENT:

2 • Proof of identity, such as a certified copy of a U.S. birth certificate, U.S. passport, employment authorization document, permanent resident card or foreign passport with an approved form I-94.

• Present **proof of your Social Security number**, such as an SSN card, W-2 or paystub with full SSN.

• Show **proof of residency document**, such as a rental or lease agreement, mortgage bill, utility bill or employment, medical or school document.

• If applicable - An original or certified copy of a **name change document**, such as a marriage certificate or divorce decree, may be required.

3 • Pay fee for license

For more information on acceptable forms of identification for boarding aircraft, visit the [TSA website](https://www.tsa.gov/travel/security-screening/identification)²⁸. However, on or after May 7, 2025, without appropriate identification, individuals will not be permitted through security checkpoint to board a flight. TSA does not require passengers under 18 to provide identification when traveling with an adult companion within the U.S. However, the companion does need acceptable identification. Airlines may demand proof of the child's age, such as a birth certificate or passport, but these requirements aren't regulated by TSA. Contact the airline for boarding information.

- **CMCA Annual Conference**

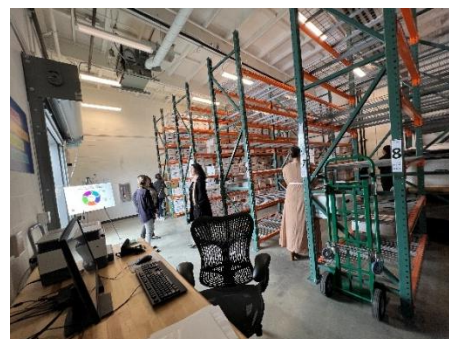
Last month, City Clerk Andrea Myrick and Deputy City Clerk Krystal Roman attended the 2025 CMCA Annual Conference in San Jose, from April 30th to May 2nd. The conference serves as a vital platform for clerks to gather, share best practices, and enhance their professional knowledge and skills.



This year's conference featured a series of workshops, keynote speakers, and networking opportunities aimed at addressing the unique challenges faced by municipal clerks in local governments. Several sessions provided an opportunity to review the impacts of legislation on the profession and learn how to leverage new technologies to improve accuracy and efficiency in the City Clerk's Office.

- **Tour of Rancho Cucamonga's New Records Storage Center**

- **Sunset Park Revitalization and Grand Opening**

Sunset Park, a cherished community space nestled between Orchard Street and Kingsley Street, has officially reopened following an extensive revitalization effort.

On May 5, 2025, the City of Montclair hosted the grand opening ceremony, drawing approximately 1,000 residents—predominantly families and children—to witness the unveiling of their newly transformed park. In her opening address, Executive Director of Engineering and Major Projects Manager Rosemary Hoerning highlighted the park's rich history and its significance to the community. She also acknowledged the ancestral stewards of the land, the Gabriellino Shoshone Tongva Nation.

Tribal leaders Marciela Castrejon and Javier Ramirez, accompanied by fellow member Jamie Rocha, shared insights into their heritage and performed a ritual song and blessing, honoring the park's reopening.

The Gabriellino-Shoshone Nation are the indigenous people of the Los Angeles Basin and the Southern Channel Islands in California. Prior to European contact, the Tongva maintained thriving villages and a rich cultural and spiritual life. Spanish colonization began in the late 18th century with the establishment of the San Gabriel Mission in 1771, which



had a profound and often devastating impact on the Gabrielino-Shoshone people. Forced labor, disease, and cultural suppression under the mission system greatly reduced their population and disrupted traditional lifeways. Despite centuries of marginalization and lack of federal recognition, the Gabriellino-Shoshone Nation continues to assert its identity and fight for land rights and cultural preservation. Today, they are active in education the public, protecting sacred sites, and revitalizing their language and traditions.

The revitalized Sunset Park now boasts state-of-the-art amenities, including:

- ADA-Inclusive playgrounds located at both the north and south ends, these interactive play areas cater to children of all abilities.
- State-of-the-art restroom facilities and picnic areas, which are equipped with drinking fountains, benches, and trash receptacles that offers comfort and convenience for visitors.
- San Antonio Creek Trail Segment is designed for bicycles and pedestrians with exercise stations and other artistic elements sprinkled along the path.
- The community fruit park's expanded grove now includes apricots, avocados, blood oranges, limes, and pomegranates, complementing the other fruit-bearing trees like avocados, cherries, figs, grapefruit, guava, lemons, and plums.

Hundreds of children had a blast enjoying different play features for climbing, swinging, spinning, and bouncing while their parents looked on from the comfort of the parks many rest areas. This project could not have been completed without funds received from the Montclair Voter Approved Local Measure "L" Sales Tax, and State partnerships to secure a Caltrans State Clean California Grant, and a State Department of Parks and Recreation Grant. With over 1.25 miles of newly lit walking paths, Sunset Park serves as a beacon of community,

sustainability, and cultural appreciation. The park's enhancements reflect Montclair's commitment to providing residents with a safe, inclusive, and enjoyable environment for recreation and connection.

The Sunset Park Beautification Project, a major Capital Improvement Project which commenced in October 2023, has been a labor of love and perseverance. Despite facing delays and funding challenges, the project culminated in a comprehensive \$8.3 million renovation, funded through the Montclair Voter-Approved Local Measure “L” Sales Tax, a Caltrans State Clean California Grant, and a State Department of Parks and Recreation Grant. This endeavor was spearheaded by Project Manager and Executive Director of Engineering and Major Projects Manager, Rosemary Hoerning.

- **Repairs Underway of Damaged Gabions in Medians**

Administrative staff at the City Yard are managing the repair of nine gabions (rock cages) located on the center medians along Central Avenue. To date, six out of nine gabions have been repaired. The remaining three are scheduled to be repaired by June.

- **Installation of New Flashing Stop Signs**

The Public Works Department’s City Yard Signs Division is in the process of installing ten new Solar Powered Flashing Stop Signs throughout the City. The tentative target date for Flashing Stop Sign installations is June 30, 2025. The new Flashing Stop Signs will be installed at the following locations:

On April 26, 2025, residents gathered at Essex Park for a morning of environmental appreciation and community service. Hosted by the City's Public Works Department, the event was led by Director Monica Heredia, who welcomed guests with a smile and a mission: to honor the importance of trees in urban spaces and promote sustainability. Held at 4295 Howard Street, Essex Park was the perfect backdrop for the annual tradition.

Lending a helping hand at the event were West Coast Arborists and Burrtec Waste Industries, who partnered with the city to hand out free goodie bags and young saplings to attendees. The giveaways were a hit with families and local green thumbs alike, offering a chance to take a bit of Arbor Day home.

The celebration wouldn't be complete without the planting of two new trees in Essex Park. Wrapped up in coats, gloves, and beanies, volunteers placed the young trees into their new home where they will provide shade for future generations.



As a result of these environmental efforts, the City of Montclair was publicly recognized by the Arbor Day Foundation as part of the Tree City USA program. The Public Works Department plans to continue its tree-planting initiatives throughout the year across various Capital Improvement Projects. The city encourages residents to stay involved in keeping Montclair beautiful.

- **Montclair Little League Opening Day Preparation**

Throughout the month of March, the Montclair City Yard crew, along with Colts Landscaping, meticulously prepared the baseball fields at Saratoga Park for Montclair Little League's Opening Day ceremonies and for the upcoming season's practices and games.



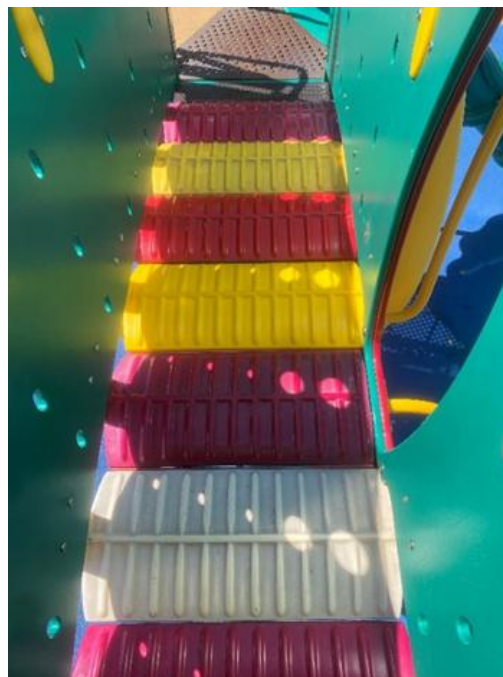
- **Playground Equipment and Padding Repair**

On March 24, the City Yard crews began installing replacement parts for playground equipment at Alma Hofman and Saratoga Parks. The dilapidated padding at Saratoga Park was also repaired by crews, ensuring a safe experience for all playground users.

- **Street Striping and Legend Refreshing**

On March 26, the Public Works Streets Division began refreshing all striping and legends on Monte Vista Ave. from Benito St. south to Holt Blvd. Crews also added raised pavement markers (RPMs) to enhance visibility to the roadway at night and during inclement weather. This was a new safety improvement in the area.



- **Civic Center Emergency Generator Update**

The City of Montclair is enhancing its emergency preparedness with the Civic Center Generator Upgrade project. The upgraded generator will provide backup power to both City Hall and the Recreation Center, which doubles as an emergency shelter for the American Red Cross during a disaster. The electrical connections for the generator were completed in the month of May. Once the contractor installs the particulate filter, facilities staff will power it up.



- **Weight Room Floor Replacement**

In the month of May, the old rubber flooring in the Community Center's weight room was removed, and the underlying concrete was sealed to prevent water intrusion. A new rubber floor was installed in a loosely fitted manner to allow for easy replacement of damaged sections and to enable evaporation in case water and moisture enters the room.

- **City Purchases New Electrical Backhoe**

On May 8, 2025, the Public Works Department received a 2025 Case 580EV Electric Backhoe Loader in compliance with the California Air Resources Board 2022 amendments to regulations of off-road diesel equipment.



The electric backhoe replaced Unit 304 PW, which has been in service for 19 years and was affected by the CARB amendments. Longtime vendor, Sonsray Machinery LLC, notified the City of a California CORE equipment voucher program that would help the City purchase a CARB compliant backhoe. The price of the 2025 Case 580EV Electric Backhoe loader was \$459,518.00 including premier warranty, freight and PDI/wash. With a 30% Sourcewell discount, the CORE voucher of \$319,000.00 and the trade in value of the 2005 Case Backhoe Loader, the total paid by the City was \$16,061.78, including tax.

This backhoe will be essential in moving material, as well as completing various street maintenance tasks including: sidewalk, curb and gutter break out and repair, and asphalt repair in City roadways. The backhoe will most importantly reduce emissions produced by City equipment.

- **Montclair Shines at APWA SoCal Event**

On March 27, 2025, Public Works Director Heredia and Associate Engineer Stevenson represented the City of Montclair at the second annual Career Fair and Scholarship Award Night hosted by the American Public Works Association (APWA) SoCal Chapter Scholarship and Young Professionals Committee.



It was an opportunity to provide students and young professionals across Southern California:

- an understanding of public works
- opportunities to achieve their educational goals
- opportunities and resources to enhance their personal and professional development and celebrate scholarship recipients

It was a fun night discussing some of the City's projects and giving out bags, brochures, pens and monkeys.

Scholarships ranging from \$2,000 to \$6,000 was awarded to high school and undergraduate students majoring in a Public Works-related fields from different universities including California State Polytechnic University, Pomona.

COMMUNITY DEVELOPMENT DEPARTMENT

- **C.A.U.T.I.O.N. Neighborhood Alleyway Cleanup**

On May 17, 2025, the City of Montclair's Code Enforcement Division hosted its annual C.A.U.T.I.O.N. Cleanup, organized by Senior Code Enforcement Officer Denise Ortiz with support from the Code Enforcement team. Originally founded by Code Enforcement Manager

Gabe Fondario, C.A.U.T.I.O.N.—*Citizens Against Unwanted Trash In Our Neighborhood*—encourages residents to take an active role in beautifying and maintaining their neighborhoods. This year's event focused on the alleyways between Kingsley Street and Bandera Street, east of Marion Avenue where volunteers came together to remove trash, clear overgrown vegetation, and paint surrounding buildings.

The strong presence and participation of the Mayor and City Council set a powerful example of civic leadership and energized the day's efforts. A total of 85 volunteers joined in, including residents, families, community members, and various organizations. Mothers participating in the event were honored in celebration of Mother's Day weekend with tote bags filled with thoughtful goodies, lovingly prepared by Chaplain Dianna Delgado, who also volunteered her time at the event. Volunteers received free event T-shirts, coffee, Krispy Kreme donuts, and pizza for lunch. The day began with an uplifting prayer from Pastor Josh Matlock of Bethany Church, who also brought a group of volunteers and helped set a positive and spirited tone for the day.

The event's success was made possible through collaboration with the City's Economic Development, Public Works, Finance, Human Services, and Police departments, including the Montclair Police Explorers, whose efforts contributed greatly to planning, logistics, and onsite support.

FIRE DEPARTMENT

- **Commercial Structure Fire at 5282 Mission Blvd**

On Wednesday April 30, 2025 at approximately 4:00 p.m., the Montclair Fire Department responded to a commercial structure fire at 5282 Mission Boulevard. Initial 911 calls indicated a possible occupant trapped inside the two-story commercial building, prompting an immediate and robust response.

Upon arrival, firefighters encountered heavy fire involvement in the northeast portion of the rear of the structure, originating from the first floor. Due to the potential for victims inside, crews launched an aggressive interior attack while simultaneously conducting a primary search of the building.



Firefighters successfully contained the fire, preventing further spread throughout the structure and preserving the majority of the building. A thorough search confirmed that no individuals were trapped or in need of rescue.

The fire caused significant damage to the affected portion of the building but resulted in no injuries or casualties. The incident escalated to a second alarm, bringing mutual aid from Chino Valley Fire District, Los Angeles County Fire Department, Ontario Fire Department, and San Bernardino County Fire Department. The cause of the fire is currently under investigation.

- **Structure Fire Contained at 5555 Vernon Court in Montclair**

On the afternoon of Saturday May 10, 2025 at 12:06 pm, Montclair Fire Department responded to a structure fire at a single-family residence located at 5555 Vernon Court. The blaze originated in the yard of the property and quickly spread to the home, threatening nearby residences.

Flames extended to the main structure and caused minor damage to the eaves of an adjacent home. In addition, fire brands carried by the wind ignited nearby vegetation, creating multiple spot fires.



Firefighters launched an aggressive and coordinated response to halt the fire's advance. Their swift action successfully prevented the spread of flames to several other homes in the area, ultimately saving multiple residences from significant damage.

The fire escalated to a second alarm, drawing mutual aid from Chino Valley Fire District, Los Angeles County Fire Department, Ontario Fire Department, and San Bernardino County Fire Department. Thanks to the joint efforts of all responding agencies, the fire was fully contained without any reported injuries or fatalities. The cause of the fire is under investigation.

ECONOMIC DEVELOPMENT

- **Montclair Recognized by American Planning Association of the Inland Empire for 2024 General Plan Update**

The Economic Development Agency and Community Development Department are pleased to announce a significant achievement in the City of Montclair's ongoing commitment to strategic community planning. On May 14, 2025, the American Planning Association Inland Empire Section (APA IES) recognized the City of Montclair with a Merit Award in the Comprehensive Plan category for its recently adopted General Plan Update. This prestigious award acknowledges excellence in planning throughout the Inland Empire and highlights the City of Montclair's dedication to creating a sustainable, resilient, and thriving future for our community.

The 2024 General Plan Update serves as the City's foundational document, guiding future development, conservation, and community enhancement efforts. Its development involved extensive public outreach and collaboration, ensuring the final plan reflects the aspirations and needs of Montclair residents, businesses, and stakeholders. The APA IES Merit Award specifically recognizes the comprehensive and forward-thinking nature of the General Plan Update.

Key elements of the award-winning 2024 General Plan Update include:

- **A Vision for a Well-Planned Community:** Strategic updates to land use designations and development standards, including the introduction of the Arrow Highway Mixed-Use District Specific Plan and the Montclair Corridors Code, aimed at fostering smart growth and reinvestment in the community.
- **Integrated Housing Element:** A robust plan to address current and future housing needs across all income levels, in compliance with state requirements.
- **Commitment to Sustainability:** A comprehensive Climate Action Plan outlining measures to reduce greenhouse gas emissions and enhance environmental quality.
- **Focus on Mobility and Accessibility:** Strategies to improve transportation choices, enhance pedestrian and bicycle infrastructure, and increase connectivity throughout the City.
- **Emphasis on Public Health and Well-being:** Policies designed to promote healthy lifestyles, improve access to parks and recreation, and enhance the overall quality of life.

The APA IES Merit Award underscores the quality and innovation embedded within Montclair's 2024 General Plan Update. It serves as a validation of the City's proactive approach to planning and its dedication to building a well-balanced community that meets the needs of both current and future generations.

The City Council and staff extend their appreciation to the American Planning Association Inland Empire Section for this distinguished honor. This award is a testament to the hard work of the Economic Development Agency, Community Development Department, consulting partners including Rangwala and Associates, and, most importantly, the Montclair community, whose input was vital in shaping this visionary plan.

- **Promoting Montclair at the International Conference of Shopping Centers in Las Vegas**

The Economic Development Agency is pleased to report on its recent participation in the ICSC 2025 conference in Las Vegas. Held from May 18-20, this premier annual event convenes over 24,000 professionals from the retail real estate and development industry across North America. ICSC provides a vital platform for the City of Montclair to connect with key industry

leaders, promote development opportunities, and attract new businesses, furthering our commitment to strategic economic growth for the community.

Staff leveraged this critical opportunity to highlight the City's strategic planning efforts and showcase its readiness for new investment. Central to the City's presentation was the recently adopted 2024 General Plan Update, emphasizing how this plan paves the way for a dynamic future.

Key areas and initiatives promoted include:

- **General Plan Update (Corridors Code & AHMUD):** Staff highlighted the Montclair Corridors Code and the Arrow Highway Mixed-Use District (AHMUD) as prime locations for investment, designed to revitalize key thoroughfares and encourage vibrant, mixed-use environments.
- **North Montclair Downtown Specific Plan:** Staff highlighted opportunities for creating a more defined and active city center, inviting investment in the City of Montclair's transit oriented district.
- **Montclair Place District Specific Plan:** Staff highlight opportunities for the ongoing development and enhancement surrounding Montclair Place, outlining its potential for continued growth and redevelopment.

Across all these specific plan areas, staff underscored the diverse growth opportunities available for retail, office, and residential development, reinforcing Montclair's commitment to creating well-rounded and sustainable neighborhoods.

To vividly illustrate that development is already underway in the Specific Plan areas, staff utilized an aerial fly-through video. This presentation showcased a variety of projects – both recently completed and currently under construction – demonstrating tangible progress and the success of the City's adopted specific plans. The projects highlighted include the Paseos, Arrow Station, Alexan-Kendry, Alexan Kendry Expansion, Marlow, Oak Mont Development Warehouse Project, Montclair Towncenter, and Holt and Amherst Strip Center.

Throughout the conference, staff engaged with numerous brokers and developers. The feedback received was consistently positive, with many complimenting the City of Montclair for its forward-thinking approach, particularly its policy of allowing mixed-use developments across various city areas. This flexibility is viewed as a significant market advantage.

Furthermore, these conversations revealed a notable market trend: In response to current economic policies, many retailers and developers are increasingly seeking properties suitable for redevelopment over new ground-up construction. This trend aligns seamlessly with the opportunities within Montclair's specific plan areas, positioning our city as an attractive destination for development and investment. We look forward to nurturing the connections made and advancing the opportunities discussed for the benefit of Montclair.

SPLASH PAD GUIDELINES

- ★ Park use is on a first-come, first-served basis. No reservations available.
- ★ Swimwear required for Splash Pad! No cotton, denim, or gym shorts allowed.
- ★ Swim diapers required for children 3 years of age or younger.
- ★ Parents must stay with children within the fencing area.
- ★ Vehicles are not permitted in the park, all loading and unloading shall take place in the parking lot.
- ★ Only Liquid Propane Gas (LPG) grills with a cooking surface of 1,000 square inches or less are permitted within the park. Grills towed behind vehicles are prohibited.
- ★ No bouncers of any kind are permitted at Alma Hofman Park, during the summer season (May 24- Sept 1).
- ★ No barbecue can be placed within 25 feet of any adjacent property, playground equipment, buildings, fences, walls, or at the Alma Hofman Park Skate Park or Splash Pad facilities.
- ★ Canopies may not be larger than 200 square feet. Canopies must be secured per manufacturer's instructions, however, in no case shall spikes be used to secure canopies. Canopies cannot be attached to another canopy or any other structure including trees, fences, etc.
- ★ Permit required for parties of 100 or more people.

**Dates and hours of operation are subject to change due to unsafe weather conditions, maintenance and repair, or drought restrictions and regulations. The splash pad will remain open until 8:00 pm on concert and movie nights.*

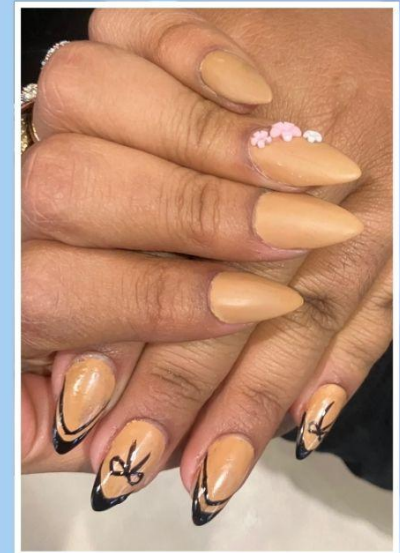

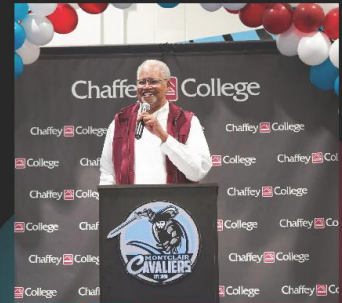
