UNITED STATES INTERAGENCY COUNCIL ON HOMELESSNESS:

The United States Interagency Council on Homelessness (USICH) was originally authorized by Congress through Title II of the landmark Stewart B. McKinney Homeless Assistance Act of 1987 (PL 100-77) to serve as an "independent establishment" within the executive branch.

The USICH is charged with coordinating the federal response to homelessness and creating a national partnership at every level of government and with the private sector to reduce and end homelessness in the nation while maximizing the effectiveness of the federal government in contributing to the end of homelessness.

USICH is statutorily charged with developing and regularly updating a national strategic plan to prevent and end homelessness.
