REASON FOR CONSIDERATION: The City Council is requested to consider adoption of Resolution No. 20-3291 certifying the results of the canvass of the November 3, 2020 General Municipal Election.

A copy of proposed Resolution No. 20-3291 is attached for the City Council's review and consideration.

BACKGROUND: The canvass of the November 3, 2020 General Municipal Election was completed on December 1, 2020. A summary of the results from the Registrar of Voters is attached and the Statement of Vote as Exhibit A to proposed Resolution No. 20-3291.

The following two candidates were elected as Member of the City Council for terms of four years:

Tenice Johnson
Benjamin "Ben" Lopez

The following candidate was elected as Member of the City Council for a term of two years:

Corysa Martinez

The following measure was passed:

Montclair Essential Services Protection Measure. Shall the measure to protect Montclair's long-term financial ability to fund general community needs, including keeping Montclair safe; preparing for / recovering from public health emergencies; helping prevent contamination of local water sources; maintaining 911 emergency response; continuing afterschool and senior programs; repairing streets; addressing homelessness; increasing the sales tax by 1¢, providing approximately \$7,000,000 annually until ended by voters; requiring independent financial audits, all funds used locally, be adopted? NOVEMBER 3, 2020, DECLARING THE RESULTS AND
SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election was held and conducted in the City of Montclair, California, on Tuesday, November 3, 2020, as required by law; and

WHEREAS, notice of the election was given in time, form, and manner as provided by law, that voting precincts were properly established, that election officers were appointed, and that in all respects, the election was held and conducted and the votes were cast; received, and canvassed and the returns made and declared in time, form, and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Registrar of Voters has canvassed the returns of the election and has certified the results to this City Council; the results are received, attached, and made a part hereof as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Montclair, California, does hereby declare, determine, and order as follows:

Section 1. That the whole number of ballots cast for "City of Montclair - Member, City Council, Full Term," and "City of Montclair - Member, City Council, Partial Term," was 13,227.

That the whole number of ballots cast for City of Montclair - Measure L, was 13,192.

Section 2. That the names of the persons voted for at said election for "Member, City Council, Full Term," at said City were as follows:

Section 3. That the number of votes given at each precinct and the number of votes given at the City to each of the persons above named for the respective offices for which said persons were candidates are listed on "Exhibit A" attached.

Section 4. That the City Council does declare and determine that:

Tenice Johnson was elected as Member of the City Council of the City of Montclair for a full term of four years.

Benjamin "Ben" Lopez was elected as Member of the City Council of the City of Montclair for a full term of four years.

Corysa Martinez was elected as Member of the City Council of the City of Montclair for a partial term of two years.

As a result of the election, a majority of the voters voting on Measure L related to a one-cent Transactions and Use Tax did vote in favor of it; and the measure was carried and shall be deemed adopted and ratified pursuant to Resolution No. 20-3283.

Section 5. That the City Clerk shall enter on the records of the City Council of the City of Montclair as Exhibit A to this Resolution a statement of the results of said election showing the following:

- (a) The whole number of ballots cast in the City.
- (b) The names of the candidates voted for.
- (c) For what office each person was voted.
- (d) The number of votes given at each precinct to each candidate.
- (e) The total number of votes given to each candidate.

Section 6. That the City Clerk shall immediately deliver to each of the persons so elected a Certificate of Election, signed by the the City Clerk and duly authenticated, and shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe thereto and file the same in their office. Whereupon, each and all of said persons so elected shall be inducted into the respective office to which they have been elected.

Section 7. That the City Clerk shall certify to the passage and adoption of this Resolution, shall enter the same into the book of original Resolutions of the City of Montclair, and shall make a minute entry of the passage and adoption thereof in the records of proceedings of the Montclair City Council in the minutes of the meeting at which the same is passed and adopted.
