Council Member Johnson asked if **CONFIRE** is the agency that receives the City's 9-1-1 calls.

Executive Director of Public Safety/Police Chief Avels advised the Police Department or other local law enforcement dispatch center will receive the call first, which is based on an estimated location for 9–1–1 calls made via cellular phone. He noted calls are then routed from that agency to the appropriate dispatch center. He advised it is possible for people to be connected to the **California Highway Patrol's (CHP)** dispatch if they are near a freeway.

Council Member Johnson thanked Chief Avels for the explanation, noting she recently made a 9-1-1 call related to a medical emergency and the dispatcher she spoke with was not familiar with the location of **the Canyon** at **Montclair Place**, so it was likely that she spoke with a **CHP** dispatcher.

 - 1. Human Services Department Summer Programs & Events

Director of Human Services Richter made the following announcements:

- The 2019 Summer Concert and Movie Series continues tomorrow night at Alma Hofman Park with the band Cold Duck. She announced that at the concert, the community is invited to provide input for the Proposition 68 Park Development Grant for the proposed new Reeder Ranch Park. An interactive activity will be set up so the community can prioritize possible recreation and beautification features of the future park. Next Tuesday, the movie Spiderman: Into the Spider-Verse will begin at 8:00 p.m. in the park.
- The *Montclair After-School Program (MAP)* ended its 2019 Summer Program on Friday, June 21st. Over 325 students participated in *MAP* summer programs. Middle School Summer Program activities included *Elite Leadership Academy; Ready, Set Cook;* and *the Shop* (where students make their own skateboards, toolboxes, and more). The Elementary School Summer Program, themed "Running Wild Montclair," taught students about environment and included activities such as campfire storytelling and environmental art and science activities.

Mayor Pro Tem/Vice Chair Raft wished everyone a happy and quiet Fourth of July.

Council Member/Director Johnson stated she recently attended a League of California Cities conference for mayors and council members where the topic of disaster mitigation was discussed in light of recent major fire events and the constant threat of earthquakes. She noted that, while she has seen the 200-plus page document that is the City's Emergency Management Plan, she would like the City to publish a quick reference guide for residents so they know what to do and where to go in case of an emergency.

Council Member/Director Ruh made the following comments:

- He noted his attendance at a housing policy conference hosted by the Building Industry Association, along with Council Member Johnson; Planning Commissioners Sahagun, Eaton, and Sanchez; and Community Activities Commissioners Escalante and Ferraro. He noted the topic of affordable housing was emphasized at the conference, noting cities are requiring builders to make homes using materials and structures that are causing the affordability issue. He stated the current homeless crisis is a result of the shortage of affordable housing, not mental illness and drugs, and that cities need to all work to address this issue.
- He noted last week he attended the Installation Dinner for the Montclair Chamber of Commerce at the Canvon Montclair.
