## 5. PRESENTATIONS

# 5.1 COMMUNITY ACTIVITIES COMMISSION PRESENTATION OF 2019 HOLIDAY HOME DECORATION CONTEST WINNERS

Community Activities Commission (CAC) Vice Chair Ferraro announced the winners of the City of Montclair's 22nd Annual Holiday Home Decoration Contest. Of the 23 nominations received, the CAC selected three winners, as follows:

- "Childhood Christmas" Award: Salonga Family, 4896 El Morado St.
- "Angels Heard on High" Award: Rodriguez Family, 4570 Moreno St.

Mayor Dutrey and the City Council presented the winning families with Award Certificates and gift cards to Lazy Dog restaurant.

# 5.2 DONATION OF EXCESS FUNDS FROM THE MAYOR'S PRAYER LUNCHEON TO THE MONTCLAIR COMMUNITY FOUNDATION FOR THE 2019 HOLIDAY FOOD AND TOY DRIVE

Police Chaplain Vicki Brobeck presented Mayor Dutrey with a check to the Montclair Community Foundation for \$4,860.

5.3 OVERVIEW OF MONTE VISTA WATER DISTRICT RATES FOR 2020-2023 PRESENTED BY JUSTIN SCOTT-COE, MVWD GENERAL MANAGER

**MVWD** General Manager **Justin Scott-Coe** provided a presentation discussing rate increases for the District for 2020 through 2023. He advised the public hearing took place on November 20 and provided copies of the hearing as well as a Frequently Asked Questions sheet for the public.

Council Member Ruh expressed concerns regarding notification of these rate increases and the impact it will have on low-income and senior residents. He also criticized the District for its plan to build a new campus for its offices.

**Mr. Scott-Coe** thanked Council Member Ruh for his comments, concerns, and recommendations. He stated the District has used several methods to notify ratepayers and will take his comments into consideration for future notifications.

Mayor Dutrey asked whether heavy users were being charged higher rates.

Mr. Scott-Coe advised the District is not legally allowed to structure rates in that way, and stated all ratepayers in each category are charged at the same rate for each tier of usage. He further pointed out that the District attempts to adjust its allocation of water use provided for each tier on an annual basis, based on usage data from previous years.

#### 6. PUBLIC COMMENT

**Ms. Iva Costa** requested the City consider installing permanent restroom facilities at the Montclair Transcenter, noting she does not feel safe using the portable units which are often not well maintained or in a clean state.

City Manager Starr advised the City is aware of the restroom issues at the Transcenter and is working with CalTrans, which owns the Transcenter property, to receive authorization to install a permanent restroom facility.

# 7. PUBLIC HEARINGS

7.1 SECOND READING — CONSIDER ADOPTION OF ORDINANCE NO. 19-988 AMENDING SPECIFIC CHAPTERS OF TITLE 10 OF THE MONTCLAIR MUNICIPAL CODE RELATED TO ADOPTION OF BUILDING CODES TO REGULATE CONSTRUCTION IN THE CITY OF MONTCLAIR, AND ESTABLISHING JANUARY 15, 2020, AS THE EFFECTIVE DATE OF THE CODES

Mayor Dutrey declared it the time and place for a public hearing related to Ordinance No. 19-988, and invited comments from the public.

Mr. Bruce Culp, 9016 Sycamore Avenue, stated he is pleased that with this Ordinance, the City will be adopting requirements for solar panels and electric vehicle charging stations for new parking lots, noting that despite the increased costs for new construction, it is a step in the right direction to address environmental issues. He stated he believes the City should move away from natural gas in new construction altogether, and urged the City Council to rescind Resolution No. 19–3251 to maintain natural gas as a viable alternative energy source, which he believes was a concerted effort pushed onto cities by Southern California Gas Company to stay in business.

Mr. Benjamin Lopez, resident, stated his understanding that the City is simply conforming to state mandates; however, he expressed his concerns shared by the real estate and development communities that the government is overextending its reach by regulating how and what can be built and done on private property. He noted this effort to require new construction utilize electric and solar will push home costs up and further exacerbate the affordable housing crisis in the state.

Mayor Dutrey closed the public hearing and returned the item to the City Council for further discussion and consideration.

Mayor Dutrey stated he understands the affordability issues; however, due to state mandates, the City will need to enforce the regulations whether they are adopted at the local level or not.

Council Member Ruh stated he dislikes being in the position to adopt these state mandates and added the City will need to look into a creative way to address the rising housing costs such as prefabricated housing. He added he feels.it is important to keep natural gas as an alternative form of energy for safety reasons, considering one form of energy may become unavailable in emergency situations.

Moved by Mayor Dutrey, seconded by Council Member Martinez, and carried 5 - 0 to direct the City Clerk to read Ordinance No. 19 -988 by number and title only; waive further reading of the Ordinance; and adopt Ordinance No. 19-988.
