followed the progress of several homeless subjects, how they were found, what help or resources were located for them, and their current status.

The PowerPoint also covered illegal dispensaries that were previously shut down and that illegally reopen over and over again under false pretenses such as a church or a medical CBD oil operation that quickly turned into an illegal dispensary again, problems and advantages with search warrants, and injunctions.

Building Official/Code Enforcement Manager Westerlin informed the group about the new software system "LAMA." It will be completed within the next three months and will streamline CE paperwork and organize notices, citations, etc.

Code Enforcement Officer Hargett reported on shutting down an illegal gambling location while the PowerPoint displayed photos of what was found inside the illegal operation.

Finally, the PowerPoint also shared several "before" and "after" photos of several properties that brought their property into compliance.
